# BANKING, FINANCE AND CREDIT

# THE "MACMILLAN" REPORT

PPOINTED in November, 1929, "to inquire into banking, finance and credit, paying regard to the factors both internal A and international which govern their operation, and to make recommendations calculated to enable these agencies to promote the development of trade and commerce and the employment of labour" the Committee on Finance and Industry under the Chairmanship of Lord Macmillan issued its REPORT in August, 1931.

Shortly after the appearance of the Report the financial crisis directed special attention to its contents and revealed to many in conclusive fashion how fundamentally important to the efficient functioning of modern economic society were the subjects con-

sidered by the Committee.

Presenting as it does, a review of the varying factors in a complex economic system, the report will have an enduring value not only for students and specialists, to whom it will appeal as a compact and penetrating summary of the best modern thought in their field, but for non-specialist readers also by reason of the clarity and conciseness of its exposition. Sir Josiah Stamp, who himself gave evidence before the Committee, has said of the Report:-
