#### PA500 CONSTRUCTION INDUSTRY

PA500

The information in this report relates to undertakings engaged in the construction industry, minimum list heading 500 in the Standard Industrial Classification (revised 1968). The activities of the industry include:—

Erecting and repairing buildings of all types. Constructing and repairing roads and bridges; erecting steel and reinforced concrete structures; other civil engineering work such as laying sewers, gas and water mains, and electricity cables, erecting overhead lines and line supports and aerial masts, extracting coal from opencast workings, etc. On-site industrialised building is also included. Establishments specialising in demolition work or in sections of construction work such as asphalting, electrical wiring, flooring, glazing, installing heating and ventilating apparatus, painting, plastering, plumbing, roofing. The hiring of Contractor's plant and scaffolding.

The report covers the construction work done by private enterprises and by persons directly employed by Local Authorities, Public Authorities and Government Departments. It excludes construction work carried out by the employees of nationalised industries and transport and water undertakings, except for the building and civil engineering work of the British Steel Corporation and the housing departments of the National Coal Board. Contractual work on opencast coal-mining is included but the activities of the division of the National Coal Board responsible for selling the coal so obtained are excluded.

## In interpreting the data in the tables it is essential to bear in mind the notes and definitions which commence on page 20.

Tables arranged according to the "Nomenclature of Economic Activities in the European Communities" (NACE) classification (tables 5i and 5ii in PA500 for 1977) will no longer be published in this Business Monitor. They will however continue to be available in the Eurostat publication — "Structure and Activity of Industry", volumes I, XIII and XV obtainable from —

## PA500 Capital expenditure

#### Introduction

- These notes give the main information needed for interpreting the figures in this Business Monitor. More detailed information about
  the census in general is given in a separate booklet "Introductory Notes", Part PA1001 of the Report on the Census of Production for
  1978, but in many respects, these general notes apply only to manufacturing industries.
- 2. The subjects to be covered for the census were decided after consultation with the Production Statistics Advisory Committee appointed under the Statistics of Trade Act, 1947, and with the Standing Consultative Committee on Construction Statistics of the National Consultative Council for the Building and Civil Engineering Industries.

#### Coverage

- 3. A return for Great Britain was required from all private undertakings employing 20 or more persons, but the full range of questions was only required from those employing 100 or more. Because of the relatively large proportion of output in this industry contributed by smaller businesses, a 5 per cent sample of undertakings with fewer than 20 employees was included in the Census. All Public Authorities were required to make a return in respect of their direct labour construction work.
- 4. The Department of Commerce, Belfast, conducts an Annual Census of Production for Northern Ireland. The information collected is passed to the Business Statistics Office for incorporation in the United Kingdom tables.

#### Industrial Classification

5. The census was conducted on the Business Statistics Office's construction register. This register was created from the Department of the Environment's builders address file of establishments in Great Britain engaged in construction (as defined in the Standard Industrial Classification minimum list heading 500), to which the addresses of Public Authorities' direct labour departments have been added. The register includes details of industry sub-division classification (used in tables 1A and 2A) obtained by the Department of the Environment in their Private Contractors Construction Census taken annually in October. As part of the Contractors census respondents are asked to indicate from a list of the various specialist classes of construction business the description most appropriate to their business. The Business Statistics Office, further sub-divides private contractors between 'main contractors' and 'sub-contractors' according to their major activity, measured in terms of the value of work done. 'Plant hiring contractors' are all classed as 'sub-contractors'.

#### Period Covered

Undertakings were asked to make returns in respect of the calendar year but a return for a business year ending on any date from 6 April 1978 to 5 April 1979 was accepted.

#### Estimation of figures

- 7. Estimates have been made in the Business Statistics Office for non-response and unsampled small firms in order to obtain totals for the industry as a whole. For Great Britain ratio estimates were obtained from satisfactory returns using as the auxiliary variables either employment or output figures obtained in the Department of the Environment's annual census for 1978. Separate estimates were calculated for each industry sub-division by employment size strata. For Northern Ireland, the Department of Commerce made individual estimates for non-response, using the latest information available from quarterly output returns and previous census returns; for unsampled small firms estimation was made by the Business Statistics Office on the basis of employment figures supplied by the Department of Commerce.
- 8. Additionally, respondents were asked to make reasonable estimates wherever exact figures were not readily available.

#### Description of tables

9. Of the tables, all except tables 4A and 4B include estimates for non-response and non-sampled businesses. Tables 4A and 4B are based on returns received only. Apart from table 5 which relates to the private contractors in Great Britain, all tables relate to the United Kingdom; tables 1A and 2A show separate figures for Great Britain analysed by industry sub-divisions and by main and sub-contractors and for Northern Ireland analysed by main and sub-contractors. Tables 1A, 2A, 3A and 4A are for private contractors only, tables 1B, 2B, 3B and 4B relate to the public sector.

#### TERMS USED IN THE CENSUS REPORT

#### Average number employed

- 10. Undertakings were required to state the number of persons on the payroll on the average during the year of return, whether full-time or part-time employees. Separate figures were required for:
  - (a) administrative, professional, technical and clerical employees and
  - (b) all other employees (operatives and apprentices)
  - Averages could be calculated from figures relating to the last week of each calendar month. Undertakings were also required to state the number of working proprietors where appropriate and these are included in total employment figures, but not in (a) or (b) above.
- 11. The figures include persons engaged in merchanting or factoring and canteen workers where particulars in respect of these activities could not be excluded from the return.

#### Working proprietors

12. These include all persons regarded as 'self-employed' for national insurance purposes and members of their families who worked in the business without receiving a definite wage or salary; such persons who worked less than half the normal number of working hours are excluded. Directors working in the business but not in receipt of a definite wage, salary or commission are included under this heading; directors paid by fee only are not included.

#### Employees

- 13. Administrative, professional, technical and clerical employees include employees (including learners and trainees) engaged in the business who do not do manual work, e.g. managing and other directors in receipt of a definite wage, salary or commission, managers, architects, surveyors, engineers, other professionals, training officers, superintendents, research, experimental, technical and design staff, draughtsmen and tracers, travellers, sales and office (including works office) staff, and general foremen and other supervisors who do not do manual work. Public Authorities were asked to include only such a proportion of total office and management staff as was fairly attributable to the building and civil engineering work carried out by direct employees.
- 14. Operatives include all other employees, both on-site and off-site. They include manual wage earners, apprentices, working foremen, operatives engaged in transport work, stores and warehouses, canteen workers and operatives engaged on the manufacture of goods for sale.

15. Capital expenditure during the year in respect of units not then in operation is included in the figures. Undertakings were asked not to deduct from the value of capital expenditure, amounts received or expected to be received in grants or allowances from the Government or any statutory body (or local authority).

#### a. New building work

This represents the cost incurred during the year of new building and other constructional work to be used in connection with the business covered by the return. The value is that charged to capital account during the year of return; it includes expenditure on new buildings and on the extension or reconstruction of old buildings, the value of works of a capital nature carried out by the undertaking's own staff and the cost of any newly constructed buildings purchased. Figures shown include any legal charges, stamp duties, agents' commissions, etc.

#### b. Land and existing buildings

The items shown are the capital costs of freeholds purchased and the capital cost or premium payable for leaseholds acquired (excluding the value of any assets aquired in taking over an existing business), and the amounts receivable for any freeholds or leaseholds disposed of. The value is that charged to capital account during the year of return.

#### c. Plant, machinery and vehicles

The items shown are the value of plant and machinery and of vehicles acquired, both new and second-hand, and the amount received for items disposed of during the year. The value of plant and machinery acquired includes plant, etc., which firms produced for their own use in connection with the business covered by the return. The value of plant, etc., acquired is the expenditure charged to capital account during the year of return less any discounts received, but including the cost of transport and installation. Deductible value added tax is excluded, but non-deductible value added tax and Customs and Excise car tax on motor cars acquired is included. No deduction is made for depreciation, amortization or obsolescence. The proceeds of items disposed of during the year exclude amounts written off for items scrapped.

#### Gross output

16. For the calculation of gross output the value of work done, sales of goods and receipts for plant hire is increased by the rise (or reduced by the fall) during the year in the value of stocks of goods on hand for sale.

#### Net output

17. Net output, a customary census measure, is calculated by deducting from gross output the cost of purchases, (reduced by the rise or increased by the fall, during the year in the value of stocks of fuel and raw materials), the cost of work sub-contracted out and of other industrial services.

#### Net output per head

18. The figures of net output per head are derived by dividing the net output by the average number of persons employed (full-time and part-time) on all activities covered by the returns, including operatives, administrative, professional, technical and clerical employees and working proprietors.

#### Gross value added at factor cost

- 19. Gross value added at factor cost is calculated by deducting from net output the cost of non-industrial services received (rent of buildings and capital equipment, commercial insurance premiums, bank charges and amounts paid for professional services, postal services, transport, advertising etc.) and certain indirect taxes (vehicles licences and rates). This estimate of gross value added approaches more closely than census net output to the definition of net output or value added used in national accounts statistics.
- 20. Gross value added at factor cost per head

The figures of gross value added at factor cost per head are derived by dividing the gross value added at factor cost by the average number of persons employed (full-time and part-time) on all activities covered by the returns, including operatives, administrative, professional, technical and clerical employees and working proprietors.

#### Purchases

- 21. Purchases include the cost of materials and goods used or incorporated in building and civil engineering work or in production; of fuel and electricity for all purposes; of packaging materials, including the full cost of returnable cases and containers when first purchased; of workshop materials, office materials and materials for repairs to an undertaking's own buildings, plant and vehicles carried out by their own work people included in the return; of consumable tools, and of parts for machinery purchased during the year as replacements. Water charges are also included. Purchases of goods for merchanting or factoring were collected separately. Materials supplied by customers for processing are excluded, as are all purchases of plant and machinery charged to capital account.
- 22. The values shown exclude value added tax but include any duty paid (less rebate, etc.). Values exclude trade discounts allowed. The cost of transport is included only if included in the cost of materials as invoiced; amounts paid to transport organisations, including an establishment's own separate transport organisation, for delivery of materials and fuel are therefore excluded. Materials purchased overseas are included at their full delivered cost. If, however, the cost of transport from the docks was not included in the invoiced price, then the c. if, cost plus any duty payable is used.
- 23. Materials and fuel transferred from another department of the establishment not covered by the same return are included at the estimated selling value recorded by the other department.

#### Stocks

24. Values are given of stocks of materials and fuels, and of goods on hand for sale, at the beginning and end of the year of return, including any stocks of goods held for merchanting or factoring. Values exclude value added tax.

#### Wages and salaries

25. These are the amounts paid during the year to operatives and administrative, professional, technical and clerical employees. Payments to working proprietors, whether called salaries or not, are excluded. The values shown include all overtime payments, bonuses and commissions, whether paid regularly or not, and no deduction is made for income tax, insurance, contributory pensions, etc. The value of any payments in kind, travelling expenses, lodging allowances etc., and employers' contributions to national insurance and pension schemes are excluded.

#### Employers' insurance and welfare contributions

26. Values shown include the employers' contribution to national insurance under the Social Security Pensions Act 1975, as well as commercial insurance premiums to provide pensions, superannuation, or other retirement benefits, sickness benefits, personal accident benefits, disability or death benefits for employees or former employees or their dependents. Contributions to running costs of canteens, social centres, childrens' and holiday homes, etc., for employees, former employees and their dependents are also included.

#### Work done and goods sold

- 27. Values shown are exclusive of value added tax.
- 28. For work done the value shown is the net contract price of the work if the contract was executed wholly within the year of return; otherwise an appropriate proportion of the net contract price is used, representing the value of work done during the year. It includes the value of all goods used or incorporated in the work done.

- 29. Sales are in respect of goods made, goods bought and sold without processing, and waste products. Goods incorporated in the building and civil engineering work are excluded.
- 30. The value shown for sales is the net selling value charged to customers, excluding any trade discounts, agents' commissions etc. The net amount charged for packing materials is included.

#### Operating ratios

31. For each industry sub-division the operating ratios shown were obtained by dividing the estimate of the sub-division total for the quantities shown in the numerator by the corresponding estimates of the quantity shown in the denominator. These estimates cover all undertakings classified to each sub-division, including those exempted and non-respondents. In comparing the ratios between different sub-divisions, consideration must be given to the nature of the business carried on by undertakings in the sub-divisions concerned. Within a sub-division, it is possible to compare ratios for an individual undertaking with the ratios shown for the relevant sub-division. However, it is important to bear in mind that various factors may affect this result — for example, differences in definitions treatment of depreciation (which is not identified in the census data) and varying practice with regard to stock valuation, may affect comparability in some respects.

#### **ROUNDING OF FIGURES**

33. Figures in the tables have, where necessary, been rounded to the nearest digit. Where figures have been so rounded, the sum of the constituent items may not always agree exactly with the total shown.

## MA8 - NATIONALITY OF VESSELS IN UK SEABORNE TRADE

How much of UK seaborne trade is carried in UK ships, and how much by our bilateral trading partners? How much is carried by so-called Flags of Convenience? Has the UK share moved up or down? Do the shares differ in terms of weight, value or tonne-miles of cargo carried, or in terms of cargo type? And who carries UK seaborne trade with particular pations?

All these questions, very relevant to current discussions in the shipping world, are answered in the annual Business Monitor MA8 — Nationality of Vessels in United Kingdom Seaborne Trade. The latest issue, containing provisional figures for 1979 was published in October 1980 and is available from HMSO Bookshops (ISBN 0 11 512871 9) price £5.50 or can be ordered on standing order from HMSO Books, PO Box 569, London SE1 9NH. A standing order ensures that this publication will be supplied automatically on publication followed by further monitors in the MA series as they are published. A £10 deposit will open an account.

Processed from information taken from import and export documents, the main analyses in MA8 present a detailed picture by type of cargo (tanker, dry bulk and other dry cargoes) of the quantity imported or exported by sea in UK bilateral trade with a detailed list of countries and areas, and the percentage shares carried by the following flags: UK, European Community (other than the UK), remaining OECD countries, flags of convenience and other. In addition, for the first time in MA8, the percentage carried by the bilateral trading partner is shown. Quantities and flag shares are also shown for a selection of commodities, with other tables giving average lengths of haul and a more detailed list of flags with their percentage carryings by cargo type. Figures in these detailed analyses are shown for a series of three years. Summary analyses give a longer historical run and show amounts and percentage shares in terms of value and tonne-miles in addition to weight of cargo carried.

## **BUSINESS MONITOR SDA 25 Retailing (1978)**

A new series of annual inquiries into retailing was introduced in 1976 to partially replace the periodic Censuses of Distribution. The results of the inquiry is available and published in Business Monitor Number SDA 25, (ISBN 0 11 512872 7) issued annually showing data for Great Britain as a whole, of type and number of businesses, turnover, gross margins, numbers employed, etc.

#### **CURRENT COST ACCOUNTING**

The Department of Industry and the Business Statistics Office jointly produce two publications which contain price index numbers which could be used for CCA purposes. "Price index numbers for Current Cost Accounting" (issue number 13) was published in April 1980 by HMSO, price £7.50, and provides historical series of price index numbers up to February 1980 for plant and machinery bought as fixed assets by specific industries, stocks held by specific industries, specific types of asset, and buildings and works. The retail price index is also included. A full explanation of the purpose, content and method of compiling the indices is given in this publication only.

The latest index numbers for the series available in the above publication are published each month in Business Monitor MM17 "Price index numbers for Current Cost Accounting (monthly supplement)". This is available from HMSO, PO Box 569, London SE1 9NH, price £7.75 for 12 consecutive copies.
