And whereas by Section 40 (2) of the Representation of the People Act, 1918, (b) any Order in Council made thereunder may be revoked or varied as occasion requires by any subsequent Order in Council:

Now, therefore, His Majesty, in pursuance of the powers conferred upon Him by the Acts and of all other powers enabling Him in that behalf, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:-

Section 7 (2) of the Act of 1918 as amended by the Act of 1926 provides: "Residence in a house or the occupation of a house shall not be deemed to be interrupted for the purposes of this Act by reason only of permission being given by letting or otherwise for the occupation of the house as a furnished house by some other person for part of the qualifying period not exceeding two months in the whole, or where the occupation of the person giving the permission commenced more than six months before the last day of the qualifying period for not more than four months in the whole during that period of six months." Section 1 (1) of the Act of 1921 as amended by the Act of 1926 provides:—
"The residence of a person in any premises shall not be deemed to have been interrupted for the purposes of the Representation of the People Acts, 1918 to 1920, by reason only of the fact that that person has been absent from the premises during part of the qualifying period not exceeding two months at any one time, or if the residence commenced more than six months before the last day of the qualifying period during a part of those six months, not exceeding four months at any one time, in the performance of any duty arising from or incidental to any office, service or employment held or undertaken by him." The foregoing express provisions are not to affect the general principles governing the interpretation of the expression "residence." A naval or military voter who is registered for the premises in respect of a residence qualification which he or she would have had but for his or her service is deemed to be resident at the premises for the purposes of paragraph 5 (b) (ii) above.

N.B.—Any false declaration made by a person for the purpose of this claim

will render such person liable to a penalty.

- 5. Under Heading III in Schedule II to the Order a reference to "heading II" shall be substituted for the reference to heading II (1)."
- 6. In the Form No. 1 in Schedule IV to the Order, the following shall be substituted for the "Instructions to the Voter."

 "INSTRUCTIONS TO THE VOTER."
 - 1. Before marking the accompanying ballot paper the voter must produce

(i) The ballot paper showing the number thereon;

(ii) This paper; and

(iii) The envelope in which the voter has received the ballot paper;

to some person to whom the voter is known, who will witness the declaration of identity (see other side).

2. The voter must sign the declaration of identity in the presence of the witness.

3. The voter may vote for......candidate[s] only.

- 4. The voter must vote by marking the ballot paper on the right hand side with a cross opposite the name of [the] [each] candidate for whom he or she votes, thus X. The voter should not allow any person to see how he or she has voted.
- 5. Immediately after voting the voter must place the marked ballot paper in the enclosed small envelope on which are printed the words "Ballot paper envelope", and fasten it up. The voter must then place the ballot paper envelope, together with this paper, in the other larger enclosed envelope addressed to the Returning Officer and despatch the same by post without delay. Unless the voter returns the ballot paper at once it may be too late to be counted.

6. If more than one ballot paper is received it must be remembered that one vote only can be given in respect of a residence qualification. A second vote, however, may be given either (a) in respect of business premises in another constituency occupied by the voter, or by the voter's wife or husband, or (b) in a university constituency.

7. Rules 1 and 6 of this Order shall come into operation on the first day of May, nineteen hundred and twenty-nine.
