Trump, North Korea and the Risk of War

April has seen the inexperienced Trump Administration further escalate US military activities from Iraq and Syria to Afghanistan and Yemen. Attacking Syrian regime targets for the first time sent a clear signal of muscular change from the Obama era and suggested to President Trump a means to reverse his negative domestic approval ratings. However, it is the crisis over North Korea's nuclear missile programme that has the greatest potential to escalate suddenly and disastrously into a conflict of global significance. Read more >>

Hans Blix: Trump's Missile Attack Motivated By Domestic Politics

ORG's patron Dr Hans Blix writes that it is possible that the Trump Administration's signal of readiness to tolerate Assad encouraged the Syrian government to barge ahead for more military gain and to use gas against its own citizens. It also seems likely that a significant motive of Trump's cruise missile attack against an airbase in Syria lay in US domestic politics. But the proper action after the gas attack would have been for the Security Council to order investigation under the UN Charter. Read more >>



Is Trident Influencing UK Energy Policy?

This two-part article by Phil Johnstone and Andy Stirling discusses the influence the UK's nuclear weapons programme may have on its energy policy. British commitment to a 'renaissance' of nuclear energy production is difficult to justify based on economics, energy security or conventional approaches to understanding innovation and technological transitions. Could pressures to maintain an independent nuclear propulsion capacity for the next generation missile submarines have influenced the intensity of UK commitments to new civil nuclear power? The implications of this extend beyond military and energy policy alone, and raise wider questions about British democracy.
