# SIXTH YEARLY REPORT,

OCTOBER, 1920, TO JANUARY, 1922.

It was decided to have the Annual Council Meeting in February, and this is, therefore, a record of fourteen months.

#### MEMBERSHIP.

There are Branches in the following towns and districts:—Aberdeen, Barnet, Birmingham, Brighton, Bristol, Cambridge, Chelsea, Croydon, Derwent Valley, Dundee, East Cheshire, Glasgow, Hampstead, Huddersfield, Hyde, Kensington, Leeds, Liverpool, Letchworth, Manchester, Newcastle, Oldham, Preston, Stockport, Street and York.

Five Branches have disbanded, but Edinburgh has formed a Standing Committee, and Stevenage has a Corresponding Secretary.

Brentford Adult School has affiliated.

#### EXECUTIVE AND OFFICERS.

The Executive Committee has held 13 regular meetings and two special meetings. Representatives of Branches have frequently attended Committee Meetings.

For the first four months of 1921 Mrs. Swanwick was absent, ill, and for a large part of the year Mrs. North Whitehead has also been ill. Miss Cooper Willis has been abroad a good many weeks. Lady Courtney, Miss Ashton, Miss Metcalfe, have all been prevented by ill-health from attending many of the Committee meetings.

Miss Margaret Buckmaster (now Mrs. Dighton Pollock) came frequently to the office during the winter of 1920 to help in the Irish campaign, and during the autumn she acted as International Hon. Secretary in the absence of Miss Cooper Willis.

On September 9th some of the Branch Secretaries met the Executive to confer upon organisation.

#### THE OFFICE.

Miss Royds was married in September to Mr. Innes, and left us, greatly to our regret. It was good that her last piece of work, the Summer School at Salzburg, should have been such a brilliant success.

Miss Broatch temporarily filled the post of Secretary till November, when Miss Dorothy Evans entered upon the work Miss Horscroft remains at her post, and throws herself into every breach that may occur. In July she went to Vienna to report the Congress for the Headquarters' Office.

#### INTERNATIONAL.

The Headquarters of the Women's International League for Peace and Freedom removed in the autumn of 1920 from its first Offices in the Boulevard Georges Favon, to a fine old house at No. 6 Rue du Vieux Collège, to which it has given the name of "Maison Internationale."

Miss Catherine Marshall spent many weeks in residence here during the Sessions of 1920 and 1921 of the Assembly of the League of Nations, and has done work of which the full report must be

read in the records of Geneva Headquarters.

The object of having Headquarters at the seat of the League of Nations was that the ideals of the W.I.L. might be made operative within the League. For this object to be realised it is necessary that two functions should be well exercised in every national section: (1) Information should be promptly sent to Genevan Headquarters on all matters which come to the knowledge of the national section bearing upon questions over which the League of Nations has or ought to have jurisdiction; (2) National sections should be prepared to carry out in their own countries such propaganda or pressure as is recommended from Headquarters. We are very far indeed from doing either of these things, and we would appeal to our members to realise the importance of equipping themselves by study and organisation for the work of making themselves politically effective. We particularly want more women who specialise on particular points of international importance, so that they can speak on deputations, represent the League at Conferences, and know how to find the people or the information required by Geneva.

#### THIRD INTERNATIONAL CONGRESS.

The Third Congress of the Women's International League for Peace and Freedom was held in the Musikvereins-Gebäude, Vienna, from July 10th to 16th, 1921. There were present from England Miss Marshall (Board of Officers), Miss Kathleen Courtney (Consultative Member), and the following delegates and alternates: Mrs. Briggs, Miss I. O. Ford, Miss D. Hammond, Mrs. Henson, Miss Hardcastle, Miss Eleanor Hobhouse, Mrs. Huth Jackson, Miss Jowitt, Miss Emily Leaf, Mrs. Lennard, Miss Frances Melland, Miss Mabel Phythian, Mrs. Annot Robinson, Miss Margaret Sackur, Mrs. Salter, Miss Picton Turbervill, Mrs. Raymond Unwin, Miss Wilkie, Dr. Ethel Williams. Miss Jane Addams presided over the Sessions, and some 200 delegates attended as well as many visitors. The following countries were represented:—America,

Austria, Canada, Czecho-Slovakia, Denmark, France, Germany, Great Britain, China, Greece, Hungary, Ireland, Italy, Japan, Jugo-Slavia, Mexico, Norway, Poland, Roumania, Sweden, Switzerland.

Discussion lingered long over the all-important question of education. Miss Marshall led discussions on the League of Nations and the problems of minorities. Mlle. Dujardin, a Belgian delegate, was warmly welcomed as one who had practised the rule that one should love one's enemies. Dr. Alice Hamilton stressed the need for investigation into the effects of war on children. A long discussion took place on the proposal to adopt a pledge not to take part in war, a proposal approved by the majority but not made compulsory on the national sections. Mrs. Widegren introduced the proposal for peace missions.

Reports were received from the National Sections showing continuous activity in most. These can be obtained from the Office, price 1/-.

A great many resolutions were passed, which space forbids our re-printing. Copies of these can also be obtained from the Office, price 1/-.

The full report of the Congress is expected at any time, and will then be obtainable from the Office, price 2/- each.

A pretty little badge was adopted. It was designed by Mrs. Uckerman (Norway) and made in Vienna. It has the device "Pax" in gold letter on a blue ground, encircled by a green olive wreath. They can be obtained from the Office, price 6d.

#### VACATION SCHOOLS.

Jordans.—A Week-end School was held at Old Jordans Hostel from October 15th to 21st, 1920, and was attended by about 35 people. Among the speakers and lecturers were Miss I. O. Ford, Miss K. D. Courtney, Miss Bondfield, Mr. C. Delisle Burns, Miss Picton Turbervill, Miss Cooper Willis, Mr. George Young, Dr. Ethel Williams, Miss A. H. Ward, Mrs. Swanwick, Miss Catherine Marshall, Mr. Pethick Lawrence, and Mr. Fred Whelen.

Salzburg.—From August 1st to 15th, a Summer School was held in the Mozarteum at Salzburg. This was organised by Miss Royds, as Secretary of the British Section, which carried out the work on behalf of the International Executive and was able to hand over a profit of £160 to the office at Geneva. About 300 scholars attended. They came from America, Mexico, Great Britain, Ireland, France, Holland, Sweden, Denmark, Germany, Austria, Switzerland, Czecho-Slovakia, Jugo-Slavia, Roumania, China, Japan and India. Miss Addams was present all the time, and took part in every sort of activity. Frau Zweig was indefatigable in hospitality and kindness. Miss Haesele and Miss Rieger were Miss Royd's lieutenants. The subject was "Education for Internationalism," and the first week was devoted more or less to the psychological, the second to the political and historical aspects of the subject.

Among the lecturers and speakers were Miss Addams, Dr. Ethel Williams, Prof. Lehmann (Lund University), Dr. Felix Petyrek (Salzburg), Prof. Lazar (Pirquet Klinik), M. Schwan (Denmark), Dr. Lionel Tayler, Prof. G. F. Nicolai (Berlin University), Mr. Watkin Davies, M. Cruey, Mr. Neill, Miss Marshall, M. Longuet, Miss Balch, Prof. Rappard (Geneva), Prof. Schultz Gaevernitz, and Mrs. Swanwick.

Miss Sav Ashworth brought her Ancoats Choir, and their singing at two concerts and on many less formal occasions was a delight to everyone. Innumerable excursions and festivities took place, and the accident of coincidence with the Mozart Festival gave ample opportunities for listening to the divinest of composers.

A large proportion of the students was quite young, and a decided stimulus was given to internationalism among those who have the future in their hands. The Executive Committee feels that Vacation Schools offer some of the best instruments of propaganda, and it is preparing to hold one at Newlands, Keswick, from April 13th to 27th, 1922.

#### COUNCIL MEETINGS.

#### ANNUAL COUNCIL MEETING, Essex Hall, October 14th, 1920.

Resolutions were passed as follows:—

Ireland: "That the Women's International League urges the Government to set free all Irish Political Prisoners and to offer a truce during which all armed forces shall be withdrawn, and the keeping of order be placed in the hands of the Irish local Councils, thus creating conditions under which the Irish people may determine and establish their own form of Government. Further, that this Council instructs the Branches to work, each in its own locality, to mould opinion in support of this policy."

Restoration of Right of Asylum: "This Council is of opinion that England should again be open as a refuge for men and women who, for political, religious, or social reasons, consider their personal freedom and safety is in danger."

Executive Action: "1.—" This Council is of opinion that the scheme of work put forward in the Executive Committee's statement \* of 13th September is the best practicable, and pledges itself to endeavour to raise the sum estimated as necessary to carry out this work. At the same time, the Council instructs the Executive Committee to do its utmost to establish in London an Institute which shall be an International Centre, with newspaper and tea-rooms, and some bedrooms to be let to suitable applicants. The capital or guarantee necessary for such an undertaking to be specially provided, and the work not to be undertaken without such provision.

2.—" That the National Executive issue from time to time memoranda and instructions to the Branches to take action in their own areas, so that when crises arise (e.g. Russo-Polish War-Ireland) the whole weight of the League may be thrown in support of an agreed policy, and a lead given to the Branches."

#### ALTERATIONS OF RULES.

Rule VI. A (a) was altered to run:—

"The Executive Committee shall consist of the Hon. Officers and 23 members, who shall be elected by representatives of the Branches at the Annual Meeting of the Council, and each Branch shall be entitled to send one representative to the Executive Committee with power to speak, but not to vote, the Executive not being responsible for such representative's expenses. '

RULE VIII. GENERAL COUNCIL (a) of the Constitution was altered to run :-

"That in view of the greatly reduced number of Branches, the Council be increased by the addition of not more than 30 yearly members: these members to be nominated by any Branch or individual member and voted upon at the Annual Council. In the interval between Council Meetings the Executive shall have power to fill up vacancies.

'As an exceptional measure and to avoid the lapse of a whole year before the Council can be increased, the first election of yearly members shall be carried out by a postal vote.'

(1) Taking all opportunities to work with educational bodies and Labour Associations in the furtherance of international ideas;

Continuing the series of histories initiated by the W.I.L. and edited by K. E. Royds and G. P. Gooch, and published by Messrs. Methuen.

Organising Holiday Schools, including an International School which the British Section

undertook to organise in 1921 for Genevan Headquarters;

Continuing as the British Section of the International League and affording all possible help and information required by Miss Balch. (N.B.—In this connection it should be noted that Headquarters at Geneva has moved into a larger house where many social developments may be possible, as well as valuable political association with the Secretariat of the League of Nations). There will be an International Congress as well as the Holiday School in 1921 to prepare for.

Your Committee does not, of course, wish to rule out any further developments that may appear practicable, but we have budgetted for this work only, and we submit that this work would be valuable even if we could do no more, and well worth the expenditure we propose. At the same time we note that the idea put forward last May, of something in the nature of an Institute and tea room, with rooms to let in the house, met with very favourable comment from our members, and believe that if suitable premises and the necessary capital could be found such an Institute would be much welcomed and would be found a source of revenue. Your Committee, therefore, suggests that every avenue be explored, and a concentrated effort made during the next six months towork out a practicable scheme. It has not been possible yet to find either the premises or the capital, in spite of efforts to do so, but your Committee recognises that the time of the year when the idea was first broached was very unpropitious, and would not willingly give up such a good idea without far more endeavour to carry

Rule (B) Annual Council Meeting (a) (d) of the Constitution was altered to run:—

"That, in order to avoid the inconvenience of closing the financial year in the middle of the holiday season, it is desirable that, in future, the accounts of the League be made up to the end of December, and that the Annual Council Meeting be held in February or March." \*

After the Council meeting a reception was held which was attended by friends from Serbia and Switzerland, and addressed by Frau Schreiber Krieger, M.P.

#### SPECIAL COUNCIL MEETING, Essex Hall, June 10th, 1921.

A great part of the time was taken up with discussions of finance and organisation. The Executive, in view of the difficulty of securing premises for an International Institute, was instructed to proceed with the opening of a tea room and reading room in some central district.

The late Dr. Fried.—On the motion of Lady Courtney a resolution of sympathy with Frau Dr. Fried and the Austrian Peace Society was passed on the death of Dr. Fried.

The following resolutions were also passed:—

Co-operation.—" This Council instructs the Executive to make enquiries and draft proposals with a view to presenting a scheme at the next Annual Meeting for systematic co-operation with other similar bodies in this country, but is of opinion that the W.I.L. should retain its present character as a body of women only, because, as such it has a definite contribution to make towards the progress of women in all nations."

- (1) International Headquarters.—" This Council is of opinion that work at International Headquarters is of great value:
- (a) In giving a centre to the international work of women:
- (b) In encouraging the formation of new national centres of feminist internationalism:
- (c) In making the W.I.L. known to the League of Nations and influential within it. It therefore resolves to make an effort to raise a due proportion of the money necessary for the work at Maison Internationale."
- (2) This Council instructs the British delegates to the Congress in Vienna to support the continuance of the office at the seat of the League of Nations."

Miss Catherine Marshall gave a most interesting account of the work of the Women's International League in Geneva, in connection with the Assembly of the League of Nations. She laid special stress on the questions of Publicity, Women on the Mandates Commission, Armenian Women Captives, and the admission of Albania to the League.

ANNUAL COUNCIL MEETING, 31, Alfred Place, Tottenham Court Road, 2nd February, 1922.

AMENDMENT TO RULES.

Rule V. Branches (a). Formation was altered to run—
"That the affiliation fee be raised to 3d. per member."

Addition to Rule VIII. General Council—

"That the travelling expenses of one delegate from each Branch to the Annual Council Meeting be pooled."

Addition to Rule VI. Executive Committee (b) (a)—

Insert after "The Executive Committee shall meet once a month" the words "and at least two of the meetings each year shall be held in towns in the Provinces."

#### RESOLUTIONS.

(1) Joint Action.

With reference to the resolution passed at the Annual Council

Meeting, October, 1920, as follows:

"This Council instructs the Executive to make inquiries and draft proposals with a view to presenting a scheme at the next Annual Council Meeting for systematic co-operation with other similar bodies in this country, but is of opinion that the W.I.L. should retain its present character as a body of women only, because, as such, it has a definite contribution to make towards the progress of women in all nations."

the Executive is of opinion that the co-operation carried out during the past year by the National Executive and Branches is of the

most effective kind.

(2) Propaganda.

"That, in view of the need of education and organisation for Peace among all women, but especially among the women voters, the W.I.L. Executive should, during the ensuing year, devote its energies to propaganda throughout the country, and to this end it should:—

(a) In every possible way encourage existing Branches and the formation

of new Branches and active groups.

(b) Assist Branches by supplying suitable propaganda, literature, speakers, etc., and in particular assist Branches in these or any other ways to prepare for a General Election.

(c) Endeavour to secure the affiliation of other Women's Societies."

(3) Disarmament and Propaganda.

"In view of the lessons learned from the Washington Conference and from the Irish Settlement, and also in view of the pronouncement on disarmament of the W.I.L. Congress at Vienna, work towards universal total disarmament, including the abandonment of chemical warfare shall be a leading part of our propaganda for the ensuing twelve months."

(4) World Congress for Economic Peace and Disarmament.

"This Council rejoices at the prospect of a World Congress in the near future for the re-establishment of world commerce and finance. It urges that Great Britain should offer as its contribution to the economic re-construction of Europe, the abandonment of all partial defensive alliances, the remission of its protective tariffs, the withdrawal of its Armies of Occupation, the resignation of its claims to indemnities and war debts, and the declaration of its willingness to agree to a policy of universal disarmament by land, sea and air, and of the universal prohibition of the manufacture of poison gas."

(5) Unemployment and the Peace Treaty.

"That the W.I.L. should strive to bring constantly before the public the close connection between unemployment and the terms of the Peace Treaties, and urge it to make demands for the drastic revision of the Treaties."

(6) Russia and Germany in League of Nations.

"That the Branches be advised to work during 1922 for the inclusion of Russia and Germany in the League of Nations."

#### EMERGENCY RESOLUTIONS.

(1) "Realising the calamitous effect of further delay this Council urges the Government to supply immediately the amount of aid demanded by Dr. Nansen for famine stricken Russia."

(2) "That this meeting urges the Government to recognise the present Government of Russia immediately, and to take all possible steps to secure its general recognition by other countries."

(7) Egypt.

"This Council sees with the utmost apprehension that the British Government is repeating in Egypt the disastrous policy so long pursued and now happily abandoned in Ireland. It affirms that Great Britain has no right to treat Egypt as if it were merely part of the "communications of the British Empire," and urges the Government to recognise in deed as well as in word that Egypt belongs to the people of Egypt, and that a treaty of amity would give Great Britain far greater security than an Army of Occupation.

"Further, that the W.I.L. should organise Conferences or other means to discover and promote the desires of India and Egypt in conformity with the ideals of the League of Nations, as stated in the first

paragraph of the Covenant."

#### (8) Travel Restrictions.

"This Council declares that the work of the W.I.L. in promoting good understanding between nations is gravely hampered by the vexatious restrictions on travel and residence of foreigners in this country, and urges that Great Britain should once more open its doors for international intercourse."

INTERNATIONAL HOUSE.

Early in November we at last began to realise the plan so long nursed of opening a social centre in London, to be for the English Section what the Maison Internationale is for Headquarters in Geneva. We have succeeded in raising only one third of the capital estimated necessary, and we have had to begin with much less than we hope to attain to in time. Our "International House" is at 55, Gower Street. Two rooms are devoted to the offices of the League. There is a Reading Room on the first floor, a "Cafetaria," for meals on the American help-yourself system, on the ground floor, good kitchen premises, and a small garden. Five rooms on the second and third floors are at present sub-let.

The money lent and subscribed is vested in a trust, of which the trustees are Lady Courtney, Miss Ashton, and Mrs. Swanwick. They have appointed the following as House Committee, with power to add to their number:—

The structural equipment has been carried out by the Building Guild, and the Cafetaria chairs, tables and trays have been supplied by the Furniture and Furnishing Guild. Mrs. Skene MacKay has been appointed Manager of the House.

By the time this report is issued the Cafetaria will have

opened for teas and lunches.

Lectures, debates, entertainments of many kinds are in contemplation. Membership of "International House" is open to men and women of 16 and over, of all nationalities. 5/- yearly admits to Cafetaria and Reading Room; 1/- yearly admits to Cafetaria only.

#### RECEPTIONS AND CONFERENCES.

Conferences on the Consequences of an Army of Occupation.— In the morning of June 8th, at the Essex Hall, a Conference called by the W.I.L. considered the moral effects of an Army of Occupation. Miss Ettie Rout, for the Society for the Prevention of Veneral Disease, advocated the use of prophylactics as preventatives. Miss Neilans, for the Association for Moral and Social Hygiene, challenged Miss Rout's statistics and maintained that the effective remedies were moral. Mrs. Wägner Landquist, a Swedish member of the W.I.L. who had travelled in the occupied areas, drew attention to the many and various evil social consequences of occupation. In the afternoon Mr. Brailsford gave a searching address on the economic consequences, and Miss Cooper Willis quoted striking figures which were printed in the July News Sheet.

The following resolution summed up the views of the Conference:—

"This Conference is of opinion that, in so far as the object of occupying parts of Germany by Allied troops is to secure reparation for the devastated areas of France and Belgium, this object would be far better and more expeditiously obtained if the Allied troops were diverted from this unproductive work to some form of production, either at home or in the devastated areas. The Germans, being thus relieved of the burden of supporting many thousands of healthy young men in oppressive idleness, would be enabled to carry out their share of reparation, and the fullest use should be made of them for this purpose.

"The social consequences of the occupation are no less injurious than the economic, both to the inhabitants of the country and to the Army of Occupation. No palliatives can right the fundamental wrong of taking thousands of men in the prime of life away from home and family and productive work and placing them, as conquerors, in positions of comparative idleness and acute temptation to unsocial conduct, with its inevitable results of sexual disorder, venereal disease, and the spread of a militarist spirit fatal to the development of a true League of Nations.

"This Conference believes that these evils must continue until the soldiers are discharged and restored to their homes and families and useful work. It urges upon the Assembly of the League of Nations at its meeting in September, 1921, to consider the whole question of Armies of Occupation in German territory."

Miss Addams.—On September 19th, 1921, Miss Addams was welcomed at a reception at the Hampstead Friends' Meeting House. She gave a short address upon the work of the League, and the room was crowded.

International House.—On November 15th and 16th "house-warming parties" were held at 55, Gower Street, at which Mrs. Scheu Riesz, Lady Courtney, Mr. Hobson, Miss Buckmaster, and Mrs. Swanwick spoke.

Dr. Rotten and Gertrud Baer.—On December 7th International House was crowded out at a reception given to Dr. Rotten and Gertrud Baer. The latter spoke twice on the World Youth Movement. She also addressed many other private meetings in London, Manchester and Newcastle during her stay of six weeks, and brought many new friends and adherents to the League.

#### IRELAND.

In the autumn of 1920 the Manchester Branch carried on a vigorous campaign in support of the claims of Ireland to selfdetermination and in protest against the continued imprisonment of Terence MacSwiney, the Mayor of Cork. In November ten members of the League visited Ireland. They were Mrs. Watts (Manchester Hon. Secretary), Mrs. Swanwick (Chairman W.I.L.), Mrs. Annot Robinson, Dr. Catherine Chisholm, Miss Amy Herford. Mrs. Gee, Miss Ellen Wilkinson, Miss Melland, Miss Mewhort, and Mrs. Dollan. Some went to Ulster, some to Clare and Kerry, some to Cork, and most of them stayed some time in Dublin and the neighbourhood. They worked in close co-operation with the Irish Section of the W.I.L., and on their return they addressed a very large number of meetings in England and Scotland, telling what they had seen in the "devastated areas." In the Manchester area alone over 30 crowded meetings were held, and large halls were packed in Birmingham, Leeds, Newcastle, Bristol, Liverpool, Glasgow, Edinburgh. In London over 20 meetings were held, including one in the Kingsway Hall, and at many of them lantern slides were shown to convince the people of the extent of the devastation.

A pamphlet was issued giving the experiences and conclusions of the mission to Ireland (entitled "A Sort of War in Ireland"), with a picture of ruined Balbriggan, and resolutions were everywhere passed and forwarded to the Government, demanding the liberation of prisoners and a truce during which the Irish people might determine their own form of government.

Miss Melland and Mrs. Watts repeatedly visited Ireland during 1921, and the propaganda of the League, alone or in cooperation with the "Peace with Ireland Council" and other bodies went on continuously. Mrs. Robinson and Miss Wilkinson accepted the invitation of the American Commission of Investigation to give evidence on the condition of Ireland and sailed on December 8th, 1920. Their evidence lasted a whole day and made a favourable impression. It is incorporated in the report issued by the American Commission.

On May Day, 1921, a meeting was held in Hyde Park, Miss Ward in the chair, Lady Clare Annesley, Miss Murphy, Miss Rinder and Miss Sackur speakers.

At the Vienna Congress in July resolutions were passed demanding self-determination for Ireland, and appealing to Ireland, when it had won its independence, to incorporate disarmament as part of its national policy. The news of the truce was received with cheers during the Summer School in Salzburg.

On 4th July the following resolution was sent to Sir Hamar

Greenwood, the Premier, and Colonial Premiers:—

"The Women's International League rejoices that an unconditional invitation has been sent to Mr. de Valera and Sir J. Craig to confer upon the better Government of Ireland, and hopes that nothing will be allowed to check the progress of negotiations. It points out, however, that a spirit of conciliation is necessary to arrive at a conclusion, and to this end urges again the need for a complete truce on both sides and a recognition of Ireland as one nation."

On 8th December the following was sent to the Premier from

the meeting at International House:—

"This meeting rejoices at the signing of a treaty of peace between representatives of Great Britain and of the people of Ireland, whereby the Irish Free State is to be established, and it trusts that out of this treaty may grow the political unity of the Irish nation and lasting peace with Great Britain."

During the summer action was taken by the officers and Miss Huntsman to bring the work of the Irish White Cross before the people of England.

Mrs. Huth Jackson attended the funeral procession of Terence MacSwiney in London, and laid a wreath on behalf of the Executive

Committee.

On 5th December, 1921, a letter was sent to the Prime Minister saying that we were watching with the intensest interest and anxiety the Irish situation and the progress of negotiations, and hoping that his efforts would be successful to making a lasting settlement. We believed the conscience of the country would not, in any case, tolerate a return to armed hostilities either in Southern Ireland or in Ulster.

#### DISARMAMENT CAMPAIGN.

At the Vienna Congress the following resolution was passed:—
1.—"The Committee recommends that the Congress, while always working for universal total disarmament, welcomes the proposed Conference of certain nations as a step in that direction, and further recommends to the National Sections that they emphatically and continuously insist upon the original meaning of the term 'disarmament' in its literal sense, thus preventing the use of the term as a camouflage for 'reduction of armaments,' which latter would simply continue the danger of war on a relatively smaller scale.

2.—"The Committee recommends that the League urge its Sections in all countries represented at the Washington Conference to bring pressure to bear upon their Governments to work for universal disarmament through the Washington Conference, and to send deputations to their Governments for this purpose, in support of a manifesto to be addressed to the Conference and to the Governments concerned.

3.—"The Committee recommends (a) that the National Sections publish leaflets incorporating the manifesto, but adapted to the needs of their own countries; (b) that a pamphlet with a summary of facts and references be printed; (c) that the National Sections prepare a list of speakers on the subject of disarmament, and arrange wherever feasible for exchange of speakers among National Sections.

4.—"The Committee recommends that the week before the Conference opens be designated as an International Disarmament Week, during which all National Sections are urged to work simultaneously in favour of the adoption of universal disarmament by the Conference."

This resolution was taken very seriously by the British delegation, which urged that steps should be taken to organise a campaign in this country. The Manchester Branch was, as usual, in the forefront of activity, and as the Executive was embarrassed by the absence of many of its members, by the change in Secretaries and by the impending removal of offices and starting of International House, the Manchester Branch undertook to organise the campaign. Shortage of funds and the extreme difficulty (which the W.I.L. has shared with all other organisations) of getting subscriptions made the work very uphill, but Manchester did wonders by sheer will and faith. The campaigns were financed locally by the Branches themselves.

Before this, however, owing to reports given by Mrs. Robinson and Miss Wilkinson, and impressions gathered during their visit to America, the Manchester Branch had organised a Disarmament Campaign from March 14th to 21st, 1921, during which ten meetings were held. They were well attended and the last of the series in the Milton Hall, addressed by Mrs. Philip Snowden, was a very fine gathering. Meetings were also held during the spring in Liverpool, Rochdale, Huddersfield, and Warrington, etc.

The autumn campaign may be very briefly summarised thus: Manchester formed a Citizens' Committee, presided over by the Dean, and supported by the Chamber of Commerce as well as by political parties, social and religious bodies. A meeting in the Town Hall, on October 28th, was presided over by the President of the Chamber of Commerce, and addressed by Mr. Norman Angell and the Lady Mayoress-elect. A deputation was sent to Viscount Grey of Falloden, on December 13th, at the Free Trade Hall. On December 8th a special Women's Meeting was called to advocate Total Universal Disarmament, and was well received. Mrs. Watts, Hon. Secretary of the Branch, designed a very effective card, graphically showing relative expenditure on armaments. This was produced by the National Peace Council, and more than 8,000 of these and others were distributed by the Branch. Over 2,000 signatures to a Peace Memorial were obtained on November 11th, and many resolutions were forwarded to the Prime Minister and Lord Curzon, and cables sent to Washington.

Ashton-under-Lyne.—A public meeting was held in the Town Hall, presided over by the Mayoress.

Liverpool co-operated with a Citizens' Committee in arranging a meeting in the Town Hall, November 7th. Obtained 500 signatures for the Memorial and distributed leaflets. On November 20th two meetings were addressed by Miss I. O. Ford.

Huddersfield Branch, in co-operation with other bodies, held a meeting on November 4th, at which the resolution was passed unanimously.

Stockport W.I.L. Branch supplied speakers at the Sunday School, Unitarian Church, and at the League of Nations Union demonstration. Leaflets distributed.

Newcastle co-operated with the local Friends' Peace Committee in placarding the town, and also sent delegates to a Conference called by the League of Nations Union.

Macclesfield circularised ministers of religion, political and other clubs, trade unions, etc.

Leeds united with local Committee in a series of open-air meetings and in a Town Hall meeting, and in placarding the town and providing speakers for other organisations.

York held a meeting.

Edinburgh co-operated with the Peace Council in a week of open-air meetings, and a public meeting in the U.F. Assembly Hall. Lady Margaret Sackville spoke and gave a reading of her poems. Mrs. Butler addressed a second meeting.

Glasgow.—September 5th to 9th, five open-air meetings. October 3rd, public meeting in conjunction with the U.D.C.

Brighton obtained over 700 signatures to the Memorial. Miss Pritchard and Miss Pickworth addressed several meetings.

Cambridge organised a good public meeting, addressed by Lady Parmoor, distributed leaflets, and supplied speakers to other organisations.

Birmingham co-operated in the Friends' Disarmament Campaign in October, arranged a very successful meeting of Co-operative Guildswomen, and distributed leaflets.

Bristol held a meeting on November 10th.

Kensington held a drawing-room meeting on November 3rd, at 3, Gloucester Walk, and on December 2nd a public meeting at "The Venture," well filled and unanimous. Miss Buckmaster and Mrs. Swanwick spoke.

Croydon held a public meeting on October 5th, Miss Morland in the chair. Mr. Edward Backhouse speaker. It also circularised

ministers and supplied speakers for Co-operative Guilds, Women's Citizens' Association, and Women's Adult Schools. Croydon also did some effective advertising with the "Advertising Ark" on Armistice Day. On November 23rd Mrs. Innes addressed a joint meeting of the W.I.L. and the Women's Labour Group. Leaflets were widely distributed.

Barnet circularised local clergy and organisations with a memorial and the diagram postcard. On Armistice night it held a public meeting at the Church House. Speakers, Mr. Rowntree Gillett and Captain Will Hall. On November 9th, a public meeting at the Adult School. Speakers, Miss Buckmaster and Mr. Pollard. The Hon. Secretary, Mrs. Westoby, also urged Disarmament campaign on the Women's Section of the St. Alban's Labour Party and League of Nations Union.

Hampstead co-operated in a meeting organised by the Friends on Tuesday, November 8th, 1921.

Central Hall, London.—The W.I.L. co-operated in the great Women's Meeting on Armistice Day.

Executive Action.—On December 11th, 1921, a letter was sent to the Premier, Mr. Balfour and Lord Lee of Fareham, enclosing our Manifesto on disarmament and urging that the British delegates to the Washington Conference should shape their policy so as to remove all possible obstacles to world disarmament.

#### ACTION TAKEN ON OTHER PUBLIC MATTERS

White Slave Traffic.—On 18th May, 1921, a letter was sent to the Prime Minister and Sir Eric Drummond, expressing gladness that a World Conference on the suppression of White Slave Traffic was being convened at Geneva on June 30th, and pressing the Government for the inclusion of women at the Conference as delegates, or, if not as delegates, as advisers.

Women and Plebiscites.—On 25th April a letter was sent to Sir Eric Drummond, embodying the resolution passed at the Zurich Congress, May, 1921:—

"This International Congress of Women urges that the following clause be inserted in the Peace Treaty: That in any plebiscite taken under the Treaty of Peace or the League of Nations women should have the same right to vote as men."

Colour Bar in South Africa.—In October a resolution in the following terms was sent to the Premier and the Colonial Office:—

"In view of the grievances suffered by natives in South Africa and of the pledge given in the Royal Letters Patent of May 12th, 1843, to Natal that there shall not be in the eye of the law any disqualification whatever founded on mere distinction of colour, origin, language or

creed, the Women's International League urges upon the British Government its responsibility for advising the Colonial Government of South Africa to remove the colour bar, to enfranchise the native men and women, and to repeal all laws such as the Native Land Act of 1913, the Pass Laws, Curfew Bells, and others, which contravene the original pledge and keep the natives in virtual slavery."

Occupation of the Ruhr.—On 22nd April, 1921, a letter was sent to the Premier protesting against the connivance of the British Government in the destructive policy involved in the threat of the French Government to occupy the Ruhr District on the grounds:—

- (1) That it is a violation of the pre-Armistice pledge in the basis laid down in the Treaty for assessing damages;
- (2) That the application of the Sanctions is a violation of the Treaty terms;
- (3) That such action must imperil what peace already is established in Europe, and must tend to promote both reactionary militarism and the spirit of revolution in Germany, and that it must set back once more all prospect of the economic recovery of Europe and make it impossible for Germany to pay the minimum of what is demanded by entirely preventing the revival of her trade in foreign markets."

Women and Nationality.—On 24th January, 1921, a letter was sent to the Premier and the Home Office urging that the Government should instruct its representative to the Imperial Conference to vote in favour of altering the Nationality Laws, to include the grant to women in those parts of the British Empire where such amendment is necessary, of the right to retain their British nationality on marriage with an alien, and to support the inclusion of women on the Committee appointed by the Imperial Conference to deal with the matter.

League of Nations.—(1) On October 20th, 1920, a resolution was passed at the Jordans Vacation School and sent to the Premier, as follows:—

"This meeting of women citizens assembled at a Conference at Jordans, Beaconsfield, demands that in order to make the League of Nations a vital and effective body it shall immediately admit to its Assembly all self-governing nations willing to submit to its conditions."

(2) On 16th March, 1921, a letter was sent to the Premier and to Members of the Assembly of the League of Nations, on the appointment of a Committee by the Council of the League of Nations "to consider proposed amendments and report on them to the next Assembly meeting," urging that this opportunity be taken for putting forward such amendments as may make the League of Nations a more effective representative instrument of Government.

(3) Women on the Mandates Commission. On 16th February, 1921, a letter was sent to Mr. Balfour supporting the recommendation of the Assembly of the League of Nations that at least one woman should be appointed to the Commission on Mandates, and submitting that it was of the utmost importance that persons of wide knowledge of native conditions should be chosen to serve on the Commission, suggesting Dr. Nansen as being eminently suitable. Sir Sydney Olivier, Mr. J. H. Harris and Mr. Leonard Woolf were also suggested.

The Maternity Convention.—On 8th March, 1921, the following resolution was sent to the Minister of Health:—

"The Executive Committee of the W.I.L. views with grave concern the decision of the Government not to carry out its pledges to the League of Nations by refusing to ratify the Maternity Convention. They would remind H.M. Government that it passed the two-shift system for women in spite of grave protest from organised Labour on the ground that the Washington Convention must be carried out.

"Under these circumstances this Executive considers it especially regrettable that the valuable clauses of the Maternity Convention should be dropped.

"It urges upon the Government to introduce legislation with Government support, that will cover the whole Convention, before the eighteen months allowed by the Conference has elapsed."

German Indemnity.—On March 4th, 1921, a letter was sent to the National Peace Council, the General Federation of Trade Unions, the Parliamentary and Trade Unions Committee of the Labour Party, and the Premier, calling attention to the need of conciliatory action in consideration of the critical state of Europe, and suggesting a Conference of economic experts on the indemnity question, at which Labour should be adequately represented.

Infants' Bill.—On April 27th, 1921, a letter was sent to the Prime Minister and the Home Office calling upon the Government to support by their vote and influence the Guardianship, Maintenance and Custody of Infants' Bill, and urging the adoption and the allowing of time for its passage into law this Session. On 4th July a letter was sent to the Prime Minister and the Home Office urging the Government to give time for the further stages of the Guardianship, Maintenance and Custody of Infants' Bill.

Cobden Club.—Conference, October 5th, 6th and 7th, 1920. Representatives, Mrs. Swanwick and Miss Ward.

Conference on Parents' Committees, September 30, 1920. Representatives, Mrs. North Whitehead, Mrs. Swanwick, Miss Eckhard, and Mrs. Raymond Unwin.

Women's Freedom League.—Equal Suffrage meeting (for women under 30), October 19th, 1920.

N.U.S.E.C.—The N.U.S.E.C. took the opportunity of holding a mass meeting in the Central Hall, on 29th November, 1920, to celebrate the American women's victory, when Mrs. Chapman Catt and other members of the International Board of Officers of the Women's International Suffrage Alliance visited England.

National Peace Council.—Education Conference, January 12th, 1921.

Association for Moral and Social Hygiene.—Meeting to consider action against objectionable clauses in the Criminal Law Amendment Bill, January 30th. Representatives, Mrs. Swanwick, Mrs. Raymond Unwin and Mrs. North Whitehead. This Bill was subsequently withdrawn.

Workers' Educational Association.—Protest meeting against the suspension of the Education Act, February 5th. Representative, Miss Ashton.

Council for the Representation of Women on the League of Nations.—Annual Meeting, February 25th. Representative, Miss Chick.

N.U.W.T.—Meeting to protest against suspension of Education Act.

N.U.S.E.C.—Deputation to Home Office on the subject of allowances for dependants of unemployed. Representative, Miss Ward. February 9th, 1921.

N.U.S.E.C.—Deputation to Prime Minister asking for a Bill granting Equal Citizenship to women. Representative, Miss Chick. November 22nd, 1921.

N.U.S.E.C.—Deputation to Mr. Balfour, Mr. Barnes and Mr. Fisher on the question of women on the Mandates Commission.

Anti-Slavery and Aborigines' Protection Society.—Mrs. Unwin and Lady Parmoor went as representatives to the Colonial Mandate Conference at the Victoria Hotel, on February 10th, 1921.

Peace with Ireland Council.—Women's meeting on Ireland on March 18th.

League of Nations Union.—Procession and mass meeting in Hyde Park on June 25th.

In June, 1921, a Consultative Committee of Women's Organisations was formed to consider joint action in political matters especially affecting women. The W.I.L. joined this Committee, and Miss A. H. Ward is its representative.

Women's Freedom League.—Procession to express the protest of enfranchised women on the condition of affairs in Ireland, was held on 2nd July, 1921.

National Peace Council.—The W.I.L. representatives for past year have been: Mrs. Unwin, Mrs. Sanger, Mrs. Ayrton Gould, Mrs. Fyffe.

#### "HISTORIES OF THE PEOPLES."

Owing to various unforseen delays none of the series planned of the "Histories of the Peoples" is yet published. The whole of the M.S., however, of the French history is to hand, and the translation is almost completed. Part of the M.S. of the "History of the Greek People" has been received, and the remainder is promised for a date before this goes to Press. The "History of the Jewish People," which would otherwise have been ready this autumn (1921), was delayed by the author's illness and is now promised for next autumn.

#### LEAFLETS AND PAMPHLETS.

Lack of funds and excessive cost of printing and postage have compelled the W.I.L. almost to suspend publication. The News Sheet has appeared monthly as usual, and the Fifth Annual Report was issued in October, 1920.

Leaflets descriptive of the League have been issued as follows:

"What Sort of World do we Want?" (June, 1921). Price 3d.

"What is the Women's International League?" (October, 1921). Issued by the North Eastern Division of the W.I.L. Price, 2/- a 100; 18/6 a 1,000, postage extra.

Membership form, with objects, membership, etc. Price, 1d. each, 7/- per 100.

In the Disarmament Campaign the publications of the National Peace Council were used. One of these (the diagram of expenditure) was designed by Mrs. Watts of Manchester. The only Disarmament leaflet published by the W.I.L was the "Manifesto on Disarmament," produced in Manchester and very widely circulated in this country and abroad.

Under the title "As others see us," was published a short summary of the protests of the German W.I.L. against the excesses of its own Government in Belgium, France and Russia, and its plea for the self-determination of Ireland.

Under the title, "A Sort of War in Ireland" (October, 1920, price 3d.), the findings of the W.I.L. Commission were printed over their signatures.
