CONSTITUTION.

I. Title.

The title of the Council shall be "the Junior Council of the London and National Society for Women's Service."

II. Status.

The Junior Council is an organisation working independently within the London and National Society for Women's Service, whose General Meeting governs the policy of the whole Society. There is no obligation upon the Junior Council as a body to work for any one of the activities of the Society.

III. Object.

The Junior Council supports the aim of the London and National Society for Women's Service for equality of citizenship between men and women, and works specially for equal economic opportunities and freedom for women in the pursuit of their work.

IV. Methods.

- 1. The Council holds regular meetings of a social character, with speakers on topics of common interest and collects information on Trainings and Openings for women.
- 2. The Council enables professional and business women to meet each other, and links up students with women already practising or in business.
- 3. The Council provides opportunities for the development of new enterprise.

V. Governing Body.

The governing body of the Junior Council shall be the general meeting of members, which will elect annually by ballot an Executive Committee, an Hon. Secretary, and an Hon. Treasurer to conduct the current business of the Council.

VI. Membership.

1. Subject as hereinafter mentioned:—

The Junior Council shall consist of (a) men and women who have or have had a professional or business qualification; and (b) of students: (i) who

support its aims; (ii) whose applications have been passed by the Executive Committee; and (iii) who have paid the current annual subscription.

- 2. The minimum annual subscription shall be 10/- for all members for five years from the date of joining the Junior Council and shall then be raised to £1. This shall apply only to those members who join on or after 1st January, 1935. Members shall have the right to use the Library, restaurant, and other facilities provided by the Society.
- 3. The Executive Committee shall have the right to terminate any membership without assigning a reason.
- 4. Membership of the Junior Council carries with it membership of the Society.

VII. Officers.

The Officers of the Council shall be the Chairman, the Hon. Secretary, and the Hon. Treasurer.

VIII. Executive Committee.

- 1. The Executive Committee shall consist of the Officers of the Junior Council, and not less than nine and not more than twelve other members to be elected by ballor at the Annual Meeting, and shall have power to co-opt not more than five additional members. A member who has served for five consecutive years shall not be eligible for re-election to the Committee until after the lapse of one year. Officers shall be eligible to serve for five years, as such, regardless of previous service as a private member of Committee.
- 2. At the first meeting after election, it shall elect the Chairman for the ensuing year.
- 3. It may from time to time make Bye-laws, and shall have power to fill by co-option any vacancies which may occur during its term of office.
- 4. It shall have power to appoint Sub-Committees for special purposes.
- 5. The Minutes of the Executive Committee of the Junior Council shall be open to the Executive Committee of the Society.

IX. Nominations.

- 1. Any member may be proposed for election or reelection as Honorary Officer or Member of the Committee on the nomination of two members of the Council to whom the candidate is personally known.
- 2. Nominations, with the consent in writing of the candidate nominated, shall reach the Secretary at least fourteen clear days before the Annual Meeting.

X. Meetings.

- 1. An Annual General Meeting of the Council, of which not less than twenty-eight clear days' preliminary notice shall be given to each member, shall be held as soon as convenient after April 1st in each year.
- 2. Special General Meetings of the Council (a) may be called at any time by the Executive Committee either of the Junior Council or of the Society, and (b) shall be called by the Secretary within twenty-eight clear days on the requisition of not less than one-tenth of the members of the Council, of not less than three calendar months' standing. A Special General Meeting shall discuss only such matters as are mentioned in the notice calling the meeting, and not less than fourteen clear days' notice shall be given of General Meetings to all members.
- 3. Joint meetings of the Executive Committees of the Junior Council and the Society shall be held at the request of either Committee.

XI Resolutions.

Proposed Resolutions to be discussed at the Annual General Meeting with names of proposers and seconders shall reach the Secretary in writing at least fourteen clear days before the meeting, and shall have been published at least seven clear days before that date. Resolutions shall be passed by a majority vote except as hereinafter provided.

XII. Alteration of Constitution.

The Constitution shall not be altered except by resolution passed at a General Meeting of the Council by two-thirds of the members present and voting, provided always that no rule of the Junior Council shall be at variance with the Constitution of the Society as a whole. The nature of the proposed alteration must be stated in the notices calling the meeting, and not less than fourteen clear days' notice given to all members.

ANNUAL REPORT, 1936.

The Annual Report furnishes the reply to those who ask: "What is the good of the Junior Council?" To questioners who assume that no disabilities remain for women, the Junior Council retorts: "Do they get equal pay with men? Are all women free to continue their work after marriage? Can they enter the Diplomatic and Consular Services?

In each case the answer is in the negative! The last eighteen years, since the passing of the Sex Disqualification Removal Act, have given so many opportunities to women, that it is all too easy to take what is there and to ignore the obstacles which still exist, unless they affect us personally. It is only then we realise the need for a well-informed and authoritative body in a position to take effective action. There is also another side which is of equal value to business and professional women. It is the opportunity they have of meeting and getting to know others in different spheres of work, whose knowledge may be of inestimable value, often in quite unforeseen directions. A very little imagination will show that a body representing well over a 100 different occupations must, by its diversity alone, offer great possibilities for making contacts which may prove invaluable. Many instances could be quoted of friendships formed, of professional help given and corporate action taken. It is not possible in the scope of an Annual Report to give an account of all the ways in which these things have been achieved and we must therefore confine ourselves to a description of the activities of the Junior

Monthly Parties.

Council during the past year.

On several occasions, the Groups have co-operated with the Executive Committee, in the arrangement of monthly parties, which, incidentally, have been fewer than in past years, owing largely to national events, which have occasioned cancellations and postponements. During the Jubilee celebrations, our minds naturally turned to other things—then, in the autumn, came the General Election, which took a number of members away into the constituencies and made it difficult to secure speakers for Junior Council meetings.

The death of H.M. the King at the beginning of the year plunged the nation into mourning and put an end, for the time being, to all public functions. Thus it will not surprise members to learn that some of the parties the Executive Committee had hoped to organise are still ahead of us. They have however reached the stage of a subject chosen, a speaker invited and dates tentatively fixed.

In May of last year, the Junior Council Executive, with the valuable co-operation of the Law Group, invited Mr. Richard O'Sullivan, K.C., to speak on "The Trial of Sir Thomas More." Mr. Douglass Woodruff, M.A. took the Chair. Miss Irene Stoney, Chairman of the Law Group Committee, opened the proceedings with a short speech of welcome to the speaker and Chairman. It was unanimously agreed by the audience, numbering about 150 people, that Mr. O'Sullivan presented a masterly survey of the "Trial" and in her vote of thanks, Miss C. M. Young (barrister-atlaw) testified to the enjoyment and appreciation of her fellow members and their guests. The dinner which preceded the party was well-attended and after the meeting, many members adjourned for refreshments.

This party was followed in June by another highly successful event, the work of the Commerce Group Committee in collaboration with the Executive Committee. Thanks to the splendid efforts of Miss Hanbury Hopkins, and her Committee, an immensely popular evening was arranged, entitled "Behind the Screens," when Mr. Andrew Buchanan, the well-known producer of the Gaumont-British Magazine and author of Films—the way of the Cinema, was the speaker and Mr. Beverley Baxter. Director of Public Relations, Gaumont-British Picture Corporation, took the Chair. Mr. Buchanan told his audience that when he joined the film industry, about fourteen years ago, everyone regarded him curiously, as though he was going to be a clown or a sword-swallower, as it was never thought possible that anyone could seriously intend to concern themselves with such hare-brained ideas. He took his audience through the evolutionary stages of the cinema, from the days of primitive motion pictures found to have existed in Ancient Egypt; the creation of the Kinetoscope by Edison; the silent films, when Charles Chaplin, Mary Pickford, and Douglas Fairbanks made history; the advent of sound films in America and the consequent language difficulties. Many interesting points were illustrated on the way, and the Junior Council has to thank Mr. Buchanan for a deeply interesting and educative evening.

Later in the year, we switched to a very different subject, when Miss M. A. Murray, D.Lit., late Asst. Professor of Egyptology, London University, at the invitation of the Executive Committee, made a special journey from Cambridge to London to speak on "Archæological discoveries in Egypt and Palestine." Her talk, illustrated by excellent slides, proved most fascinating and the audience was thrilled to hear of the excavations in which Miss Murray herself has played so great a part. It was evident that here was an outstanding personality; in addition to her extensive knowledge and long experience in the field of archæological research, she possessed the power to control large gangs of Egyptian workmen and to organise most efficiently the conditions under which they carried out her orders. Miss Murray is also an authority on "Witchcraft in the Mediæval Ages" and promised to come again at a later date to talk on this enthralling subject.

In January of this year, we had the pleasure of welcoming an old friend and member of the Society, when the Executive Committee and the Arts & Letters Group invited Miss Constance Prescott, M.B.E., B.A. to give a lecture on "Chinese Art," to celebrate the Chinese Art Exhibition being held at that time at Burlington House. Those of us who have heard Miss Prescott on previous occasions knew there was a treat in store for us and our expectations of an entrancing evening were well justified. In addition to a scholarly interpretation of her subject, Miss Prescott interposed many charming illustrations of the poetry and imagination portrayed by those great artists of a bye-gone age, whose work fills us to-day with a perpetual wonder and delight. As always, the slides were excellent, and to her many admirers as a lecturer, Miss Prescott added a goodly number that evening, among them Dr. Chen Wei-Cheng, Counsellor to the Chinese Embassy, who took the Chair.

Egypt and China having previously occupied our thoughts, the following month we travelled northward along the international road and in February we heard the Baroness Palmstierna, wife of the Swedish Minister in this country, describe "How the Swedish women reached their present-day position." On this occasion, the Chair was graced by Mrs. Kinnell, ever the honoured friend and supporter of the Junior Council.

Arts & Letters Group.

In addition to very valuable collaboration in organising the Chinese Art Lecture, the Group broke new ground at their May Party, when Miss Christine McClure sang Jacobite songs and told the "Story of the Forty-five." In her lecture-recital, she was accompanied at the piano by Mrs. Dora Gothard. After the preliminary introduction, Miss McClure took us through the successive phases of the Jacobite Movement, the rebellion of 1715 and its failure, the waiting time, with the songs written by exiles, the landing of Prince Charlie in 1745, the Forty-five and lastly, the Jacobites' farewell to the Prince. Those members of the Group who were unable to be present missed a good evening, as was demonstrated by an enthusiastic audience, which begged Miss McClure to come again.

In the autumn, the Group spent a pleasant Saturday afternoon visiting Sir Herbert Cook's Art Collection at Doughty House, Richmond Hill and recently Miss Harvey gave a most illuminating description of the work of the Women's Institutes. Those present at this party reported afterwards that Miss Harvey's narrative was so absorbing as to be worthy of a much larger audience. Some excellent examples of craft work were exhibited.

Miss J. D. Blackman was unanimously re-elected Chairman for the year and Miss A. Fenwick and Miss S. N. Brown as Secretary and Asst. Secretary. We reluctantly take leave of the former, who has gone to Poland to take up a year's appointment on the editorial staff of an intellectual quarterly publication. Miss M. E. Harries (textile designer) joins Miss Brown as co-secretary.

Law Group.

A debate with the 1919 Club, which has now become an annual fixture, was held on April 30th, 1935. The motion chosen was the eminently topical one of "That this House welcomes Belisha as a worthy follower of Hitler." Miss Venetia Stephenson, seconded by Miss A. Ll. Amphlett, proposed the motion on behalf of the Law Group and was opposed by Miss Thomas, seconded by Miss Hastie. After a heated discussion, the motion was lost by three votes.

Another very topical title chosen for a party at a later date was "Legal and commercial effects of economic sanctions" with Dr. H. Lauterpacht, Ll.D. and Mr. David Wills as speakers. The Chair was taken by Miss Hilda Clark, M.B., so well-known as an apostle of peace.

Miss Irene Stoney, who has continued to fill the role of Chairman during the past year, has conceived the idea of holding readings from books in the Library once a month, with a view to tamiliarising members with the many unknown treasures on its shelves, and, as a beginning, in June proposes to take "The Trial of Mary Blandy" in February, 1752 for the murder of her father, Francis Blandy, Gent. with white arsenic procured by her lover.

Miss Amphlett has well justified her appointment as Hon. Secretary of this Group, and we hope that she may long continue to fill this post.

Political Group.

One of the pleasantest parties held in the last year was a reception for secretaries to Members of Parliament when Major Hills, M.P. sprang into the breach at the last moment to deputise for Mr. Robert Bernays, M.P., who was pledged to speak on "Personalities in the House of Commons" and was prevented at the last moment from fulfilling his promise. Not only was this a most popular event, largely due to our good fortune in securing so distinguished a substitute speaker, but it brought a number of valuable members to the Junior Council, among them Miss M. Sneath, who accepted an invitation to join the Political Group Committee last autumn. In addition, the Committee has welcomed as its members Miss P. M. Brandt, Miss M. E. Brasnett, Miss P. Knox, Miss E. Thomas and a senior member of the Group, Miss G. E. Thompson.

The next meeting took the form of a discussion on "Are we over-educating our future citizens?" The Group had the good fortune to secure Miss Ahrons, member of the Senior Executive Committee of the Society and until lately one of the Inspectors of the Board of Education, to open the discussion, in which many of those present joined, among them members of the Arts & Letters and Social Work Groups.

Just before Christmas, the Group constituted itself an INTER-PARTY CONGRESS, at which were disclosed existing abuses in the selection of Parliamentary candidates, followed by suggestions to all parties on the best methods of securing their representation in future elections by Youth and Genius. A special welcome was extended to hecklers and agitators, but in actual fact the discussion was kept on an amicable and amusing plane.

In March of this year, the Group held a party on somewhat more academic lines, when the Rt. Hon. Josiah Wedgwood, P.C., D.S.O., M.P. came to talk on the "History of Parliament," a subject on which he is so great an authority. His speech evoked many eager questions on the part of the audience and sent us away with the desire to study still

further the evolution and growth of the complex machinery

by which we are governed.

Our thanks are due to Miss Amicia Carroll, the indefatigable Chairman of the Group, for shouldering so large a share in the planning of parties, and to Miss D. G. Sara for taking on the duties of Secretary.

Science Group.

"The folly and danger of noise" was the topic chosen for the first spring party, a suitable time of year to discuss this growing menace to our peace of body and mind. The fine weather which causes us to throw up our windows to let in the sun and air also results in an increasing number of noisy cars on the road, and although the regulations with regard to hooting at night have resulted in a considerable diminution of unnecessary use of the horn in the day-time, engines cannot be said to run silently! Mr. H. G. Strauss, a member of the Council, Anti-Noise League, was the speaker and the Chair was taken by Miss Ethel Watts, B.A., A.C.A., for so long the valued Chairman of the Junior Council and now Chairman of the Executive Committee of the Society.

In the course of the year, two expeditions were undertaken, one in June to Whipsnade, when a party of about twenty members and friends visited the Zoo and were specially conducted round the Gardens by the Head Keeper, and the other in November, when the Group was invited on a Saturday afternoon, to inspect the Battersea Power Station.

In October, Miss Sheila Bevington, Ph.D., lecturer and investigator at the National Institute of Industrial Psychology and a member of the Junior Council, gave an extremely interesting talk on "Vocational Guidance" which was well attended by members (both senior and junior) and their friends.

Miss Mary Field, M.A., Director of the Gaumont-British Instructional Ltd., accepted an invitation to speak on the production of nature films in March last, with Professor Winifred Cullis, C.B.E., M.A., D.Sc. in the Chair. Unfortunately, two days before the party, Miss Field was laid low with an attack of influenza. Mr. William Farr, Acting-Manager, British Film Institute, gallantly took her place, although due to leave that night for a speaking engagement in Belfast. He took as his subject the production of films generally, enlightened his audience on technical points and led a very lively discussion on many and varied aspects of the industry. Professor Cullis gave up a rare free evening to take the Chair and the Members' Room was crowded to the doors—an altogether successful party.

Miss Roberts as Chairman, and Miss Leigh-Clare and Miss Fischer as Secretary and Asst. Secretary are to be congratulated on their efforts.

Commerce & Business Group.

In spite of the number of brilliant parties arranged by them, the Committee decided that the Group was not being sufficiently actively supported to warrant its continuance and at a General Meeting held on Thursday, October 17th, 1935, it was proposed and carried that the Group be dissolved. A warm vote of thanks to Miss Hanbury Hopkins, the Chairman, for the great amount of work undertaken by her was proposed by Miss Selby and carried unanimously.

Social Work Group.

With great regret we have also to record the decision of the Social Work Group to wind up its activities, owing to lack of interest and support on the part of members.

If, however, at any future time, a desire should be expressed by ten members for a revival of either of these Groups, or any other new Groups, the Executive Committee will be glad to know of it.

Sherry Parties.

Several sherry parties have been held in the course of the year, at one of which Miss Arnot Robertson, the well-known author, made an informal speech to the effect: "That women won't be freed." Mrs. Oliver Strachey took up the challenge on our behalf and several Junior Council members contributed their views, leaving the impression that the majority of those present did not share the contention of the first speaker.

Bridge Circle.

The Bridge Circle has continued to meet every week, on Tuesday evenings, and a good game can be relied on. Dinner is always available for those who order beforehand.

A Bridge Party, with excellent prizes, was organised by Miss Douglas in collaboration with Mrs. Thomson Bowen, who ran the Christmas Fair, which resulted in a profit of £8 for the funds of the Society.

Christmas Fair Dance.

Mrs. George Burton, with a Committee set up for the purpose, of which Miss M. L. G. Bagnall was Hon. Secretary, organised a Junior Council Dance on December 10th and handed over a profit of £15 5s. 6d.

League of Nations Union.

Mrs. D. W. L. Daniels has continued to represent the Junior Council most ably on the Women's Advisory Council and has sent in excellent reports.

Marsham Street Players.

During the past season the Marsham Street Players have been able to give three performances. The first on Thursday, November 21st, 1935 when "Dangerous Corner" by J. B. Priestley was ably performed. This was a very successful

and pleasant evening.

On Wednesday, February 12th the Players gave an excellent presentation of three one-act plays: (1) "The Wardrobe" written and produced by our Producer, Mr. Arthur Ewart; (2) "I plan for myself" written and produced by one of our own members, Miss Mary Lane; and (3) "Symphony in Illusion" by James Wallace Bell. The first two plays were charming and the Society is to be congratulated upon having such talent amongst its members. "Symphony in Illusion" was entered for the Drama League Festival and was played at King George's Hall on February 14th, the team being placed eleventh out of an entry of ninety. The Adjudicator gave a very good criticism and commented, among other things, on the excellent production of the play. He also made special reference to the scenery, which he said was adequate and very artistic.

The final performance of the season "I'll leave it to you" by Noel Coward, was produced on Tuesday, April 21st.

Once again the performance was a great success.

Mr. Arthur Ewart, of the Lena Ashwell Players, has put in a lot of hard work in the season's productions and the Players are benefiting greatly by the assistance he is able

to give them.

This season the Players have been fortunate in being able to acquire an interior set of scenery, This scenery has been "let" to other Societies performing in the Millicent Fawcett Hall thereby helping the funds of the Players. It is hoped that next season more Societies will take advantage of hiring this scenery so that the Marsham Street Players may improve and augment the scenery and procure some very necessary props.

The Marsham Street Players are still very anxious to increase their membership and new Subscriber and Acting

Members can be assured of a warm welcome.

The Walkers' Club.

The main feature of the Walkers' Club during the past year was a Whitsun week-end walk along the Pilgrims' Way from Maidstone to Canterbury, in which nine pilgrims—seven Junior Council members and two friends—took part. The route proved varied and interesting all the way. Owing to the enthusiastic determination of the leader (M. V. Wallace) to stick to the original route, in some places discarded by pilgrims of to-day and very much overgrown, it proved at times to be exciting as well! Good weather, two days' good walking, and a day in Canterbury, including of course a tour of the Cathedral, provided a splendid Whitsun holiday at moderate cost.

The monthly walks arranged by the Club are themselves becoming something in the nature of a pilgrimage, for fields give place to bricks and mortar at an astonishing rate, and every year the journeys out to the starting point will necessarily grow longer. In spite of this, with the aid of Ordnance maps and local exploration, cross-country routes have proved as inexhaustible as the beauties of our lovely southern countryside. Recent walks have embraced five counties—Kent, Surrey, Essex, Herts. and Bucks. The walks are not over-long or over-crowded. Most people can do ten or twelve miles in a day and the Club would welcome new members. Any member of the Junior Council can walk either occasionally or regularly without payment of any preliminary fee, as there is no annual subscription. A leaflet concerning the Club has been issued and is obtainable from the office.

General Work of the Society.

The Junior Council participates in the Society's general work in two ways. In the first place, its members, equally with the other members of the Society, are eligible for the main Executive Committee, and of the fifteen members of that body five are, this year, members of the Junior Council; one of whom holds the distinguished position of Chairman of the Society's Executive Committee. In the second place, members of the Junior Council take part in the general work through membership of the Executive's Public Work Sub-Committee which meets monthly to consider matters affecting those interests of women which come within the Society's scope.

This Committee is always much occupied with the employment of women in the State and local Government services; for the public, as their employers, have a special responsibility towards them and through the power of the vote it is possible to exercise a certain measure of control. In the past year, the Committee has devoted much time to the campaign for equal pay for women with men in the

common classes of the Civil Service which culminated in the spectacular result of the defeat of the Government. Another subject to which endeavour is constantly turned is that of the employment of married women, and the L.C.C.'s removal of the bar for teachers and doctors marked a great step forward in a struggle of long standing. The Committee has continued to work for the admission of women to the Diplomatic and Consular Services and for the fuller opportunities for them in various Government departments, it has shared in obtaining a wider acceptance of the rights of women in the later stages of the India Bill, and has contributed to influence the discussion on the Status of Women in the Assembly of the League of Nations last September.

The Committee has been concerned on behalf of fair play for women in employment in many more directions than can be here recorded, endeavouring always to take its stand on an accurate knowledge of the facts. Without this such work would be futile and here the Society is supported by the admirable organisation of the Women's Service Library.

According to our present vote by which three members of the Committee retire in rotation each year, we lose Mrs. Burton and Miss Scott whom we should like to thank for their loyal and devoted service during their term of office.

The third member to retire is to our great regret, our Chairman Miss Hancock.

Members will have an opportunity later of expressing their appreciation of Miss Hancock's services, but I cannot conclude this report without putting on record the Executive Committee's deep appreciation of Miss Hancock's able chairmanship, her unfailing patience, grasp of detail and sound judgment and their thanks for the time and energy she has given unstintingly to the work of the Society, both in Committee and elsewhere during a term of office which has marked a none too easy period in our history.

Conclusion.

This year, as in previous years, the Executive Committee cannot conclude their report to the members of the Junior Council without expressing their gratitude for the support received from the members. In particular, they desire to thank all those who have helped in special ways, whether by taking a leading part in the organization and work of the Groups, the Marsham Street Players and the Walkers' Club, etc. It is this loyal support and co-operation on the part of the members which is and must always be lifeblood to any democratic organization.

I. Appointment of Tellers.

Moved from the Chair, seconded Miss H. Mosely and passed that Miss Brasnett and Miss Sneath should act as Tellers.

II. Appointment of Auditor.

Moved Mrs. George Burton, seconded Miss C. G. Gatey and passed that E. Watts & Co. be appointed Hon. Auditors for the ensuing year. It was also proposed Mrs. Burton and enthusiastically carried by the Meeting that a special vote of thanks be passed to the Hon. Auditors for their generous services ever since the inception of the Junior Council.

III. Diplomatic and Consular Services.

Leave was asked from the Chair and granted to move the following urgency resolution:—

"That this Annual Meeting of the Junior Council of the London & National Society for Women's Service expresses its profound disappointment at the decision of the Government not to allow the admission of women to the Diplomatic and Consular Services, thereby restricting the field from which the best qualified candidates could be selected.

"This Meeting is convinced that the introduction of suitable women to these services would help to promote international understanding and decides to continue its work for this object with unabated vigour." Carried.

IV. Annual Report.

The Annual Report was then read by the Hon. Secretary, Miss K. M. Halpin. Moved Miss E. H. Garnham, seconded Miss W. M. S. Moss and passed "that the Report be adopted, printed and circulated."

Miss Strachev asked leave to congratulate the Junior Council on the variety and interest of its many activities.

V. Treasurer's Report.

The statement of accounts was read by the Hon. Treasurer, Miss M. H. Pearson. Moved Mrs. R. W. Knollys, seconded Miss M. Whyle that the financial statement be adopted. Carried unanimously. Moved Mrs. Burton, seconded Mrs. Knollys and carried:-

"That the Annual Meeting endorse the resolution passed at the last Meeting of the Executive Committee to post in the entrance lobby a list of members whose subscriptions are six months in arrears."

VI. Constitution. Alteration of Rules.

Rule 8. Executive Committee. Proposed by Miss A. Carroll, seconded Miss H. O'Malley. Paragraph 1. Delete from:—"Three members of the Executive Committee" to the end of the paragraph, and substitute the following:-"A member who has served for five consecutive years shall not be eligible for re-election to the Committee until after the lapse of one year. Officers shall be eligible to serve for five years, as such, regardless of previous service as a private member of Committee." Carried.

VII. Resolution in Support of Equal Pay for Equal Work.

Proposed by the Executive Committee from the Chair:—

"That the Junior Council place on record their appreciation of the action of the House of Commons on April 1st last in re-affirming their support of the principle of equal pay for equal work by men and women; the Committee, being convinced that this vote represents an advance in public opinion, record their profound dissatisfaction with the attitude of the Government on this occasion and determine to relax no effort until effect has been given to the wishes of the House by granting equal pay to the women with the men in the Common Classes of the Civil Service." Carried unanimously.

VIII. Election of Executive Committee.

Miss M. H. Pearson, as Hon. Treasurer and Miss K. M.

Halpin as Hon. Secretary were re-elected.

The names of members serving on the newly-elected Executive will be found on the first page of the Report. No ballot was held as the nominations corresponded with the vacancies available.

Other Business.

Vote of thanks to retiring Chairman by Miss E. Russell-Smith.

I am very sorry to be in a position to thank Miss Hancock for her services as Chairman of the Junior Council Executive Committee because we are all going to miss her so much, both the Executive Committee and the Council itself. It will be very different without her. She has combined the heavy duties of Chairman with a particularly arduous and difficult outside job.

After the sort of day which would make most people want to scratch the face of the first person they met, she has been just as patient with particularly argumentative and self-opinionated members like myself, as if she had spent the whole afternoon resting in the garden. In the long run, women's work should be judged by what they do on their outside jobs. There is one thing more important than being women doctors, women solicitors, and women Civil Servants and that is being good doctors, good solicitors and, to use the highest form of praise known to some of the older members of my own profession, to be competent clerks. Above all, we must be good colleagues.

In all professions one comes across people with the most brilliant mental equipment and the most outstanding qualities who stultify themselves and are their own worst enemies because they have never learnt how to be a good colleague. Perhaps they have looked at things rather too much from a personal point of view, so that they seem unable to play their part as units in a big machine; they should be able not only to do their own work well, but to do it so that everyone else works well too.

Miss Hancock has been a good Chairman and a good Colleague, as I have had occasion to know, and she carries with her our best thanks and good wishes for the future.

Miss S. Lister seconded the vote of thanks, and with Miss Hancock's name coupled those of other retiring members of the Committee, Mrs. George Burton, Miss Elisabeth Scott, A.R.I.B.A., and Miss Russell-Smith herself. Carried unanimously.
