MOTTO OF I.C.W.:

THE GOLDEN RULE:

'Do unto others as ye would that they should do unto you.'

OBJECTS:

1. To bring together women's organisations from all parts of the world for consultation on action to be taken to promote the welfare of mankind, of the family and of the individual.
2. To work for the removal of all disabilities of women.

PRESIDENT'S MEMORANDUM

For the eighth time I have the honour of presenting you the customary President's Memorandum after a plenary Council Meeting.

It should have been my *ninth* Memorandum, but unfortunately it was decided that for economical reasons no Memorandum should be printed after the Paris Council Meeting of 1934. That Council therefore remains without permanent record, beyond the report given in the I.C.W. Bulletin of July, 1934, and which should therefore be carefully preserved.

I trust that the present Memorandum, together with List of Resolutions adopted at Dubrovnik, and other documents necessary for reference, may be put together in a form in which they can be placed along with former volumes of Council Transactions.

THE PASSING OF I.C.W. PIONEERS.

Since our last Council Meeting in Paris, the I.C.W. has lost two of its most outstanding figures—Madame Chaponnière-Chaix, at the age of 84, in January, 1935, and Frau Marianne Hainisch, at the age of 97, in May, 1936.

They were amongst the very few remaining pioneers who took part in the founding of their own National Councils and of the I.C.W., and their influence in the development of the Council idea throughout the world has been far reaching. Tributes have been paid elsewhere to the personality and work of these two most remarkable women, and I will therefore only here record my own and the International Council's undying gratitude to these leaders, to whose devotion and vision women all over the world owe so much.

ORGANISATION OF NEW COUNCILS.

Regarding the formation of new National Councils I can only present one, that of *Japan*, where a National Committee was formed some years ago with the express purpose of developing into a National Council. The number of Societies affiliated with this Committee and its Constitution fully qualify it to the status of a National Council, and I have therefore presented it for affiliation as such to the Executive Committee, although it prefers to retain the name of National Committee. We welcome Japan very heartily into our International family.

The National Council which we thought was on the point of being formed in *Spain* when our Council met at Paris, has not materialised, and under the present heart-breaking conditions of that country, we cannot hope for any such movement to develop at present.

Southern Rhodesia has not either finally decided whether to form a National Council through its fine Federation of Women's Institutes, which indeed is already carrying out the idea of Council work in that country.

The National Council of Women in *Burma* is functioning as such very satisfactorily, and the Executive Committee have authorised its affiliation as soon as the political separation of Burma from India is formally accomplished. My daughter, Lady Pentland, had a most interesting visit to this Council.

The women of the *Philipines* have also indicated their desire to form a National Council when the political recognition of the independence of the Philipines is carried into effect.

Under the head of organisation, I think I should also congratulate the National Councils of *Belgium* and of *Poland* on the excellent results they have obtained through very careful and thorough re-organisation of their Constitutions and methods of work.

I welcome very heartily the proposal of the National Council of Women of *Hungary* that each National Council should prepare a short history of its own Council. This would be very valuable, and the work should be undertaken before the Council pioneers have passed away. Some Councils have already undertaken this work on their own initiative.

SPECIAL INTERNATIONAL CONFERENCE AT CALCUTTA, JANUARY, 1936.

I wish to record my sense of the great value of the International Conference held at Calcutta under the joint management of the I.C.W. and the National Council of Women in India. The representative character of the Conference and the interest manifested in it by the public and by the Indian Press was most gratifying. The earnestness and the ability of the Indian women deeply impressed the visiting I.C.W. delegates from other National Councils, who all gratefully record the extraordinary kindness and hospitality with which they were received. The Conference has undoubtedly greatly strengthened the ties between the women of India and their sister workers in other lands.

It was a matter of great satisfaction that by the co-operation of our National Councils, such a representative delegation from the I.C.W. was able to attend this Conference.

It was a real grief to me to be unable to carry out my hope of accepting the most kindly urgent invitation of my friends in India personally, but I was glad to think that our Vice-President, Princess Alexandrine Cantacuzène, was able to lead the delegation, assisted by Dame Elizabeth Cadbury, and that my daughter, Lady Pentland, was able to represent me personally.

The National Council of Women in India have printed a full and most interesting report of the Conference, for which we are greatly indebted to them, at a time when our finances unfortun-

ately preclude us from printing Reports, a fact which is seriously hampering our work. The initiation of a Rural Committee under the Indian National Council of Women for the development of much-needed work in rural districts will, we hope, develop successfully.

ASSOCIATED COUNTRY WOMEN OF THE WORLD.

I wish also to congratulate our daughter Association, the 'Associated Country Women of the World,' on the outstanding success of their movement, and on the wonderful recognition of the value of that movement given to them at their Congress this year at Washington, and at subsequent meetings in Canada. I trust that the close, though informal alliance, which exists between them and the I.C.W. will always be maintained for the mutual benefit of both organisations.

I.C.W. BULLETIN.

I wish also once more to bear testimony to the value of our Bulletin in maintaining the interest of the various National Councils in each other's work and that of the I.C.W. As it is our only printed publication, we depend on it for our propaganda, and for international news of a character to interest and stimulate our workers to carry on their activities according to the ideals of the I.C.W. We are greatly indebted to our Editor, and trust that one result of our Council Meeting at Dubrovnik will be to largely increase the number of subscribers to the Bulletin, and also of advertisers.

STATUS OF WOMEN

The publication of the pamphlet on the Status of Women, compiled by Dame Maria Ogilvie Gordon, from the valuable information supplied by National Councils, has given much satisfaction, and it is hoped that National Councils will co-operate in providing the further information required in view of this subject coming up on the Agenda of both the League of Nations Assembly and the International Labour Conference.

PEACE CONFERENCE AT BRUSSELS.

A very notable International Peace Congress was held at Brussels on September 3rd to 6th, convened by Lord Cecil and M. Pierre Cot, under the auspices of the International Peace Campaign.

The I.C.W. was one of the Societies represented at this Congress by the Women's Peace and Disarmament Committee of Geneva, and also independently by Baroness Boël, acting as our observer.

Briefly stated, the four points which were agreed beforehand should be the objects for the Congress to uphold are as follows:—

1. Sanctity of Treaty obligations;
2. Reduction of Arms by international agreement;
3. Strengthening of League of Nations through Collective Security;
4. Establishment of machinery within the framework of the League of Nations for remedying international conditions likely to lead to War

and the idea was to bring together all classes and all political parties in support of these objects.

There was a great concourse of some 5,000 delegates at Brussels, who showed most effectively their will for Peace and their desire to sink all political differences for its attainment.

Baroness Boël concludes her report as Observer with the following words:

"Pour résumer l'impression retirée de l'effort fourni par ce Congrès, je ne puis mieux faire que de vous citer la phrase de Mr. Herriot lorsqu'à la séance inaugurale il a dit : 'Nous sommes ici pour affirmer notre horreur de la violence, de toutes les violences, notre réprobation de la guerre, de toutes les guerres, extérieures, civiles ou religieuses. Notre seul espoir est de réaliser dans l'ordre international ce que l'on a déjà réalisé dans les ordres nationaux.'

"Les divers orateurs ont insisté sur le fait qu'il faut organiser la paix comme on organise la guerre, en unissant toutes les bonnes volontés sans en exclure aucune, mais en demandant à toutes de faire abstraction de ce qui les divise pour ne chercher que ce qui les rassemble dans un même idéal."

MEETINGS OF BOARD OF OFFICERS.

There have been six meetings of the Board of Officers since our Council Meeting at Paris, and most of these meetings used the powers entrusted to us by the Executive in combination with the Conveners to carry on the necessary work between the meetings of Executive.

I think it is agreed that the plan has worked well, especially in view of the travel difficulties experienced by our members in these hard times.

Undoubtedly the Triennial Council Meetings involve a greater number of meetings, and many National Councils complain of being unable to provide delegates so frequently.

It may well be considered whether a return to Quinquennial Councils might not be advisable.

RETIRING OFFICERS.

Some of our Hon. Officers and Conveners, long identified with the I.C.W., did not accept re-nomination on this occasion,

and their absence from the meetings of the inner circle of workers will be sorely missed.

At Dubrovnik, the long and devoted services of Madame Avril de Sainte-Croix and of Dame Elizabeth Cadbury were acknowledged with grateful acclamation, both by their own Standing Committees, which owe them so much, and by the Council, when they were elected Hon. Vice-Presidents with loud applause.

But there was another of our very faithful friends and officers who was not present to receive the similar tribute paid to her, and who rendered us inestimable service, not only during the eleven years when she was Hon. Secretary, but during all the period of her connection with the I.C.W.—Dr. Alice Salomon.

In her letter conveying her apologies for absence, she sent the following message to her I.C.W. friends:

"My relations with the I.C.W., which have lasted continuously since 1899, have always been an inspiration and a source of deep joy for me. The ideal for which the I.C.W. stands has become the ideal of my life, and I can assure all my colleagues that I shall devote myself to its attainment just as much when I am no longer a member as I have done hitherto."

RESOLUTIONS ADOPTED AT DUBROVNIK.

Apart from the general Resolutions adopted by the I.C.W. Council on its own behalf, a large number of resolutions will be found calling for the co-operation of National Councils to make them effective.

The number of these may indeed look bewildering, and we cannot expect National Councils to take up all these subjects, but it must be remembered that each National Council has a number of affiliated Associations to whom it can distribute the work and enquiries requested, and this once more illustrates the far-reaching character of our organisation, when fully put in action by the National Councils, who are indeed the driving power behind all our work.

Support for Paris Institute of Intellectual Co-operation in its effort to promote the study of Modern Languages.

Raising of School leaving age and longest possible prolongation of compulsory school attendance.

Promotion of Children's Libraries.

Training of women for Overseas Settlement.

Watchfulness required by National Councils in regard to re-action taking place in regard to equality of sexes.

Co-operation of National Councils required in re-affirming Principle of equal right of women married or unmarried, to obtain and keep paid work.

Attention of National Councils required in difficulties of women over thirty years of age obtaining or retaining work.

Assistance of National Councils required for collection of statistics, etc., relating to Women Police movement.

Legal position of Children in different countries.

Education and training of Crippled Children.

Request to National Councils to report to next Council Meeting regarding the pre-natal Clinics and rate of newborn and infant mortality in their respective countries.

Continuation of programme adopted by Cinematograph and Broadcasting Committees, and efforts required to increase influence of women in regard to Broadcasting administration and programmes.

DEPUTATIONS TO LEAGUE OF NATIONS AND TO INTERNATIONAL LABOUR OFFICE.

As the date of the Dubrovnik Council made it impossible for our usual deputation to wait upon the President of the Assembly, the Secretary General kindly received us, before the Assembly opened, and undertook to convey to the President our message of renewed allegiance to, and support of, the principles of the League.

M. Avenol also undertook to mention in the League's official Journal the messages of support and good wishes which were being sent direct by our National Councils.

The Deputation which consisted of myself, Mme. Avril, Melle. van Eeghen and Dr. Renée Girod, also expressed our earnest hope that the Humanitarian Section of the League might be able to render some assistance to the suffering people of Spain, irrespective of the parties to which they belonged.

The Director General of the International Labour Office also received our Deputation with his usual cordiality, and discussed with us the extensive survey now being made by the International Labour Office as to the position of women in all the different countries, both as to legal and actual point of view, and including unemployment, training, wages, and family relations.

Mr. Butler's subsequent letter to me, read at Dubrovnik, and printed in the November, 1936, Bulletin, indicates the strong desire of the I.L.O. for the continued active co-operation of the I.C.W.

It was a matter of deep regret to us all that, owing to the exceptional circumstances of this year, there were no representatives of the League of Nations nor of the International Labour Office at our Council Meeting.

I.C.W. LIAISON COMMITTEE.

At our meeting of the I.C.W. Liaison Committee with the League and Labour Office we received most interesting accounts of the varied international activities of both organisations in which the co-operation of the I.C.W. could be useful and effective.

MESSAGE TO COMBATANTS IN SPAIN.

At the meeting of the Board of Officers in Geneva, it was decided to unite with the Women's Peace and Disarmament Committee in a Message of entreaty to all concerned in the conflict to observe more humane methods of warfare, and we also sent the following appeal by Air Mail, in the name of the I.C.W., to all parties in the conflict in Spain, which action was endorsed at Dubrovnik:—

"The women of all nations are profoundly distressed to hear that negotiations undertaken by the Diplomatic Conference at St. Jean de Luz in the hope of lessening the horrible sufferings of the people of Spain by persuading both parties in the conflict to accept more humane methods of war, especially as regards prisoners and hostages and protection of women and children, have broken down. The mothers of all races entreat those in authority, and especially the Generals in command of the contending armies, to listen to their appeal."

FINANCE.

The meeting of the Finance Committee at Dubrovnik and the subsequent adoption of its recommendations by the Council were notable for the goodwill and heartiness which prevailed, in spite of specially trying international difficulties, and were a gratifying tribute to our Honorary Treasurer's efforts to set the financial arrangements of the I.C.W. on a more satisfactory and permanent basis.

The efforts which had been made by the National Councils were gratefully acknowledged, as also the generous gifts of Indian friends and others to the funds of the I.C.W. and which enabled the Treasurer to announce that all debts had been discharged.

NEW STANDING COMMITTEES.

The formation of a Housing and Town and Rural Planning Committee, under the leadership of Lady Pentland and Fröken Ingeborg Krafft (Norway), fulfils a long standing desire of many of our members, and is certain of cordial support from National Councils, as also will be the case in regard to the new Broadcasting Committee, under Dr. Castellani (Italy) and Fru von Konow (Sweden).

INTERNATIONAL ANTI-RHEUMATISM CAMPAIGN.

The identification of the I.C.W. with the International Campaign against Rheumatism is also a forward step under the Public Health Committee, which has all our best wishes.

REVISION OF I.C.W. CONSTITUTION.

The long expected revision of the Constitution was finally completed, under the Chairmanship of the Dowager Lady Nunburnholme, at two special meetings of the Council, and came into force at once, except with regard to the election of Officers, which necessarily had to be carried out under the nomination plan of the old Constitution.

Our heartiest thanks are due to those who have contributed to the completion of this distasteful bit of work.

GRATITUDE TO OUR HOSTS IN YUGOSLAVIA.

We are under a deep debt of gratitude to our friends of the National Council of Yugoslavia—to its President, Mme. Petkovitch, and all her colleagues, not only in Dubrovnik, but in every part of the country where any of our delegates visited, and to our own Miss Christitch, who has exerted herself so unselfishly on our behalf during many months. And to Her Gracious Majesty Queen Marie, who has shown such a true personal interest in our work, as well as such generous hospitality, and to the Yugoslav Government, and to all the citizens of Dubrovnik who have shown our delegates so much courtesy and kindness, we offer most heartfelt thanks.

SERVICES OF HEADQUARTERS STAFF.

And whilst recording these thanks, let me also emphasise the unanimous and enthusiastic expression of thanks passed by the Council to our Secretarial Staff at Headquarters Office.

On Miss van Veen and Miss Günther lies the chief burden of our multifarious activities. Their entire devotion to our interests, which they make their own, is beyond all praise. But our danger lies in taking undue advantage of that devotion to which we mainly owe our success.

In conclusion, let me say what a real joy it is to me to leave our beloved I.C.W. in the hands of a President who understands our ideals, who will devote herself to their realization, and who will guide you with wisdom and affection along the path illuminated by our Golden Rule.

To her, and to her new Board of Officers and Conveners, I beg to offer confident good wishes.

Work and fellowship inspired under our ideals can never fail, whatever its outward developments may be.

It has enriched my life for well nigh fifty years, and has given me innumerable wonderful friendships, shared in to the full by my husband, who so completely identified himself with my work and made it possible.

And so I close my last President's Memorandum in a spirit of deepest thankfulness.

This is no farewell to my friends of the I.C.W., but just a halt at a milestone, where we may all renew our pledge of service, under whatever circumstances we may be placed, in this world or the next.

List of Resolutions passed by the Council Meeting held at Dubrovnik, Yugoslavia, from September 28th to October 9th, 1936.

I.C.W. CONSTITUTION.

That as the new Constitution cannot be put into operation until it has been adopted by the full Council, the elections shall take place in accordance with the present Constitution.

The Board of Officers elected at this Council Meeting shall accordingly hold office during the period 1936-38.

With this exception, the new Constitution shall be brought into operation immediately on its acceptance.

RESOLUTIONS DEALING WITH THE FORMATION OF NEW STANDING COMMITTEES.

Division of the Cinematograph and Broadcasting Committee in two separate Standing Committees.

Having regard to the different nature of many of the problems associated with the uses of the Cinema and of Broadcasting, and the fact that few individuals are able to acquire and maintain an intimate acquaintance with both these subjects,

The International Council of Women resolves to subdivide the existing Standing Committee into two separate Committees each with its own officers and members, to be named respectively Committee on the Cinema and Committee on Broadcasting, the work of both Committees to continue as heretofore to be linked up through the I.C.W. Liaison Officer with the International Organisation of Intellectual Co-operation of the League of Nations and other correlated international bodies.

Housing Committee.

The International Council of Women constitutes a Standing Committee on Housing in order to study improved methods of town and rural development planning, and to encourage higher standards in matters relative to the hygiene of housing and the comfort and well-being of the people in every condition of life.

RESOLUTIONS DEALING WITH THE SEMI-CENTENARY JUBILEE MEETING IN 1938 AND THE JUBILEE FUND.

Jubilee Meeting in 1938.

That in view of the fact that the year 1938 will mark the 50th anniversary of the origin of the International Council of Women, the next plenary Council Meeting shall be held in that year instead of the year 1939 and shall take the form of a Jubilee Celebration.

Lady Aberdeen Fund of the I.C.W.

That the International Council of Women shall establish a Jubilee Fund in connection with the Jubilee Meeting of the I.C.W. in 1938 and that, as a mark of our affection and in recognition of the great work which Lady Aberdeen has accomplished for the I.C.W. and for international good-will throughout the world, the fund be named the "Lady Aberdeen Fund of the I.C.W."

ERADICATION OF SLAVERY.

The International Council of Women welcomes the Report on Slavery communicated to the Council of the League of Nations by the Advisory Committee of Experts at the close of its session in April, 1935. The International Council of Women would particularly draw attention to the statement of the Committee that in some cases there was insufficiency of information in the Governmental documents provided, and desires warmly to support the Committee's suggestion that they be allowed to hear direct evidence on points arising in the documents supplied by the Governments.

The I.C.W. notes with satisfaction the inclusion in the Report of practices or customs restrictive of the liberty of the person, e.g. the 'Enslavement of children disguised as adoption,' and certain forms of peonage. It regrets the decision of the Committee to exclude from their purview the custom of the acquisition of girls by purchase, which goes under the name of payment of dowry. The I.C.W. hopes that the Committee will re-consider this matter in the near future.

The affiliated National Councils of Women are urged to follow closely the work of this Committee of the League and to keep before the public in their own countries the urgent need of co-ordinated efforts on the part of the Governments in order to accomplish the complete eradication of Slavery in all its forms.

SURVEY OF THE HISTORY OF NATIONAL COUNCILS.

The International Council of Women asks its National Councils to write a short survey of their history. Such a book would serve as documentation testifying to the utility, necessity and the great importance of women's work all over the world.

RESOLUTIONS DEALING WITH THE WORK OF THE INTERNATIONAL STANDING COMMITTEES.

FINANCE COMMITTEE.

Contributions from National Councils.

That in Article III, paragraph 8, of the new Constitution the following sentence be added: "That each Council shares the financial burden of the International Council of Women by an allotment of shares or units of equal size—the number of units

being in proportion to the annual income of the individual Council. The relative income of every other Council having been taken into consideration."

PRESS COMMITTEE.

Journalism as a Career for Women.

Considering the influence of the Press on the mentality of the public and the difficulties which the work of women meets all over the world, the International Council of Women urges National Councils to do their utmost to promote journalism as a career for women and especially to keep the younger generation of women journalists well informed regarding the woman's movement and any advance made in the work for peace and the other aims and purposes of the International Council of Women.

Bibliography or Card Index re Woman's Movement.

The International Council of Women request National Councils, either alone or in co-operation with other women's organisations in their respective countries, to keep a bibliography or a card-index recording national developments in the woman's movement, in order that a complete survey may at any time be available within the Council.

Importance and Wider Circulation of I.C.W. Bulletin.

The International Council of Women desire to emphasise the importance and value of rapid interchange of information between members of the Council and begs that more use be made of the Bulletin, especially in reporting successes and advances that can be helpful in other countries. It also urges all National Councils to make more use of the useful information made available in this way by largely increasing the circulation of the Bulletin.

PEACE AND ARBITRATION COMMITTEE.

Upholding of the Covenant of the League of Nations.

The International Council of Women realising that only by international agreement and friendship can war be averted and civilisation saved begs its affiliated National Councils to urge their respective Governments to uphold by every means in their power the Covenant of the League of Nations.

Poison Gas.

The International Council of Women welcomes with satisfaction the protests voiced by the Medical Profession in various countries on the use of Poison Gas in warfare as degrading and inhuman, causing untold suffering, both mental and physical, and calls upon the Governments of all countries to prohibit its use according to the Convention of the League of Nations.

Establishment of an effective Peace Settlement by Re-enforcement of the League of Nations.

The International Council of Women re-affirms its whole-hearted opposition to war, and its unswerving faith in the necessity for international collaboration for the promotion of Peace and the Common Welfare of all nations.

The International Council of Women believes that the present situation must be utilised to establish an effective Peace Settlement, by a re-enforcement of the League of Nations, based on the principle of the representation of all nations each having equality of rights and responsibilities under the Covenant of the League, interpreted in the light of recent events.

The International Council of Women further believes that the essential elements in such a settlement are:—

- (a) The redress of grievances, national, economic and political, by pacific means, and the development of the economic and other co-operative services of the League of Nations.
- (b) The drastic reduction and limitation of armaments by international agreement.
- (c) United responsibility for collective action to prevent a breach of the common peace or a disregard of disarmament obligations.
- (d) Restoration of the sanctity of Treaties.

The International Council of Women urges the Governments forthwith to organise the necessary international discussions to achieve these ends.

World Peace.

Convinced that the League of Nations must be supported by enlightened public opinion the International Council of Women requests its National Councils to do their utmost to maintain their confidence in the League of Nations in order to increase its influence and its power.

Strengthening of International Organisation.

The International Council of Women appreciating all difficulties in the way of Peace urges the National Councils to ask their respective Governments to support all measures to strengthen international organisation and to prevent private interests from interfering with the common interest, notably in all that concerns the manufacture, sale and exportation of arms.

Distribution of Raw Materials.

The International Council of Women recognising that the development of peaceful relations between nations requires an early attempt to deal with the economic problems bearing upon access to raw materials and markets so as to provide a more equitable distribution of the world's resources,

- (1) Urges the League of Nations to set up the necessary preliminary investigations as a basis for renewed international discussions of these questions.
- (2) Recommends the National Councils to take all possible steps to encourage the official and unofficial consideration of these policies in their individual countries, and to secure the support of their Governments for effective international action.

LAWS COMMITTEE.

Nationality of Married Women.

Considering the request made by the XVI Assembly to the Council of the League of Nations, to continue to follow the development of the problem of Nationality both in the national and the international field with a view to further concerted international action in the future.

The International Council of Women resolves:—

- (1) To continue to work for an International Convention that shall embody the essential principle of equality between the sexes in respect of nationality, including the right of the spouses to independent nationality;
- (2) To proceed to make a special study of problems of nationality as they affect children;
- (3) To call upon the affiliated National Councils to co-operate with the I.C.W. Laws Committee on these lines, and in particular to examine the nationality laws of their own countries and endeavour to make legally secure the above-named principle in respect of nationality.

Montevideo Treaty.

The International Council of Women supports the principle laid down in the Equal Rights Treaty signed at Montevideo on December 26th, 1933, and decides to supply the affiliated National Councils with full information concerning the matter.

Women Police.

The International Council of Women notes with satisfaction the increasing interest throughout the world in police work as a profession for women, and the success attending the employment of women police in carrying out police duties.

In view of the importance of accurate information on methods of appointment, duties and conditions of service for women police whether with the status of police officers, or otherwise employed by the police, obtaining in the different countries where they are already functioning,

The International Council of Women urges the National Councils to assist the Standing Committee on Laws in the collec-

tion of statistics and information relating to the growth of the movement.

SUFFRAGE COMMITTEE.

Increase of women's efforts before Elections.

The International Council of Women urgently begs the National Councils in those countries where women have the vote to intensify their efforts before elections—either parliamentary or municipal—with a view to making women voters take a more active part in the elections in order to obtain the return of the most suitable candidates of either sex and that a greater number of women be elected.

In those countries where women have not yet got the vote, the International Council of Women begs National Councils to do all in their power to increase the interest of candidates in the question of women's franchise.

EQUAL MORAL STANDARD AND AGAINST TRAFFIC IN WOMEN COMMITTEE.

Draft International Convention for Suppressing the Exploitation of Prostitution.

The International Council of Women, after careful consideration of the Draft Convention proposed at the 15th Session of the Traffic in Women and Children Committee of the League of Nations, cordially agrees with its text. It strikes at every individual of either sex who derives profit from the prostitution of others.

The International Council of Women considers, in fact, that it is illogical to punish the souteneur without punishing the tenancier of the tolerated house, who lives wholly or in part on the immoral earnings of women, and accordingly urges upon the Traffic in Women Committee of the League of Nations to press for the punishment of all third party exploitation of prostitution and for the complete abolition of tolerated houses.

It further urges that the National Councils do all in their power in their respective countries to obtain not only the acceptance by their Governments of the resolutions adopted by the Traffic in Women Committee of the League of Nations, but also the actual enforcement of the recommendations contained in the resolutions.

Adherence of Young People to a high and Equal Moral Standard.

The International Council of Women calls upon its National Councils throughout the world to consider what steps can be taken to secure the loyal adherence of young people to a high and equal

moral standard and in particular to study how the reasons for good morals and good citizenship may best be presented to them.

It further urges that the National Councils do all in their power in their respective countries to obtain the abolition of State regulation (reglementation) of prostitutes, but also an equal moral standard for both sexes in all domains.

PUBLIC HEALTH COMMITTEE.

Nutrition.

The International Council of Women welcomes the initiative taken by the League of Nations for a radical investigation of the Nutrition Problem in the spirit of solidarity and international co-operation.

Considering that the provision for a rational nutrition for all peoples and races should be of great interest to women as specially concerned in the health and development of the young generation, the International Council of Women recommends to the National Councils to urge the collaboration of women in the proposed Expert Committees of the various countries as well as in the administrative and practical work in connection with this scheme.

International League against Rheumatism.

The International Council of Women requests the National Councils to get into touch with the National Committees set up in most countries in connection with the "International League against Rheumatism" and endeavour to promote their efforts by propaganda and other means.

EDUCATION COMMITTEE.

Study of Modern Languages.

In view of the rapidly increasing intercourse between nations and the desirability of promoting friendly relations National Councils of Women are urged to do all in their power to support the efforts of the Paris Institute for Intellectual Co-operation in its schemes for the exchange of teachers and scholars from one country to another and its fostering of correspondence between schools and to encourage the study of modern languages both by the usual methods of teaching and by the system of radio-teaching now provided in most countries and other modern methods.

Part-time Education after leaving School.

In view of Article 427, No. 6, of the Treaty of Versailles, 1919, namely:

"The abolition of child labour and the imposition of such limitations on the labour of young persons as shall permit the continuation of their education, and assure their proper physical development,"

And in view of the growing complexity of modern life, not only in economic organisation, but also in social and political environment,

The International Council of Women urges:—

- (1) The importance of the continuance of part-time education and training for all young persons after the close of the period of compulsory attendance of full-time school, the duration of which shall be regulated according to the length of compulsory education, their hours of employment being such as to permit attendance without undue prolongation of the working day.
- (2) The provision of day continuation schools by the State in co-operation with the commercial, industrial, agricultural and domestic interests concerned, due consideration being given to varying local needs.
- (3) The laying of an obligation on all unemployed young persons up to the age of 16 years to attend classes for a specific number of hours per week.

School Leaving Age.

The International Council urges that in those countries in which the school leaving age is 14 or under, National Councils shall press for it to be raised immediately by at least one year, without prejudice to its being raised still further in due course.

The International Council of Women also urges the National Councils to approach their respective Governments with a view to obtaining the longest possible prolongation of compulsory school attendance in order to assure a more complete education for young persons and of which one of the consequences would be a decrease of unemployment.

Better Education for World Understanding.

Considering the growing interdependence between the different parts of the world and the importance of international collaboration,

The International Council of Women recommends to the National Councils to promote a better education for world understanding

- (a) by fostering in the schools a spirit of good-will and understanding;
- (b) by reforming, where necessary, the textbooks and the teaching of such subjects as History, Geography and Civics.

Children's Libraries.

Considering the importance of children's libraries for the intellectual, moral and social development of children and young people, the International Council of Women urges its National Councils to study the functioning of these libraries and to contribute to their increase by interesting Public Authorities and private enterprise in this question.

It draws attention to the enquiry which is being made by the International Institute for Intellectual Co-operation on the Social Role of Public Libraries for Young People.

MIGRATION COMMITTEE.

Membership of the Conférence Permanente pour la Protection des Migrants.

That in view of the considerable advantages of membership in the "Conférence Permanente pour la Protection des Migrants" (Headquarters, Geneva), and the reduction of the annual affiliation fee to 30 Swiss Francs, the International Council of Women shall apply for re-affiliation with that body and shall send a representative to its meetings.

Training of Women Settlers.

Seeing that under certain of the Colonial Powers very good results are being obtained by the provision of special preparatory training for women about to settle in Colonies or other lands overseas,

The International Council of Women resolves:—

- (1) To make request to the International Labour Office to find some appropriate means of stimulating interest in this form of practical help to women settlers;
- (2) To urge upon the National Councils of Women in the countries concerned to work for the provision of such training as an integral part of their Governments' overseas policy, so that women may be prepared as fully as possible for their task in the new country.

TRADES AND PROFESSIONS COMMITTEE.

Restrictions on Women's Right to Work.

The International Council of Women requests the National Councils to consider the reaction which is taking place against the principle of equality of the sexes, and to take energetic action to safeguard rights already obtained and to secure that they shall be put into practice.

The International Council of Women is especially concerned at the increasing tendency of Governments, Local Authorities, employers and Trade Unions to restrict the right of women to

earn, that is to provide with self-respect for themselves and their dependents, and in particular it views with alarm the delegation of arbitrary powers of restriction to Ministers and Officials, thus placing women virtually "outside the law."

The International Council of Women therefore protests against all such restrictions and demands full equality of rights.

Equal Conditions of Work between Men and Women.

The International Council of Women invites the National Councils to combat the assumption that the economic dependency of the woman is necessary to the unity and stability of the family and again re-affirms the resolution adopted at the Council Meeting in Paris in 1934:

"The International Council of Women re-affirms the principle that a woman, married or unmarried, shall have the same right as a man to keep or obtain paid work and is resolved to promote equal conditions of work between men and women."

Weekly Rest of one and a half days.

The International Council of Women considers that the maximum working hours in Industry and Commerce should be so distributed as to allow at least one and a half days' weekly rest for all workers, and that these intervals should be continuous whenever possible (the so-called "English week-end").

Loan Funds and Training Schemes for Women over the age of 30.

The International Council of Women desires to call the attention of the National Councils to the increasing difficulty experienced by women over the age of thirty years in retaining or obtaining employment, and to urge the need of measures such as loan funds and training schemes to enable such women to qualify themselves for entry into new occupations.

CHILD WELFARE COMMITTEE.

Position of Children in the different Countries.

With a view to the unification of the legal codes affecting children the International Council of Women begs its affiliated National Councils to make an enquiry into divergencies that may exist between the legislation regarding children actually operating in their respective countries and the principles which form the basis of the Declaration of Geneva (Children's Charter).

Education and Technical Training of Crippled Children.

The International Council of Women urges its affiliated National Councils to give every encouragement in their respective countries to organised work for the education and technical

training of crippled children, in order to render them self-supporting. It also urges that day schools be provided at least in towns for physically deficient children.

Infant Mortality and Prenatal Care for Mothers.

The International Council of Women urges its affiliated National Councils, while recognising the value of pre-natal care not only to the mother but to the unborn child, to continue to promote, by every means in its power, the full use of pre-natal clinics in the organised work for mother and child. It further urges that each National Council undertake to report to the next Council Meeting date as to the increased use of ante-natal clinics and the rate of new-born and infant mortality in their respective countries in relation to previous years.

LETTERS COMMITTEE.

Professional Position of Women in Literary Careers.

The International Council of Women decides to put on its programme the study of the professional position of women in literary careers.

Youth Theatres.

The International Council of Women decides to interest itself in the development of Youth Theatres.

CINEMATOGRAPH AND BROADCASTING COMMITTEES.

Continuation of the Programmes of Work of the Committees.

The International Council of Women approves of the continuation by the Committees on Cinema and on Broadcasting of the programme of work of the former Committee which has started its activity in the domain of the Cinema in 1926 and in that of Broadcasting in 1931 and which has met with active collaboration from the National Councils of Women and with increasing interest for its efforts generally.

The International Council of Women wishes the new Committees to continue to act on the lines along which the former Committee has worked successfully since the beginning with special emphasis on education and peace.

CINEMATOGRAPH COMMITTEE.

Condemnation of Films with harmful tendencies.

The International Council of Women strongly condemns all films which tend to bring one country into contempt in the eyes of others or to exploit social evils and bad customs. Such films

are harmful to international relationship and impede the work of promoting international friendship and understanding.

Films of Artistic Merit and Social and Educational Value.

The International Council of Women requests its affiliated National Councils to foster an appreciation of films of artistic merit and pronounced social and educational value so that the production of such films shall be encouraged and also to do their utmost to disseminate information concerning them.

BROADCASTING COMMITTEE.

Women in the Administration of the Broadcasting and Programme Committees.

Considering that Broadcasting is a splendid means of information and instruction and has a great influence on the mentality of the public throughout the world the International Council of Women calls upon its National Councils to do all in their power in their respective countries to introduce or increase the influence of the women upon the Broadcasting, its administration and the drawing up of its programmes. The National Councils are recommended for this purpose to form a Committee of representatives of the leading women's organisations in their respective countries or to encourage those that already exist to co-operate with the Broadcasting Authority of the country in order

- (1) To place women as well as men in the administration of the Broadcasting and to let women take part in the drawing up of the programmes.
- (2) To have popular information and lectures on the woman's movement broadcasted in respective countries, thus giving men as well as women a better understanding of the well founded claims of women and the social work actually done by them.
- (3) To arrange an international exchange of broadcasts with a view to making use of the radio to promote a greater degree of understanding between various countries.
