ANNUAL REPORT, 1931.

In view of the prevailing need for economy, it is decided to make this Report as short as possible. In presenting the 27th Annual Report of the Women Public Health Officers' Association, it is a matter of congratulation that the increased activities of the Association have been maintained, in spite of the unfavourable financial conditions which have been general during the past year.

President and Vice-Presidents.

I am voicing the feelings of all the members when I express their warm appreciation of the influential support given to the Association by our President, the Lady Cynthia Colville, whose keen interest in our work has been most valuable.

The Association also desires to thank the Vice-Presidents for their helpful interest, especially in conferring with the Executive Committee on June 13th on questions of immediate policy.

Office Arrangements.

With a view to reducing expenditure it was decided to let one of the three rooms used as offices and to reduce the permanent staff. There is now a small room for the use of the Secretary, and a larger one for the clerical staff and for Committee meetings.

The Office Staff.

During the year various changes have been made in the staff which now consists of

> Miss Gray, 8 years' service. Miss Acott, 6 years' service. Miss Burraway, 3 months' service.

Annual General Meeting.

The Annual General Meeting was held on 13th February, 1931, at the Royal Sanitary Institute.

Dr. Seekings Friel was again good enough to take the Chair. It was owing to her able chairmanship that the business of this meeting was conducted without a hitch.

There were present at the meeting 68 members, both from London and the provinces—a very gratifying number. The Honorary Secretary, Miss M. Wilkie, presented the report; the balance sheet presented by the Honorary Treasurer, Miss Blanchard, was adopted. The meeting then proceeded to elect the President, Vice-Presidents, Officers and members of the Executive for 1932.

The voting was conducted by the very satisfactory method of card voting.

In addition to some alterations to Rules and Standing Orders, resolutions on the following matters were all passed :

- A. Standardisations of Conditions of Service.
- B. Immediate objects of the Association.
 - (a) Improved and Standardised conditions of Service.
 - (b) The extension of the Local Government and other officers' Superannuation Act 1922, with special provisions for women Public Health Officers.
- C. The extension of Maternity Services.
- D. Number of Health Visitors.
- E. Appointment of more Women Sanitary Inspectors.

Resolutions from the Centres:—

LANCASHIRE.

A resolution amending Standing Order No. 14. Executive Committee Meetings, was passed.

NORTHUMBERLAND AND DURHAM CENTRE.

"That a system of pooling the travelling expenses of the Centre representatives in attending Executive Committee meetings be adopted, the details of the scheme being referred to the Executive Committee."

The resolution was carried, but there was not a two-thirds majority in favour of the alteration of the rules which was necessary before a scheme could be adopted.

YORKSHIRE CENTRE.

"That this Association views with alarm the increasing employment of Student Health Visitors in substitution for fully-qualified persons, particularly in those places where the salaries offered are too low to attract suitable women."

CARRIED UNANIMOUSLY.

Special General Meeting.

A special general meeting was held at Harrogate on April 4th, at the close of the Annual Conference.

A resolution, altering the rules to enable the pooling scheme for travelling expenses of Centre representatives to Executive Committee meetings, to be put into operation, was carried by the necessary two-thirds majority. This was the only business.

Executive Committee.

The Executive Committee met 13 times during the year, 10 ordinary meetings and 3 special meetings. The average attendance was 20.8 and the duration of the meetings three hours. Last year the average attendance was 19.5. This increase is largely due to the pooling system, which came into effect this year to lighten the travelling expenses of those members in the provinces.

The July meeting this year was held in Cardiff, on Saturday, July 4th, and was followed by a meeting of the South Wales Centre in the Council Chamber.

Miss Sayle gave a lecture on the Educational Tour in the

Netherlands; this was followed by a Propaganda Meeting. Dr. Helena Jones, Assistant Medical Officer of Health, Rhondda, was in the Chair, and Miss Glascodine and Miss Gray spoke.

The Lord Mayor of Cardiff, Alderman R. G. Hill Snook, J.P., kindly invited the members to tea at the close of the afternoon meeting.

Growth of the Association.

The Association is steadily growing. Last year's report showed a membership of 937; this year we are proud of a membership of 1,060, an increase of 123.

The Association has 10 Centres:—Birmingham, Bristol, East Midlands, Kent, Lancashire, London, Northamptonshire, Northumberland and Durham, South Wales, and Yorkshire.

Appointments' Branch.

During 1931, 40 candidates for appointments have registered under the Appointments' Branch. Of these, seven registered for temporary appointments only, four for permanent appointments only, 28 for either temporary or permanent appointments and one for part-time work.

Eleven temporary appointments have been secured through the Appointments' Branch, two of these lasting for three months. During the latter part of the year very few temporary vacancies have been notified and it seems probable that this is largely because of the economies which Local Authorities are effecting.

Fourteen candidates on the register have themselves secured appointments during the year.

There are now 30 candidates on the register requiring appointments.

The Woman Health Officer.

Miss Brown was our honorary Editor for five years. It was with great regret that we received her resignation last year. The Association is deeply indebted to Miss Brown for all the time she has given to the WOMAN HEALTH OFFICER.

Miss Dean very kindly consented to carry on the good work. The Association is very grateful to her in maintaining the high standard of this magazine. The contents are varied and interesting.

The Library.

Librarian :-- Miss Morrell.

There are a number of interesting books in the library. The charge is one shilling per volume for four weeks, the postage to be paid by the borrower.

Sunlight Training.

Members are still availing themselves of the opportunity

offered by the Royal Northern Hospital, Holloway Road, for a course of Sunlight training.

The course consists of two sessions per week for six weeks and the fee is f_{I} . Is. od.

Seven members have attended this year and thoroughly enjoyed the course.

Winter School.

The Eleventh Winter School was held at Bedford College, from 29th December, 1931, to 8th January, 1932.

Seventy-seven students attended the Course, seventy-five entering for the whole Course, and two for one week only. This number is slightly more than half the number who attended the Tenth Winter School, which was one hundred and forty-five. In view of the economic situation in the autumn, and of the consequent pressure put upon Local Authorities to reduce expenditure, this reduction in numbers was less than had been feared.

Fifty-five Local Authorities gave facilities to members of their staffs to attend, compared with ninety-five in the previous year. Two voluntary committees also gave facilities, and there were three "free lance" students, one of whom had spent twenty years in Canada and the United States, and one of whom came from Australia.

The School was organised in seven groups, under the leadership of Miss Neall, Miss Heap, Miss Ventris, Miss Grout Tong, Miss Morrell, Miss Heath and Miss Rodgers respectively. The success of the School was undoubtedly largely due to their loyal and publicspirited co-operation.

Apart from the occurrence of three cases of illness during the second week—one serious and two slight—there were no untoward happenings, and the School appeared to be an exceptionally happy one. Perhaps the smaller number of students made it easier to establish personal contacts.

With one exception, all the lectures were given as arranged. The percentage of absences among students (apart from those due to illness or recalled to duty) was 1.5; there were no absences from observation visits among the physically fit.

The thanks of the Association are again due to the Principal and Council of Bedford College for allowing the Winter School to be held under ideal conditions, to the Bursar and her staff, and to the Matron for her professional care of the two resident students who were ill.

The students were again entertained socially on two occasions once by our London Centre and once by Dr. Octavia Lewin, a Vice-President of the Association.

Correspondence Course.

Students taking the Fourth Correspondence Course varied in numbers from thirty to seventeen. Six students obtained the Health Visitor's Certificate in 1931 after taking the whole or part of the Fourth Course, in addition to three others who had taken previous courses. This brings the total number of our successful candidates up to thirty-four.

Joint Meeting of Vice-Presidents and Members of the Executive Committee.

The Executive Committee invited the Vice-Presidents to confer with them as to further steps which might be taken to secure a greater measure of standardisation of salaries and conditions of service.

This joint meeting was held at the Royal Sanitary Institute on June 19th, with the President, the Lady Cynthia Colville, in the Chair, and seven Vice-Presidents and thirty members of the Executive Committee present.

Miss Sayle, on behalf of the Executive Committee, gave an outline of the steps which had already been taken. After a full discussion, and much helpful advice from the Vice-Presidents, it was decided to concentrate on trying to raise the level of the lowest salaries in the first place.

Conference with Representatives of Institutions recognised by the Minister of Health for the Training of Health Visitors.

This conference was convened by the Association, and met at the Royal Sanitary Institute on 20th November, under the chairmanship of Miss Philippa Strachey, of the London and National Society for Women's Service.

Discussion took place on the following questions, relating to the training, examination and work of Health Visitors:

- 1. Is the requirement of a minimum educational standard desirable?
- Are any modifications in the examination desirable? Letters from Dr. Ralph Picken, Welsh National School of Medicine, and from Miss Nora Milnes, University of Edinburgh, were read and discussed.
- 3. Is the duty to refrain from applying for appointments at inadequate salaries sufficiently realised by qualified Health Visitors?
- 4. Is there a danger that the supply of Health Visitors will exceed the demand?

Resolutions embodying the views of the Conference on each of these questions were passed, in addition to one recommending the formation of a Joint Consultative Committee of Training Institutions approved by the Minister of Health for the Training of Health Visitors, and of organisations of Health Visitors. As a result, a Joint Consultative Committee has been formed and will carry on the work of the Conference.

HARROGATE CONFERENCE.

Problems affecting Health Visitors and their work were discussed at length at the first Conference of Women Public Health Officers, which was held at the Harrogate Grammar School, on Saturday, April 4th, 1931, under the chairmanship of Lady Lawson-Tancred, J.P.

The 87 delegates were welcomed by The Mayor, Alderman W. W. Stott, who said that, although at one time he was not in favour of appointing Health Visitors, he would now like to pay tribute to the valuable work they were doing.

At the morning session, being the Public Session, at which Lady Lawson Tancred kindly presided, the programme was:

- 1. Methods of Health Education in connection with Ante-Natal Care.
- 2. The Health Visitor and the Child from I to 5 years.
- 3. The Co-ordination of Maternity and Child Welfare and School Medical Services.
- 4. Home Helps.

The Afternoon Session was a Private Session for delegates only. Miss H. S. Cooper Hodgson, M.B.E., Superintendent Health Visitor, Durham County Council, presided.

The subjects discussed were:

- 1. The present position with regard to salaries, holidays and other conditions of service of the woman Public Health Officer.
- 2. The necessity of Post-Certificate leave for women Public Health Officers.
- 3. The position of Health Visitors in relation to the suggestion contained in memorandum 156 of the Ministry of Health as to the use of Ante-Natal Clinics by private practitioners.
- 4. The position of women Public Health Officers who are required to undertake duties which are contrary to their convictions, e.g., to assist at Birth Control Clinics.

The Conference closed with a reception and tea, kindly given by the Mayor and Mayoress, which was much appreciated.

The Association would like to express its gratitude to Lady Lawson Tancred, The Mayor and Mayoress of Harrogate, Alderman Webster, Chairman of the Public Health Committee, Dr. Mair, Medical Officer of Health, Dr. Laura Veale, Assistant Medical Officer of Health, and all those who contributed to the success of the Conference, and the various social functions arranged in connection with it.

All the delegates felt that the Conference had been of immense value to them, and a resolution calling for a further conference next year was carried unanimously.

EDUCATIONAL TOUR, 1931: THE NETHERLANDS.

22nd May-7th June, 1931.

Twenty-eight members of the Association took part in this tour, accompanied throughout by Miss Sayle, and in Holland by Miss Schippers, a Dutch lady.

The journey in both directions was made by Gravesend and Rotterdam. The programme of visits and the introductions everywhere were arranged by Dr. Josephus Jitta, Chief Medical Officer to the Netherlands Government, and the greatest kindness was received from Regional and District Medical Officers. From Rotterdam, having breakfasted in a roof restaurant, the party travelled to The Hague, where an afternoon reception was given by Dr. Jitta. The next two days—Whit Sunday and Whit Monday—were spent mainly in sight-seeing, but on Tuesday, 26th, Leiden University Hospital was visited, and the rural health work of the Green Cross Society, as exemplified in Wassenaar and elsewhere, investigated.

The following day was the first of five spent in Amsterdam, where the Chief Medical Officer of Health not only received the members of the party and addressed them on the work of his Department (which provides a complete municipal health service, preventive, institutional and domiciliary), but accompanied them personally for a day and a half. Two new municipal health centres, in which maternity and child welfare work, school medical inspection (as well as treatment), the diagnosis of tuberculosis and/or the treatment of venereal diseases take place under one roof, were visited in Amsterdam, as well as a day convalescent centre for adults. In this, patients recovering after operations or serious illness rest on beds in open-air shelters, and receive coffee and milk, bringing their own sandwiches and return home for their principal meal in the evening.

In Amsterdam and in the other towns visited—Eindhoven, Maastricht, Horn and Arnhem—hundreds of streets of new houses were to be seen on all hands, many estates being managed by trained women managers. - On these new estates were situated most of the day-nurseries and nursery schools visited.

Outside Amsterdam, the health services are financed by voluntary bodies, subsidised by the central and/or local governing bodies, district nurses being responsible, under supervision, for most of the Health and Tuberculosis Visiting.

A salient feature which contrasts strongly with the practice in England was the sectarian basis underlying the organisation of the work, each Infant Welfare Centre, for instance, outside Amsterdam, being maintained either by a Protestant or Roman Catholic Green or White Cross Society. Much of the financial support of the work of these Societies comes from the regular small contributions of the wage-earners who benefit from the nursing and other services of the Green Cross District Nurse.

The tour was both interesting and enjoyable; a fuller account of it is given in the booklet published by the Association at one shilling, entitled "Public Health and Social Work in the Netherlands." This is mainly compiled from the reports made to the Health Committee of the League of Nations by the three members of the Association nominated by that Committee:— Miss H. Knight, Chief Health Visitor, Liverpool; Miss W. Smart, Sanitary Inspector and Health Visitor, Deptford, and Miss N. Brocklehurst, Tuberculosis Health Visitor, Lewisham.

VIGILANCE WORK.

Routine Work.

All advertisements for Health Visitors, School Nurses, Tuberculosis Visitors, etc., are scrutinised, and letters of protest sent in all cases where a salary of less than f_{200} per annum is offered.

Letters are also sent as a routine measure in cases where an age limit is stated in advertisements.

Although during the early part of the year salaries continued to shew some improvement, Circular 1222 issued to Local Authorities by the Minister of Health in September has resulted in reductions of salary in a number of cases. These reductions have affected the whole staff—not women Public Health Officers only. On the whole, the reductions have been small, and are of a temporary nature. In many cases provision has also been made for revision in the event of a rise in the cost of living. The Executive Committee considered the position shortly after Circular 1222 was issued, and defined its policy. This was made known to members and an offer made to approach the Local Authority in any case where the reduction proposed was excessive or where the other conditions differed from those outlined in the Association's policy.

Action on Behalf of Members.

Local Authorities have been approached by letter or deputation at the request of members in 20 cases.

In two cases increases of salary were granted as a result of this action.

Two deputations were received by Local Authorities. In one case the deputation succeeded in preventing a reduction of salary, the Health Visitors being the only officers of the Local Authority excluded from the reductions. In the other case a joint deputation from this Association and the National Association of Local Government Officers was not successful.

In one case where an all-round reduction of $7\frac{1}{2}$ % was enforced by the Local Authority an effort was made to secure the re-grading of the health visiting and school nursing staffs, as their salaries compared unfavourably with those of other officers of the Local Authority. Although this application was supported by three Members of Parliament, the Council has refused to take any action.

The Association continues to watch new appointments of Health Visitors, and any irregularities in qualifications are brought to the notice of the Ministry of Health. Four cases have been reported during the year.

A paragraph urging members to send information as to any appointments which appeared to be irregular was inserted in the December "WOMAN HEALTH OFFICER."

Routine Office Work.

During the year 5,374 communications were received in the office.

REPORTS OF SUB-COMMITTEES.

Annual Dinner Sub-Committee.

Chairman: Miss D. Walding. Secretary: Miss H. M. Gray.

Three meetings have been held, the first two to complete the arrangements for the Annual Dinner on February 14th, 1931, and the third to consider the question of the Annual Dinner for 1932.

It was decided that it would not be possible to hold the Annual Dinner without incurring a loss to the Association and it was finally decided, with great regret, to abandon the Annual Dinner for 1932.

Conference 1931 Sub-Committee.

Chairman: Miss A. Sayle.

Secretary: Miss H. M. Gray.

Five meetings were held during the early part of the year to complete the arrangements for the Harrogate Conference, on Saturday, April 4th, 1931.

A report of the Conference itself is included in the Annual Report.

Conference 1932 Sub-Committee.

Chairman: Miss M. Brown. Secretary: Miss H. M. Gray.

This Sub-Committee was appointed by the Executive Committee on September 2nd to make arrangements for the 1932 Conference. The Committee consists of representatives of each of the Centres and Groups. Two meetings were held prior to December 31st. The Committee recommended that the Second Annual Conference of Women Public Health Officers should be held at Buxton on Whit-Monday, May 16th, 1932.

Co-operation Sub-Committee.

Chairman—Miss M. Brown. Honorary Secretary—Miss M. Campbell. This Committee comprises 12 members and three officers.

We much regret that there were three resignations during the year.

Mrs. Durrie Mulford. Mrs. Watkin. Miss Martin.

. The Committee deals with the correspondence from outside organisations and submits to the Executive Committee recommendations connected therewith. It also submits the names of representatives and delegates for Conferences, Deputations, etc. The Committee has received about 40 reports from the representatives who have attended Committee meetings, etc. The most important of these reports have appeared in the "WOMAN HEALTH OFFICER.'' One new subject which involved much discussion was a proposed Insurance Scheme for members of the Association. The details were examined carefully, but the Executive Committee decided to postpone this proposal for a year.

The names of the various organisations with which the Committee has co-operated seem to form themselves into a long list; to save space only a few representative organisations are given.

This Sub-Committee met once, on 28th July, 1931, and made provisional arrangements for the Fifth Correspondence Course.

Correspondence Course Tutorial Committee.

This Committee, which acts as an expert advisory committee to the Executive Committee of the Association, met once, on 14th July, 1931, and approved the syllabus and time-table for the Fifth Correspondence Course. Chairman: Miss A. Sayle. Honorary Editor: Miss M. Dean. Honorary Secretary: Miss N. Brocklehurst.

The meetings were held on the second Wednesday in each month, at 6-15 p.m., when the WOMAN HEALTH OFFICER was prepared. Paragraphs and articles were also prepared for publication in journals. Advertisements for the WOMAN HEALTH OFFICER were obtained from suitable firms.

At the last meeting of the Committee a scheme for securing advertisements was considered and submitted to the Executive Committee for approval.

Educational Tour, 1931, Sub-Committee.

Chairman: Mrs. J. Kent Parsons.

Honorary Organiser and Secretary: Miss Sayle.

This Sub-Committee met four times during 1931, on 31st January, 27th March, 29th April and 17th June. It was responsible for all the arrangements made by the Association for the Educational Tour in the Netherlands, which began on Friday, May 22nd, and ended on Sunday, June 7th.

Educational Tour, 1931, Report Sub-Committee.

Chairman: Miss Smart.

Honorary Organiser and Secretary: Miss A. Sayle.

This sub-committee met three times, on 23rd July, 13th August and 19th August, and was responsible for the production of the booklet "Public Health and Social Welfare in the Netherlands," written by Miss M. C. Lewis.

Educational Tour, 1932, Sub-Committee.

Chairman (during 1931): Miss A. Sayle. Secretary (during 1931): Miss H. M. Grav.

This Sub-Committee met twice in 1931, on 17th October and 12th December; it recommended that an Educational Tour in Great Britain be arranged, leaving Buxton on Tuesday, May 17th, visiting Manchester, Liverpool, Glasgow, Edinburgh, either Leeds or Sheffield, and Birmingham, finishing in Birmingham on Wednesday, May 25th.

Finance Sub-Committee.

Chairman: Miss D. Walding.

Secretary: Miss H. M. Gray.

Five ordinary and two special meetings have been held.

The Committee has been mainly concerned with regulating the finances of the Association.

At a Special Meeting in January recommendations were made to the Executive Committee, with a view to lightening the duties of the Secretary. These were adopted. At the Executive Committee meeting on April 10th the following terms of reference for the Finance Sub-Committee were adopted:

- 1. To prepare an annual budget for consideration by the Executive Committee at its September meeting, shewing the estimated income and expenditure of the Association for the following year, 1st January—31st December.
- . To consider and submit recommendations to the Executive Committee on the following matters:
 - (a) All suggested items of expenditure exceeding £1. os. od. not specifically included in the budget.
 - (b) The use to be made of any surplus exceeding £5. os. od. arising from any special activity of the Association when such a surplus has not been specifically included in the budget.
 - (c) The premises to be occupied by the Association.
 - (d) A scheme defining the conditions of service, including duties, salaries, insurance, pensions, sick leave, hours (including overtime) and holidays of all members of the staff.
 - (e) Any proposed changes, additions or reductions in the staff.
 - (f) Any changes in salaries or other conditions of service of the staff.

As directed in these terms of reference, a budget of estimated income and expenditure for 1932 was prepared, and was adopted by the Executive Committee on December 2nd.

Also, in accordance with the terms of reference, the Finance Committee has made certain recommendations to the Executive Committee relating to the conditions of service of the staff.

Joint Sub-Committee on Co-operation with Training Institutions.

Chairman: Miss A. Sayle.

As a result of a recommendation from the Standardisation of Conditions of Service Sub-Committee, this Committee, together with the Co-operation and Propaganda Sub-Committees, appointed representatives to serve on a Joint Sub-Committee, to deal with the question of co-operation with the Training Institutions on the lines suggested at the Conference of Vice-Presidents on June 19th. Three meetings of this Joint Sub-Committee were held and recommendations made to the Executive Committee on the following matters:

- (a) Methods of interesting student Health Visitors in the work of the Association.
- (b) The possibility of urging Health Visitors to refrain from accepting appointments at a salary of less than ± 200 per annum.
- (c) Modifications in the syllabus and examination for the Health Visitors' Certificate.

A Conference of representatives of Institutions recognised by the Minister of Health for the training of Health Visitors was arranged by the Joint Sub-Committee and held at the Royal Sanitary Institute on Friday, November 20th.

A report of the Conference itself is included in the Annual Report.

Propaganda Sub-Committee.

Chairman: Miss M. Wilkie.

Honorary Secretary: Miss C. G. Ware.

There was an average attendance of six at each of the 12 meetings held.

In accordance with the instructions of the Executive Committee, the policy of the Committee has been to concentrate on the formation of Centres and the reduction of groups. Four new Centres have been formed during the year.

Six Propaganda Meetings were held:-

- At Canterbury on May 30th, when Kent Centre was formed.
- At Bristol on July 3rd, when Bristol Centre was formed.
- At Cardiff on July 4th, in connection with the Executive Committee Meeting.
- At Northampton on November 30th, when Northamptonshire Centre was formed.

At Bedford College on January 5th, for the Winter School students.

At Plymouth on January 28th, when the Devon and Cornwall Centre was formed.

Miss Sayle and Miss Gray undertook a Propaganda Tour from June 27th—July 4th, Salisbury, Yeovil, Taunton, Exeter, Torquay, Paignton, Brixham, Plymouth, Barnstaple, Bristol and Cardiff being visited.

Twenty-eight Health Visitors were interviewed either singly or in small groups and larger meetings addressed at Plymouth, Bristol and Cardiff.

About 120 Health Visitors were thus brought into personal contact with the Association's representatives and informed of its activities.

Three "At Homes" to members and friends on the outskirts of London were held:—

- At the Chestnuts, Tottenham, on February 28th, for North and North-East London members.
- At Eltham Health Centre for South-East London members.
- At Kensington, for West London members.

Interviews with staffs of London Boroughs.

Miss Gray interviewed the staffs at Greenwich, Bermondsey, Camberwell, Hendon and Enfield.

The following recommendations have been made to the Executive Committee:—

1. That the amount of the Student Associate's subscription should be reduced.

2. That Sub-Committees of the Executive be urged, when co-opting members, to include as far as possible new and isolated members.

As a matter of propaganda interest :---

The total number of new members up to December, 1931, was 180. Allowing for 65 resignations, this gives an increase in membership of 115 up to December 31st.

Standardisation of Conditions of Service Sub-Committee.

Chairman: Miss A. Sayle.

Secretary: Miss H. M. Gray.

Thirteen meetings of this Sub-Committee have been held. The work of this Sub-Committee has fallen into six sections:—

- 1. Considering suitable scales of salary for Superintendent and Assistant Superintendent Health Visitors.
- 2. Preparing a Memorandum of Evidence to be submitted to the Departmental Committee on the Training, Qualifications, Recruitment and Promotion of Local Government Officers.

This Memorandum has been forwarded to the Departmental Committee and verbal evidence is to be given when meetings of this Committee are resumed.

3. Endeavouring to secure improvements in salaries below £200 per annum and holidays of less than 14 days.

It was decided to concentrate on cases in which women Public Health Officers were receiving salaries of f_{200} or less and holidays of 14 days or less.

All Local Authorities paying salaries below f_{200} have received letters asking whether any alteration has been made in their scale of salary since the Summary of Information from Local Authorities was published by the Ministry of Health. As a result of this it was ascertained that 76 of these Local Authorities had increased their scales of salary since 1929, but there were still 167 Local Authorities paying salaries of less than f_{200} to women Public Health Officers.

Letters were also sent to Local Authorities giving less than 14 days' holiday to ascertain whether there had been any alteration in the holidays given to their staff.

4. Collecting information as to mileage allowances made by Local Authorities to women Public Health Officers.

A questionnaire relating to the expense of running a car for Health Visiting work was drafted and sent to members in County areas who were using cars for their work. The information received was tabulated. Action on this matter has been deferred on account of the economic situation. 5. General improvement and standardisation of conditions of service.

As a result of a recommendation to the Executive Committee, a Conference of Vice-Presidents and members of the Executive Committee was held at the Royal Sanitary Institute on June 19th. The Conference considered it inadvisable to proceed with the general question of standardisation and advised a concentrated effort to improve the conditions of the worst-paid members of the profession.

6. Policy with regard to salary reductions.

The policy of the Association with regard to reductions of salary proposed by Local Authorities on account of the economic situation was drafted for the approval of the Executive Committee.

It was also decided to obtain information from other professional organisations affected by salary reductions as to steps which they had taken to safeguard the amount of superannuation in the case of officers retiring who would be affected by these reductions.

Standing Orders Sub-Committee.

Chairman: Miss A. Sayle. Secretary: Miss H. M. Gray.

One meeting was held to prepare the final agenda for the Annual General Meeting on Friday, February 13th, 1931.

Winter School Sub-Committee.

Chairman: Miss A. Savle.

Secretary: Miss H. M. Gray.

Three meetings were held and all the arrangements made for the Eleventh Winter School.

A report of the Winter School itself is included in the Honorary Secretary's Report.

REPORTS OF CENTRES.

Birmingham.

During the year General Meetings have been called on seven occasions, and the Executive Committee has met on six occasions.

Lectures have been arranged in connection with the Birmingham Infant Welfare Association.

Representatives have been sent to meetings of the Executive Committee in London whenever possible, and when this could not be done arrangements have been made with Miss McCarthy and Miss Barber, who have acted as Proxies for us.

Miss Hopson, of Birmingham, represented the Centre at the Association Conference at Harrogate, and Miss Twist, of West Bromwich, represented us at the Executive Committee meeting at Cardiff in July. The Trades Union Congress, which was held at Bristol in September, was attended by Miss Vineall, of Evesham.

An appeal from London for funds was put before the November meeting, and at the decision of the members, a donation of $\pounds 55$. od was sent to Headquarters.

It was not possible this year to arrange a Summer Picnic, but a very successful Theatre Party was arranged, in which 31 members met and spent a very happy time together.

There have been three resignations from the Association, but this has been counterbalanced by the election of twelve new members, three of whom are Student Associates, from the last group of the Birmingham students.

The Birmingham Branch of the Association is still going ahead with a membership of 73.
