INCORPORATED HOSTELS.

AIMS.

The Royal Free Hostels are for the care of girls and women suffering from venereal diseases in an infective stage.

The patients are drawn chiefly from the Royal Free Hospital V.D. Clinic, and are selected by the Medical Officer to the Clinic; but cases from any part of London or the country may be received. (See Rules for admission.)

Most of the patients admitted to the Hostel are treated as out-patients at the Royal Free Hospital.

The aims of the Committee are:—

- 1. Care and medical treatment of women suffering from venereal disease.
 - (a) Non-pregnant cases. Admitted to Regent's Park Road Hostel.
 - (b) Pregnant cases. Admitted to Highbury Quadrant Hostel.
 - (c) Mothers and babies up to six months old. Admitted to Highbury Quadrant Hostel.
- 2. After-care of these patients when discharged from the Hostels, and medical supervision of the

The work is supplementary to that of the Hospital outpatients' clinic, as at present insufficient provision is made in general hospitals for the isolation and after-care of these infectious cases. The special daily treatment given at the Hostels, together with rest and good food, help to make hospital treatment more effective, and to shorten the course of the disease.

The greater number of those admitted are wage-earners; such as waitresses, domestic servants, factory workers, or clerks, who are, for the time being, unfitted to earn their living. They would not willingly enter a large institution, nor are they so ill as to need a bed in hospital. Conditions often make it impossible for the girl to stay at home, though the parents willingly contribute towards her expenses at a hostel. Whatever the circumstances, these girls all need help to start them on the road to recovery.

The Hostels are conducted on undenominational lines, but during their stay, every effort is made to help patients to moral. as well as to physical recovery, and to train them in the care of their children.

After-care is an integral part of the scheme, and great importance is attached to keeping in touch with patients over a considerable period of time. The keeping of records of the health and physical development of the children for some years is to form an addition to the medical work carried on whilst they are inmates of the Hostel.

REGULATIONS AND CONDITIONS FOR ADMISSION.

- 1. Cases are admitted by the Medical Officer of the Royal Free Hospital Venereal Diseases Clinic, who attends at the Hospital (Out-patients) daily from 9.30 a.m.—7.30 p.m., and on Saturdays from 9.30 a.m.—12.30 p.m.
- 2. Only patients suffering from Venereal Disease in an infectious stage are eligible for admission.
- 3. Medical practitioners who are desirous of securing the admission of a patient to the Hostels are invited to refer the case to the Hospital Clinic with a note to the Medical Officer.
- 4. Patients from other hospital Clinics in the district are admitted and arrangements made for them to continue under the care of their own Medical Officer. Applications for vacancies should be made to the Almoner, Royal Free Hospital, Gray's Inn Road, W.C. 1.
- 5. The most suitable cases for admission to the Hostels are young girls, Married women, professional prostitutes, or remand cases are not usually suitable.
- 6. Patients are kept in the Hostels, if possible, until their condition becomes not-infectious, and suitable arrangements have been made for their return to work, or to their families.
- 7. No patient is refused on grounds of inability to pay. but the circumstances of patients are enquired into by the Almoner of the Royal Free Hospital. They are required to contribute towards the cost of their maintenance if in a position to do so.

REPORT

for year ended March 31st, 1926.

The past twelve months have been spent in consolidating the position created by the new activities reported last year.

Subscribers will remember the extent of the developments. The Committee had previously been responsible for one Hostel with eleven beds and an annual expenditure of about £1,100, but at the end of 1924 they became responsible for two hostels, with a total of 34 beds and 12 cots, and an annual expenditure of about £3,500.

When the last Report was made the Royal Free Hostel (now known as the Regent's Park Hostel) had only recently been moved to a larger house and the Highbury Quadrant Hostel had

only just been taken over.

The present Report deals therefore for the first time with the result of twelve months' work under the new conditions. The Committee are of opinion that this Report shows satisfactory progress both as regards general and internal administration.

The chief points may be summarised as follows: (1) the incorporation of the Hostels as an Association has been completed; (2) the freehold of the house at Highbury Quadrant has been purchased (the details of this are to be found on page 20); (3) the Hostels have been fully occupied by patients and the staff at both homes have carried on the work with an enthusiasm that overcame all difficulties.

The Regent's Park Hostel Income and Expenditure Account shows a deficit for the first time in seven years, due to the higher cost of maintenance and an increase in "Patient Days"

of twenty-five per cent.

Highbury Quadrant Hostel was given a flying start by the donations collected towards the initial outlay and therefore shows a good credit balance at the end of the first year. Such generous contributions cannot be counted upon in future, and the ordinary income is less than the estimated expenditure for the coming year.

Incorporation as an Association. The incorporation under the Board of Trade as an Association "not for profit" was completed early in 1926. It was not found possible to register the name as Royal Free Hostels, so

somewhat reluctantly the title "Incorporated Hostels for Women and Girls associated with the Royal Free Hospital" was adopted. The Committee are deeply indebted to the Vice-chairman for putting the matter through at great expenditure of time and trouble. The Memorandum and Articles of Association were drawn up by him, and were considered by a special sub-Committee, on which served Lord Ancaster, Mr. d'Avigdor Goldsmid and Mr. Henriques, to whom special thanks are due.

pended for the information of subscribers. It contains an enumeration of all
the present objects of the Association, and is drawn up so as
to cover any future extension of the work. The Committee
were advised that they should obtain very wide powers under
the Incorporation in order that the work might suffer no hindrances in its development. It should be well understood that
the Committee are fully occupied with existing responsibilities,
and do not look forward to further extensions at present. They
think, however, that subscribers will be interested to learn of
the powers that have been obtained.

Administration. The two Executive Committees appointed to administer Regent's Park and Highbury Hostels have been in close touch with one another, and the Hostels are working on parallel lines. Of necessity the conditions in the two homes are somewhat different. At Regent's Park Hostel (15 beds) for non-pregnant cases, the patients stay a comparatively short time and are often very young. At Highbury Hostel (19 beds and 12 cots) the patients are admitted about three or four months before confinement and stay till their infants are six months old.

After-Care. The problems connected with these two sets of girls are very dissimilar. When a girl leaves Regent's Park Hostel she may return to her original work, or be placed in a Training Home or new work may be found for her. But the mother from Highbury Hostel with her baby to look after is in a different situation. Though she has a greater sense of responsibility and will probably prove to be a better member of society, her economic position is precarious and high wages have to be obtained for her, if she is to support her child. It is usually necessary to place the baby with a fostermother, where a payment of at least 12s. 6d. a week is expected; a few well-disposed people are ready to employ mothers, and house the babies, but this is exceptional.

The Executive Committee of both homes are in close co-

operation with many voluntary organisations, in London and elsewhere. But in order that the community at large should gain the full benefit of the social work done by these organisations, there is still urgent need throughout the country for (a) Hostels for working girls; (b) Hostels for mothers employed by day, where babies could be cared for.

Appeal for Voluntary Help. The Committee would welcome voluntary help for both Hostels. The worker who counts most, is the individual with enthusiasm and perseverance, and sufficient leisure to visit the Hostel regularly, or undertake secretarial duties. More especially is help needed for any form of teaching, singing, dancing, games, etc. The teacher can get to know a girl more readily in this manner, and may be able to initiate a friendship with her, which would prove greatly to the ultimate benefit of the girl.

ABSTRACT OF THE MEMORANDUM OF ASSOCIATION OF THE INCORPORATED HOSTELS ASSOCIATED WITH THE ROYAL FREE HOSPITAL.

Note.—The paragraphs and words omitted are chiefly phrases or statements in accordance with legal requirements or provision for contingencies unlikely to arise. A copy of the complete document can be lent to any subscriber wishing to read it.

The objects of the Association are:—

(a) To assist, aid and provide treatment for women infected with venereal disease and their children including pre-natal and post-natal treatment and all necessary after-treatment.

- (b) To establish, conduct and carry on the after-care of such women and children including the provision of board and accommodation and the organisation of education and training.
 - (c) To organise preventive and rescue work generally.
- (d) To establish and carry on all treatments for the prevention and cure of venereal disease and to render aid assistance and encouragement to medical research work incidental and conducive to the attainment of the above objects and to instruct and train persons therein.
- (e) To establish, conduct and carry on such classes, lectures or other educational activities as may be likely to promote any of the objects of the Association.
- (f) to provide such legal assistance as may be likely to promote any of the objects of the Association including legal assistance in affiliation cases.
- (g) —— to acquire any patents —— conferring any right to use any —— invention —— for —— the purposes of the Association ——.
- (h) To take over as a going concern the institutions for the treatment of venereal disease now carried on at The Regent's Park Hostel and The Highbury Quadrant Hostel under the style of the Royal Free Hostels and all assets and liabilities in connection therewith —.
- (i) to purchase lease or acquire any property (etc.) necessary for the furtherance of its objects and in particular the said Hostels —.
- (j) —— to hold any gift of property —— for —— the objects of the Association.
 - (1) To borrow and raise money —.
 - (m) To invest any moneys of the Association —.
- (n) To promote or amalgamate with or manage any association or society whose objects are similar to the objects of the Association.
- (p) The doing of all such other lawful things as are incidental or conducive to the attainment of the above objects.

REGENT'S PARK HOSTEL.

Details of the Year's Work.

On April 1st, 1925, there were 13 patients in residence at the Hostel. During the year 61 have been admitted, of whom 8 were in residence on March 31st, 1926, making a total of 74 patients for the year. The total "patient days" is 4,188, an increase of 885 over last year's total. The average length of stay is 57 days. In addition 8 old girls have spent a few days at the Hostel, either for rest, or whilst looking for employment.

Premises. The house, the lease of which was purchased in the autumn of 1924, has proved itself convenient and well adapted for its purpose. The situation with is view over Primrose Hill is a constant source of gratification to staff and patients alike.

Minor improvements have been carried out; a water supply has been carried to the treatment room, and overhanging trees in the garden cut back.

Staff. No change in the staff has taken place this year. As always, their work has been admirable. The Committee are aware that without their untiring patience and devotion it would be impossible to carry out the aims of the Hostel.

Patients. An unexpected phase of this year's work has been the extreme youth of a large number of the patients. At one period there were six girls under 16 in residence. This was partly, but not entirely, due to a large influx of patients from a Training Home, and entailed alterations in the internal administration and more supervision. It is extremely difficult to place such young girls suitably on discharge. Some have been drafted to other training homes, and some have returned to their families. The failure in morals of a very young girl can usually be traced to bad home influence. The return to her home in such a case is not a satisfactory plan, and every endeavour has been made to avoid it, but often no other course has been open.

Education and Recreation.Much is done by the staff of the hostel towards the general training and education of the patients. It is felt that outside help in this direction is also most valuable, and the Committee are very grateful to Miss Lloyd, an officer of the Girl Guides, who continues to give one afternoon a week to the teaching of singing,

country dancing and games. Other Guide Officers have been generous in giving evening classes for signalling, geography, or First Aid, and Miss Jones has again kindly taken the party for walks. It may be noted here, that at recent conferences initiated by the Central Council for Rescue and Preventive work, superintendents and workers were agreed that such educational efforts were most valuable in giving the girls a new outlook and fresh interests to replace those associated with their previous mode of life; further that these efforts are often more effective if carried out by visiting instructors.

After-Care. The number of patients who have passed through the Hostel since June, 1919, is now 335. It is naturally impossible to keep in touch with all, and indeed in some cases not desirable. It will be seen from the table given on page — that 126 are now classified under "No recent news," 22 of these are not likely to be heard of again, many of them having left England.

It is gratifying to note that of the 209 of whom fairly recent news can be obtained, 115 may be classed as satisfactory. This number added to the 27 "married" who, it is hoped, may be considered satisfactory, gives an average of about 68 per cent.

The figures given below indicate the amount of work entailed by After-care during the year, and for the information of subscribers it should be explained that practically the whole of the burden falls on the sister-in-charge. She frequently sees two or three of the old girls a day who expect to be advised on every conceivable subject.

Medical Report.

From Mrs. Margaret Rorke, M.B., Ch.B., Medical Officer in Charge of the Female V.D. Clinic, Royal Free Hospital.

"The Hostel has been full practically continuously, the patients have been exceptionally interesting and much more "helpable" and responsive, speaking broadly, than at some other times. A considerable number of cases from a Home for Girls have been dealt with. Several of these patients had almost certainly been accidently infected from other inmates suffering from gonorrhoea, in whom the disease had either never been

detected or had been incompletely treated. The need for medical inspection and careful supervision of sanitary and hygienic details had not been fully recognised. The arrangements in this Home have now, I understand, been completely revised, and under the new conditions any recurrence of accidental infection would be impossible.

"Several cases of congenital Syphilis with strongly positive reactions to the Wasserman blood test were also found among these girls and their

treatment undertaken.

"The other patients admitted to the Hostel from the Royal Free Hospital or other V.D. Clinics came from the same classes as usual. In one or two cases operation was required before the condition could be completely cleared up. Our "recovery time" is on the whole shorter than it used to be, although the average length of stay shown in the statistics this year, is a little longer, owing to a few very long cases. The shorter recovery time is, in part, due to better treatment, but is also, I believe to a great extent because the girls are happier, and in better surroundings in the new Hostel.

The work has periods of great discouragement for the Medical Officers and Hostel Staff alike, both from the medical and moral points of view; but encouraging features counterbalance those which discourage,

and so we go on from day to day."

MARGARET RORKE.

Finance. The income from subscriptions and donations during the financial year has been slightly increased in comparison with the previous year, but the advantage gained has not met sufficiently the increased expenditure necessary for maintenance of a larger establishment. The Committee were therefore not in a position at the 31st March to reserve the amount of £80 towards redemption of mortgage. This amount, however, will be transferred during the ensuing year, in addition to the sum due for 1926.

The future expenditure must be estimated at £1,500 per annum, and it is hoped the available income will not fall below

this figure.

The Executive Committees of the two Hostels are grateful for the interest on 1650 shares in Rembau Jelei Rubber, Ltd., presented to the Hostels by a friend of Sir Thomas Barlow, and registered in his name. The interest on these shares is divided between the two accounts and appears in the list of donations.

HIGHBURY QUADRANT HOSTEL.

Details of the Year's Work.

The Highbury Hostel has been in full swing for just over a year, and the Committee feel they may be allowed to congratulate themselves on the success of the enterprise. This success is due, almost entirely, to their having been able to find a most admirable and devoted staff.

The great need for such a Hostel is shown by the fact that there is rarely a vacancy, and that during the year, 61 patients and 41 babies have been in residence; the total "patient days" being 5417 and the baby "patient days" 3070.

Premises. The house has now been adapted as far as is possible, for its special purpose, and the garden and verandah contribute greatly to the health of both mothers and babies. Through the generosity of an anonymous donor the old stable has been converted into an excellent drying-room for laundry.

Patients. On entering the Hostel the girl is expected to help in the house or kitchen, according to her state of health. When first admitted there is no doubt that she is going through a difficult time. She soon settles down and after her return from the Royal Free Hospital where she is sent for her confinement, pride in and affection for the child predominate, and for the next few months she is absorbed and happy.

It has unfortunately not been found possible to arrange definite educational courses this year, but members of the Committee have generously given up time to visiting the Hostel regularly, and in this way have become better acquainted with the patients and their needs.

Babies. Every effort is made to keep a patient in the Hostel until her child is six months old, and established in health, but it is sometimes difficult to prevent a mother from becoming restless, and going out sooner, to earn her living.

Special health records are kept of the children of syphilitic mothers, and photographs taken of them. These records will, if possible, be continued through childhood and adolescence, and it is hoped that they will show that congenital syphilis can be completely eradicated by the thorough treatment of the mother. Observations limited to the first year or two of life are not

sufficient proof, as symptoms of congenital disease may appear for the first time when a child is 12 or 14 years old. Thanks are due to Miss Higgins for the trouble and time she has given to photographing the babies.

After-Care. It will be realised that it is not yet possible, after only a year's work to give detailed records of After-Care. But it is gratifying to note that the patients take pleasure in returning to the Hostel after discharge, and that from January 1st to March 31st, the Sister-in-charge had received 75 visits from Old Girls.

Medical Officer's Report,

Report from Dr. A. R. Campbell, M.B., Ch.B., Medical Officer, Highbury Quadrant Hostel.

"The first year of the Hostel since its re-organisation, can, I feel

sure, be considered successful.

"The figures on another page show that the beds have been almost fully occupied, and that the majority of the women have been admitted during pregnancy. Thirty of the mothers were suffering from gonorrhoea, but there has been no case of eye trouble among the children. Four infants had syphilitic mothers, but the mothers having had treatment before confinement the babies showed no sign of disease at birth, and their blood tests taken at the age of six to eight weeks were negative.

"The babies are mainly breast-fed, or breast-fed with a supplementary feed of cow's milk. Any infant not doing well has had test feeds taken over a period of ten or fourteen days and a supplementary feed has been given as required. The mothers are encouraged to continue breast-feeding by every means and take pleasure in so doing. The results are so definitely successful that weaning has only been resorted to when there have been signs of failing health and loss of weight in the mother, or preparatory to the child leaving the hostel for a foster-home. No baby has been reared on patent food.

"The nursery in the Hostel, with its windows opening on to a verandah and garden is an ideal room for children, and they have been outside for part of the day at least, throughout the different seasons. There has been no epidemic, or infection in the nursery, credit for this must be given to the staff and to their care and supervision of all details.

"One child, a premature infant two weeks old, died of bronchial catarrh two days after its return from hospital. Another child had broncho-pneumonia, he was admitted to hospital, and is now doing well. Four infants were still-born, in three cases the mother had gonorrhoea, and in one syphilis, but the cause of the still-birth of the latter was obstructed labour. One infant was born prematurely at six-and-a-half months, and died in two hours.

"In general the health of the patients has been very good, and there is marked improvement in their condition after a very few days in the Hostel. The food is ample and well-arranged. The staff have been well and have worked together splendidly."

Finance.

The Committee wish, first of all, to thank those generous friends who by subscriptions and donations have made it possible for them to embark on the necessary alterations and repairs on taking over the Hostel, and to buy enough equipment to start it on efficient lines.

Especially would they like to thank the Trustees of the Women's Training Colony for a gift of £100, an anonymous donor for a gift of £75 to be spent on capital outlay (which has been laid out on a laundry and drying room) and another

anonymous donor of £50.

The Committee are much indebted to an anonymous friend of the Chairman who has made over to him £1,650 of shares in the Rembau Jelei Rubber Co., Ltd., the interest on which is to be divided annually between the two Hostels, and which, this year, has amounted to a dividend of 25 per cent.

It will be seen, however, that the subscription list is lamentably small, and it would be a real help if, in the coming year, each present subscriber would find one more friend to promise

an annual subscription.

The Committee have to report the purchase of the freehold of 22, Highbury Quadrant for the sum of £625, the cost of this being defrayed from the £1,250 4 per cent. Funding Stock which was handed over, together with the Hostel, on the understanding that it should only be used for capital expenditure.

It will be seen that the accounts cover the whole period from the opening of the Hostel on January 19th, 1925, until the close of the financial year on March 31st, 1926. It is therefore impossible to make an accurate estimate of the cost per head, but roughly, the cost per patient is £2 17s. 6d. a week, or, excluding extraordinary expenditure on alterations and equipment, £2 7s. 3d. a week.

The cost of food per head is 10s. 6d. a week per adult, and 7½d. a week per baby. The medical officer in charge is entirely satisfied with both the quantity and quality of the fare provided. Great praise is therefore due to the Sister-in-charge and the Staff for their careful and economical catering.
