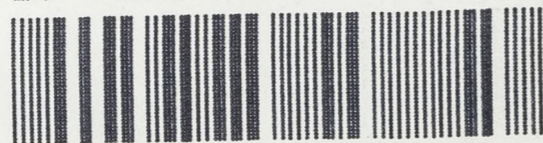

ANNUAL REPORT, 1938.

**Opening Remarks.**

Looking back over the past year we find that the first three months were taken up with thoughts of the Coronation and its attendant functions, since when the Junior Council's work and social activities have prospered; but we should not be fulfilling the purpose for which we were created—that of securing and preserving the economic status of the young professional and business woman—if we were not alive to the somewhat disturbing influences at work in the world around us.

To-day democracy is being challenged on all sides and reactionary principles have triumphed in countries which were amongst the first to give emancipation to women. This world-wide tendency gives warning that we must seek renewed vigour and purpose if we are in the future to preserve that freedom of thought and action of which we are so proud.

This Society has one great possession—its Library—and if this can be endowed so as to remain for all time as a record of women's work, we shall have contributed not only a permanent memorial to the women's movement, but a storehouse of fact and information with which to fight any retrogressive influences that may creep in in the future.

For this reason the Society is launching a big scheme of endowment for the Library, so as to relieve itself of the expense of its upkeep. The Junior Council is supporting this work in that it has agreed, with very mixed feelings, to Mrs. Henderson devoting the greater part of her time to assisting in this task. It has also been agreed that the Junior Council should take a more active part in the Society's public work, as will be seen later in the Report.

**Monthly Parties.**

Again this year the Executive Committee wishes to express its grateful thanks to the Groups Committees for their valuable co-operation in the organization of some of the Monthly Parties. One of the most successful of these was held in April 1937, when Victor Stibel, the distinguished young dress designer, not only accepted the Society's in-

itation to speak on "Fashion Secrets" but secured the collaboration of Norman Hartnell and Digby Morton in staging a display of models suitable for all occasions. We were fortunate in having as Chairman on this occasion Mrs. Oliver Strachey, Organising Secretary of the Women's Employment Federation.

In June the Junior Council entertained Sir Henry Walker, C.B.E., LL.D., H.M. Chief Inspector of Mines, who gave a fascinating talk on "Coal Under England," illustrated with slides.

At the end of the month the Junior Council co-operated with the Senior Society in an At Home to meet the President, Lord Cecil of Chelwood. Those who were able to be present on this occasion will long remember Lord Cecil's delightful talk, full of incidents of the past, in which he and many members of the London Society had played a leading part.

Before parting for the summer holidays the Executive Committee decided to give an At Home "to meet ourselves." The opportunities for getting to know each other are all too few and this provided a welcome occasion for meeting informally which might well be arranged more frequently, both by the Executive Committee and the Groups.

The meeting arranged for October proved to be singularly opportune, for Lord Lytton had been invited to speak on "International Peace." At that moment, with the recent outbreak of war in the Far East, added to the already long drawn out conflict in Spain, Lord Lytton addressed an audience eager to hear how international problems might be solved without recourse to arms.

There are some occasions when we could wish our Hall was twice its size, and one of these was when Miss Delafield came to speak to us on "Life on a Farm in South Russia." The very word Russia has come to be a danger signal, but on this occasion the detailed story of several months in this country was so enthralling that controversy over political opinions faded into the background, and the description of the daily problems of life without almost everything we consider essential to it was all-absorbing.

In November the Committee invited Mr. A. F. Wise to speak on the work of The Hospital Savings Association. As a result of this meeting, at which Miss E. Douglas presided, several Junior Council members offered to help in the organisation of H.S.A. Groups of subscribers and, subsequently, a Group was formed by one of our members among her own staff.



After this meeting the Junior Council devoted its energy to assisting with the Christmas Fair, and the "Twenties Group" to organizing a "Bavarian Evening."

The year covered by this Report ended with one of the most delightful parties the Junior Council has ever had, when Dr. L. D. A. Hussey was the guest of the evening and gave a most thrilling description of his journeys with Shackleton in the Antarctic, illustrated by some magnificent slides taken during the 1914-16 Expedition.

### Groups.

The great value of the Groups lies in the fact that they fulfil one of the principal objects of the Junior Council by providing opportunities for members to meet and exchange views on their own work as well as topical subjects. These small informal gatherings encourage individual expression of opinion in a way which is not possible at larger meetings.

### Arts & Letters Group.

On April 22nd the Group co-operated with the Executive Committee in arranging a party at which Mr. Victor Stiebel gave a most entertaining talk on Fashions.

During the summer members of all the Groups were invited to join in an evening expedition to the Gardens of Penn House, Amersham. Viscount Curzon very kindly had the gardens kept open specially for the party, and with his permission the visit ended with a picnic supper in the grounds. Members gave a contribution to the Queen's Fund for Nurses.

The first meeting in the autumn took the form of a Naval Ration Party when Miss Mary Field (Director of G.B. Instructional Films) spoke on "Dominated by America."

On January 19th, 1938, a debate took place between Miss Pamela Frankau and Mr. T. B. Martin, Political Correspondent of the *Daily Telegraph*, on the motion "The Public Censor is a Victorian Anachronism." Miss Martita Hunt, who presided, greatly contributed to the gaiety of the evening by her anecdotes of the Stage. A much appreciated innovation was the serving of punch in the course of the evening.

On February 3rd the Group met at Old Devonshire House, by kind invitation of Major Benton Fletcher, who gave an interesting lecture on his unique collection of old musical instruments.

On March 14th, Captain George Hill, D.S.O., gave an exciting account of his thrilling experiences as a Secret

Service Agent during and after the War. Miss Edna Mosely, as Chairman and Mrs. Gardner, the Hon. Secretary, have both given much valuable time to the arrangement of the very varied selection of parties, and the thanks of all members of the Group are due to them for their generous and able management of the Group's affairs.

### Law Group.

A very original party was held in the Library in October 1937. Miss Stoney and Miss Amphlett read a number of unpublished family letters, including those from Lord Chief Justice Scroggs; Elizabeth Chudleigh, Duchess of Kingston; Edmund Burke and Mary Wollstonecroft Shelley, and an exceedingly interesting selection from letters by the Misses Grant of Rothiemurchus written on the occasion of the Coronation visit of George IV to Edinburgh; the reading was from the original letters, kindly loaned by Miss Philippa Strachey. These, together with other very curious old documents, were handed round for inspection afterwards.

In the following month another party was held at the special request of several members to explain the material alterations brought about by the recently passed Matrimonial Causes Act, and the effect of such alterations on exemplified cases. Miss Amphlett undertook this far from easy task, and the Group was much indebted to her for a singularly clear exposition. Both the Chairman and Secretary answered all questions subsequently raised by attendant members.

The Committee are now actively engaged in the organisation of meetings on "Voluntary Euthanasia" and "Penal Reform," and hope to secure well-known speakers on these subjects. It is thought that these meetings will attract large audiences in view of the keen interest both subjects have for many members of the public. A definite promise to speak on Penal Reform has been received from Miss Lilian Barker (a very old friend of the Society) and Mr. Alexander Paterson, one of H.M. Commissioners of Prisons.

Members are urged to support the Group by securing new members and also to send in suggestions for subjects of popular interest.

The Committee of the Group particularly wish to draw the attention of members of the Junior Council to the fact that membership of the Law Group is not confined to members of the legal profession. The Group has been fortunate in having Miss Stoney as Chairman again this year and Miss Amphlett as Hon. Secretary, in spite of many calls on their time in other directions.



### Political Group.

In April of last year the Political Group arranged a visit to the Home Office Museum, and, under the guidance of Miss Helen Mosely, twenty-five members of the Group were shown the Museum exhibits and were instructed in many of the safety devices used in factories.

During the summer the Group co-operated with the Junior Council Executive Committee in the organisation of a party at which Sir Henry Walker gave a very instructive lecture on Coal Mining.

Owen Green, head of Reuter's Far Eastern Department, accepted the Group's invitation to speak on October 4th on the war between China and Japan. Mr. Green has lived in China for the last twenty years, and it was not surprising that his lecture proved vividly interesting.

Mrs. Frank Ormerod, who was to have spoken at the November meeting, was unable to do so owing to unforeseen circumstances. Her place was taken by Miss Clare Hollingsworth, who gave a most enlightening talk on the Balkan States.

On December 13th a party of twenty members visited the General Post Office, where they watched the work of the Sorting Office at its "peak hour," handling the heavy Christmas mails. The Foreign Postal Section was visited, and, by a special concession of the authorities, the visitors were allowed to see the Post Office Underground Railway at work.

In February members of all Groups were invited to hear Mr. John Newsom, Director of the Durham Community Service Council from 1935 to 1937, speak on "The Special Areas." He drew a vivid and very human picture of the way in which the Council is grappling with the new and complex problems caused by unemployment on such an unprecedented scale.

Mrs. Frank Ormerod spoke at the March meeting, taking as her subject "What of the Refugees?" As the date of her lecture coincided with Germany's occupation of Austria and Mrs. Ormerod herself had only just returned from Vienna, the plight of the refugee had a specially grim reality.

Miss Amicia Carroll, Chairman, and Miss Sara, Hon. Secretary, are to be congratulated on the very successful results of their efforts on behalf of the Group during the year.

### Science Group.

"The History and Work of the Lister Institute" was the subject of the first meeting of this Group, when Miss Edgar gave a stimulating talk illustrated by lantern slides.

In July the Group invited members of the Arts & Letters and the Law and Political Groups to join them in a visit to the Pool of London. Although the warehouses were not open, all docks belonging to the Port of London Authority were visited and the interest of the trip was greatly enhanced by a running commentary on the points of historical interest with which the shores abound.

The Science Group voted by an overwhelming majority in favour of present day design in Architecture and Furniture when Mr. J. Craven Pritchard spoke on "Modern Architecture in relation to Modern Life" at a meeting held in February 1938. Miss Theodora Alcock, in spite of a very busy professional life, has continued to act as Chairman, and Miss C. G. Gatey as Hon. Secretary.

The Committee will welcome as members all those interested in scientific subjects whether they have technical knowledge or not.

### The Marsham Street Players.

A very successful production of "Sixteen" by Aimee and Philip Stuart was given on April 27th, 1937.

In May our Chairman (Miss J. M. Bowie) invited the members and the men who had acted for the Dramatic Society during the season to a Winding-Up Party at her house at Ardingly, where a delightful afternoon was spent in her beautiful garden.

The new season 1937 - 38 was begun with a balance in hand, so it was decided to effect some improvement in the lighting on the Stage of the Hall, and £15 was spent on this.

On November 29th, 1937, the Players entered the *News Chronicle* Drama Contest, with a performance of "Mystery at Greenfingers," which J. B. Priestley had specially written for this contest. Many difficulties were encountered during the rehearsals of this play, the chief one being illness amongst the cast. In view of the work involved in the presentation the usual entry for the British Drama League One-Act Play Festival was not undertaken.

On April 4th and 5th, 1938, two performances of the old Chinese play "Lady Precious Stream" by H. S. Hsiung, were given. The Players were fortunate in having the advice of Mrs. Viga Hart, of Miss Nancy Price's Company, on the costumes and properties. A member of the Junior Council,



Miss Lena Purcell (make-up specialist), nobly undertook the task of making up the large cast with excellent results.

This play entailed an enormous amount of work, especially in the making of the properties which was undertaken by the members. This was the first occasion on which two performances of a play had been given, and with a little more support from the Junior Council and the parent Society this could be done profitably.

Mr. Arthur Ewart was the producer again this season. He has worked hard and patiently, and the Players are much indebted to him.

The Secretary will be pleased to welcome new members, especially anyone with a knowledge of scene and costume design and property making. Subscriber members are entitled to two tickets for each performance and need not be actors.

#### **Walkers' Club.**

In March 1937 the Walkers' Club realized a long cherished ambition to visit Whipsnade. They went across country from St. Albans, visiting the recent excavations at Verulamium on the way, and after a tour of the Zoo they watched the exploits of the Gliding Club at Dunstable.

The next expedition was to Cambridge, where Newnham and Girton were visited. A later walk ended in a visit to the National Maritime Museum and to Greenwich Park.

On a Saturday afternoon before Christmas a few members visited the Roman Bath in the Strand and proceeded to the Christmas Shopping Markets in Leather Lane, Covent Garden and Shepherd's Bush.

Whitsun was again chosen for the annual week-end walk, this time in the Cotswolds. The route included Hailes Cistercian Abbey, Belas Knap, the famous Long Barrow, and Bourton-on-the-Water. The party were particularly struck by the picturesque and solid stone houses, set in such lovely surroundings, and found it difficult to tear themselves away from this delectable country at the end of the all too short holiday.

The Club has been fortunate in having leaders whose homes are in the midst of attractive scenery and who have most generously entertained the Club at the end of some delightful walks, in their neighbourhood.

#### **Bridge Circle.**

The Bridge Circle, which meets every Tuesday evening in the Members' Room, continues to flourish, and, in order to increase the number of players, a small class for beginners has been organised by Miss Douglas and Miss Douie. This meets from 6.15 to 7.45 p.m. every ten days, the next date being arranged at each class to suit the convenience of the majority. The charge made is 1/- per head for a lesson of 1½ hours' duration, the attendance has been very good and both instructors and instructed appear to have enjoyed the sessions.

Another successful Bridge Party was held on November 30th, 1937, in support of the Christmas Fair, the proceeds amounting to £8 12s.

#### **Twenties Group.**

At the last Annual Meeting it was decided to attempt the formation of a Student Group. A sub-Committee of the Executive which met on July 12th was appointed to deal with this proposal, and after much discussion it was agreed that a letter should be sent out to all members of the Junior Council with the object of interesting the younger ones in the Junior Group and gaining the help of the older ones by asking them to interest their own young friends in the project. All arrangements were to be left to those members of the Junior Council who were twenty-eight or under.

A general invitation was issued to a Party for young members in the Members' Room on September 27th, and at this meeting it was arranged to hold a card party the following week. Several small meetings of this nature were held in the course of the autumn, and it was subsequently agreed to try to form a Badminton Club. This project was continued for several weeks, but the inaccessible position of the court made it impossible to continue on a permanent basis. It was hoped, however, that a court in a more central position might be found for the coming winter.

On March 10th Miss Bagnall and other members of the "Twenties Group" organised a "Bavarian Evening" in the Millicent Fawcett Hall. This proved a very gay and successful function, and brought in a considerable profit to swell the funds of the Christmas Fair and the "Twenties Group."

On the whole the attempt to form a group of younger members in the Junior Council has not been successful. There is still a very real need for a Group of this kind and Miss Bagnall and Miss Henderson (the Hon. Secretaries) will be delighted to hear from any members of the Junior Council



who would be willing to co-operate with them in making a further effort to organize such a Group.

### **Public Work.**

*Ministry of Labour "Cost of Living Enquiry."* A request was received from Miss Popert, Manager of Great Marlborough Street Labour Exchange, and a member of the Junior Council, for help in the Ministry of Labour Enquiry into Cost of Living. A circular letter was sent out to all members, and as a result nine volunteered to help in this scheme.

Miss Popert wrote to the Executive Committee thanking them for their very kind help in making the matter known to the Junior Council, and expressed her gratitude to those members who had taken part in the enquiry, and her appreciation of the highly efficient way in which they had carried out the work.

Under the auspices of the Arts & Letters Group Committee and with the object of supporting the claim for equal pay for men and women in the Civil Service, an Ad Hoc Committee was set up in March, 1938 to enquire into the position of salaried Architects in Government and County Council Departments, with Miss Strachey as Chairman. The first meeting was held on Wednesday, March 30th, and it was then resolved to make certain preliminary enquiries and to meet again in April.

Members of the Junior Council Executive and the Chairman and Secretary of each Group have continued to attend the meetings of the Public Work Committee of the Society, and have testified to the immense interest felt by them all in the matters dealt with by this Committee, which they recognise as their principal fount of knowledge on the work upon which the Society is engaged.

## **JUNIOR COUNCIL ANNUAL MEETING**

**MEMBERS' ROOM, 10th MAY, 1938, at 8.15 p.m.**

Chairman: Miss K. I. Hancock.

### **I. Appointment of Returning Officer and Tellers.**

Moved from the Chair and passed that Miss M. E. Brasnett should act as Returning Officer and Mrs. Hume and Miss Robinson should act as Tellers for the Ballot and Miss Lister and Miss Alcock as Tellers for the Resolutions.

### **II. Appointment of Auditors.**

Moved Miss I. Stoney, seconded Miss T. Alcock and passed that E. Watts & Co. be appointed Hon. Auditors for the ensuing year.

### **III. Annual Report.**

The Annual Report was then read by the Hon. Secretary, Miss K. M. Halpin. Moved Miss E. Cook, seconded Miss D. Lange and passed that the Report be adopted.

Miss Strachey asked leave to congratulate the Junior Council on the excellent year's work under review and stressed its increasing participation in the activities of the Society.

### **IV. Treasurer's Report.**

The statement of accounts was read by the Hon. Treasurer, Miss M. H. Pearson. Moved Mrs. Johnstone, seconded Mrs. Rolfe that the financial statement be adopted. Carried unanimously.

Miss Pearson reported on the Special Appeal that had been launched during the year. She pointed out that the total of £95 had been subscribed by 207 members, which was only one-third of the membership. In consequence the total fell far short of the amount aimed at. Without the Appeal the Junior Council would have had a deficit of about £15.

### **V. Constitution. Alteration of Rules:—**

Rule VI. Membership.

Associate Membership.

It was proposed by Miss K. I. Hancock, who vacated the Chair for this purpose, that this Rule be amended as follows:—



"Members of the Junior Council who resign after not less than one year's membership on the ground that they are no longer able to take an active part in the work of the Council shall be eligible for election to Associate Membership at a subscription of 5/- per annum. Such members shall be notified of the Annual Meeting and have the right to attend the meeting and to vote. They shall also be entitled to receive a copy of the Annual Report, but not of any other notices or invitations."

Miss Hancock pointed out that this resolution had been drafted to meet the needs of those members who left London and who would like to keep in touch with the Junior Council, although they could no longer be active members. The Junior Council was something more than a club, and many members would be willing to give financial support for its work after they had left London. Certain dangers would arise if it were possible for new members to join the Junior Council as Associate Members and immediately have the right to vote at the Annual Meeting, and these dangers would be met by limiting Associate Membership to those who had been full members. A letter had been sent out to all members who had resigned during the past year asking for their views on this subject, but had met with little response.

Miss H. Mosely seconded the motion and said that from her own experience such a scheme of Associate Membership would be a great benefit.

Miss Strachey pointed out that this would involve a change in the Constitution of the Society as a whole, and would therefore have to be referred to the Annual Meeting of the Society in the autumn before ratification.

The resolution was put to the meeting and carried nem. con.

#### VI. Resolution. Spinsters' Pensions.

"That the Junior Council of the London & National Society for Women's Service, holding that the position of working women would be further impaired by lowering the age at which old age pensions are payable to unmarried women under the Contributory Pensions Acts, calls on the Government to reject this proposal and to meet the complaints of unmarried women under these Acts, by (1) raising the income limit for women voluntary

contributors under the 1937 Act to an equality with that of men contributors, and, (2) improving the position of the insured women through a modification of the National Health & Unemployment Insurance Acts to ensure their receiving equal treatment with the insured men."

Miss Cridland moved this Resolution on behalf of the Executive Committee. She pointed out that women already suffered great injustices with regard to Health and Employment Benefits generally, and that it would therefore be better to work to improve existing conditions than to press for Spinsters' Pensions. The annual amount of 4½ millions which would be needed to provide Spinsters' Pensions might much more profitably be spent on such improvements. Further, if this scheme were adopted it would probably have an injurious effect on the economic and social position of women generally, by tending to give support to the idea that a woman's working life was of very short duration and that at fifty-five she was of little value in the labour market.

Miss Gatey seconded the Resolution, and endorsed the point made by Miss Cridland that a pension would result in a decreased labour value, as in the case of agricultural workers, where such a situation has already arisen. The Resolution was put to the vote, and carried nem. con.

#### VII. Other Business, by leave.

Membership Campaign. Miss Stoney.

Miss Stoney stressed the infinite variety of occupations represented among the membership and that the contacts made within the Junior Council were frequently of immense value in business life, particularly to those who had completed their period of training and were on the brink of their professional or business careers. Miss Stoney urged that a vigorous membership campaign be sustained and that individual members should assist the Executive Committee by supplying regularly from such sources as were specially available to them the names of entrants into their particular sphere of professional or business life.

Women's Employment Federation. Mrs. Oliver Strachey.

Mrs. Strachey said she welcomed the opportunity of speaking to the Junior Council, with which the Women's Employment Federation had such close ties. She pointed out the great value of the Federation as a central store-house



of information on all questions of women's work: this was achieved by the close co-operation which existed between the schools, universities, and other bodies which were affiliated to the Federation. A very successful campaign had been waged a few years back on the question of the entry of women candidates into the higher grades of the Civil Service, and as a result there had been a great increase in the number of candidates presenting themselves for the examination. At the present time a general enquiry was being organised into Nursing as a career for girls. Mrs. Strachey said that one of the chief problems with which the Federation had to deal was that of the middle-aged woman who had lost her job and who had no capital behind her. She went on to stress the need for women to insure in their retirement at as early an age as possible, as it was only by this means that they could get premiums low enough for their normally low wages. She gave an outline of some of the insurances approved by the Federation, and offered to give detailed rates to any members interested. It was suggested by a member that a meeting might be arranged by the Junior Council on this subject. The Chairman thanked Mrs. Strachey for describing so fully the work of the Women's Employment Federation and especially for the very useful information she had given them on the varied forms of insurance that are now obtainable.

#### VIII. **Election of Executive Committee.**

Miss Halpin and Miss Pearson were re-elected as Hon. Secretary and Hon. Treasurer respectively. Seventeen nominations were received for membership to the Executive Committee, a ballot was held and thirteen members were subsequently elected. The result of the Ballot was announced at the end of the meeting.

## CONSTITUTION.

### I. Title.

The title of the Council shall be "the Junior Council of the London and National Society for Women's Service."

### II. Status.

The Junior Council is an organisation working independently within the London and National Society for Women's Service, whose General Meeting governs the policy of the whole Society. There is no obligation upon the Junior Council as a body to work for any one of the activities of the Society.

### III. Object.

The Junior Council supports the aim of the London and National Society for Women's Service for equality of citizenship between men and women, and works specially for equal economic opportunities and freedom for women in the pursuit of their work.

### IV. Methods.

1. The Council holds regular meetings of a social character, with speakers on topics of common interest and collects information on Trainings and Openings for women.
2. The Council enables professional and business women to meet each other, and links up students with women already practising or in business.
3. The Council provides opportunities for the development of new enterprise.

### V. Governing Body.

The governing body of the Junior Council shall be the general meeting of members, which will elect annually by ballot an Executive Committee, an Hon. Secretary, and an Hon. Treasurer to conduct the current business of the Council.

### VI. Membership.

1. Subject as hereinafter mentioned:—

The Junior Council shall consist of (a) men and women who have or have had a professional or business qualification; and (b) of students: (i) who

support its aims; (ii) whose applications have been passed by the Executive Committee; and (iii) who have paid the current annual subscription.

2. The minimum annual subscription shall be 10/- for all members for five years from the date of joining the Junior Council and shall then be raised to £1. This shall apply only to those members who join on or after 1st January, 1935. Members shall have the right to use the Library, restaurant, and other facilities provided by the Society.
3. The Executive Committee shall have the right to terminate any membership without assigning a reason.
4. Membership of the Junior Council carries with it membership of the Society.

### VII. Officers.

The Officers of the Council shall be the Chairman, the Hon. Secretary, and the Hon. Treasurer.

### VIII. Executive Committee.

1. The Executive Committee shall consist of the Officers of the Junior Council, and not less than nine and not more than twelve other members to be elected by ballot at the Annual Meeting, and shall have power to co-opt not more than five additional members. A member who has served for five consecutive years shall not be eligible for re-election to the Committee until after the lapse of one year. Officers shall be eligible to serve for five years, as such, regardless of previous service as a private member of Committee.
2. At the first meeting after election, it shall elect the Chairman for the ensuing year.
3. It may from time to time make Bye-laws, and shall have power to fill by co-option any vacancies which may occur during its term of office.
4. It shall have power to appoint Sub-Committees for special purposes.
5. The Minutes of the Executive Committee of the Junior Council shall be open to the Executive Committee of the Society.



### IX. Nominations.

1. Any member may be proposed for election or re-election as Honorary Officer or Member of the Committee on the nomination of two members of the Council to whom the candidate is personally known.
2. Nominations, with the consent in writing of the candidate nominated, shall reach the Secretary at least fourteen clear days before the Annual Meeting.

### X. Meetings.

1. An Annual General Meeting of the Council, of which not less than twenty-eight clear days' preliminary notice shall be given to each member, shall be held as soon as convenient after April 1st in each year.
2. Special General Meetings of the Council (*a*) may be called at any time by the Executive Committee either of the Junior Council or of the Society, and (*b*) shall be called by the Secretary within twenty-eight clear days on the requisition of not less than one-tenth of the members of the Council, of not less than three calendar months' standing. A Special General Meeting shall discuss only such matters as are mentioned in the notice calling the meeting, and not less than fourteen clear days' notice shall be given of General Meetings to all members.
3. Joint meetings of the Executive Committees of the Junior Council and the Society shall be held at the request of either Committee.

### XI. Resolutions.

Proposed Resolutions to be discussed at the Annual General Meeting with names of proposers and seconders shall reach the Secretary in writing at least fourteen clear days before the meeting, and shall have been published at least seven clear days before that date. Resolutions shall be passed by a majority vote except as hereinafter provided.

### XII. Alteration of Constitution.

The Constitution shall not be altered except by resolution passed at a General Meeting of the Council by two-thirds of the members present and voting, provided always that no rule of the Junior Council shall be at variance with the Constitution of the Society as a whole. The nature of the proposed alteration must be stated in the notices calling the meeting, and not less than fourteen clear days' notice given to all members.

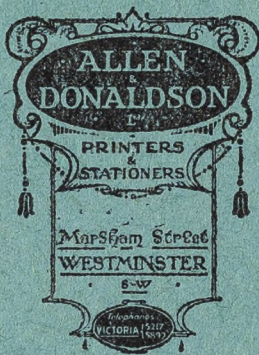
