# Twenty-First Annual Report

#### INTRODUCTORY

1937 will be remembered by Women's Institute members for a Coronation and a Coming of Age. Of the last event we shall speak first.

On July 21st was celebrated the 21st birthday of the Women's Institutes. Thousands of members listened to the broadcast, hundreds of telegrams poured into the N.F.W.I. office, hundreds of birthday cakes were lit with 21 candles. In short, the great occasion was marked with fitting ceremony, and the fact that the celebrations were held locally made it possible for nearly every member to take part in them.

"Birthdays are jollifications," wrote *Home and Country*—" they are also stocktakings—what have our twenty-one years done for us, what have we done for them?" Answers to these questions are to be found amongst the birthday messages from some of the people best qualified to speak.

Lady Denman said: "The experience of our 21 years work shows that we can do something to add to the happiness of the countryside. But we realize that to make the country a better place to live in, and to be able ourselves to get the best out of country life we must do a great deal more when we meet together once a month than to have tea and a good friendly talk."

Miss Hadow said : "The movement links in common work and common friendship all countrywomen, whatever their race or their experience may be and because it works through individuals, works slowly but all the more surely."

Mrs. Watt said : "At Llanfair, Anglesey, 1915, I met with 50 complete strangers to form the first W.I. At the Albert Hall, 1937, I saw in front of me 8,000 friendly faces. The years between tell of knowledge gained for the enrichment of our lives of ever widening

outlook and responsibilities, of growth in grace and understanding which may yet make for each of us a new heaven and a new earth."

Mr. Bostock, former Chairman of the Agricultural Organization Society, and one of the first champions of Women's Institutes, wrote, "I have often lifted up my heart in thankfulness as I have watched the growth of the movement from its start. As a country dweller, I am thankful for its past and present strength . . . ."

Lord Ernle, Minister of Agriculture during the time that Women's Institutes were under the wing of the Ministry's Food Production Department, 1917-1919, wrote, "No movement has done or is doing so much to break down the barriers of village life, vary its interests and create new domestic interests and occupations."

Finally, Mr. Nugent Harris, to whose enthusiastic support the foundation of the movement in this country was in a great measure due, pointed the signpost forward when he said, "What an opportunity such an occasion presents for drawing up a balance sheet to ascertain where the movement stands and on the information disclosed to develop, if necessary, a new policy to meet the new conditions that have grown out of twenty-one years of experience."

He was not alone in urging Women's Institute members to look ahead. That desire was common to the good wishes of all their principal friends and leaders. The stocktaking was suggested not so much as a means of finding out how much the Institutes have been able to accomplish so far but in order that they might gauge their strength and their readiness for fresh work and new developments.

But the fact that our thoughts have been directed to 1938, rather than to 1916, does not indicate ingratitude for what the movement has already done and more especially for the devoted work given to its foundation by so many people. Of our selfgovernment we are proud, but we are equally proud of our leaders :--for without good leadership self-government cannot flourish. "If the Women's Institutes enjoy liberty and democracy, if they are tolerant and broadminded, and humorous with a sense of comradeship amongst themselves they know well that they derive these traditions from the sanity, liberality and foresight of those who made their framework long ago in the days of their uncertain infancy . . . all societies owe their spirit as well as their form to their first founders." During the year the thanks of the Institutes to those who have given service for them, and more especially to their leader-in-chief, have found expression in two ways. The County Book presented to Lady Denman at the Annual Meeting was "in token that there is no county in England and Wales in which her name is not held in warm affection and

respect as that of a wise and just Chairman and a true friend, and in grateful recognition and acknowledgment of twenty-one years of unsparing service." A few months later a card went out to every Voluntary County Organizer in England and Wales on which was recorded gratitude for their services so generously given to the Institutes, in many cases since the very earliest days.

So as the year comes to an end may we hope that the Institutes, their stocktaking accomplished and armed with plenty of good advice are now looking resolutely forward to "fresh woods and pastures new".

Our motto is Home and Country. It was a happy chance that made our domestic celebration coincide with the great national rejoicing of the Coronation. Suffice it to say that through the generosity of the Government over a thousand Institute members had a superb view of the historic procession from a special stand of their own, that their enthusiasm was entirely undamped by a downpour of rain, that their discipline under the Napoleonic eye of Miss Simpson was perfect, and their anti-litter efforts on the whole very creditable. Even the member who was seen depositing her hat in the litter basket as she left the stand said, "Yes, I shall go home bareheaded, but what is a hat compared to a Coronation; I shall never forget this day!"

In the pages which follow will be found a detailed account of the activities of the year. On the organization side it is encouraging to note the increase in Institutes and membership (page 28) which is above the normal for the last few years. On the public questions side work of special interest and importance has been done with regard to the price of milk (page 16) and to the Government's Family Budget Enquiry (page 18).

#### WORK AT HEADQUARTERS

#### N.F.W.I. EXECUTIVE COMMITTEE.

The Executive Committee has held twelve meetings during the year. A list of the Committee and Officials will be found on page 4.

#### STAFF.

Owing to the expansion of work the Committee decided in the spring to appoint a third administrative secretary. Four County Federation secretaries were short-listed and interviewed. From these Miss Marriott was appointed, and started work at the beginning of July.

#### ANNUAL GENERAL MEETING.

5,379 delegates' and 1,908 visitors' tickets were issued, and approximately 5,153 delegates attended, i.e. about 91 per cent. of the possible maximum. There were about 150 more delegates than in 1936. A report of the meeting will be found on page 30.

#### CORONATION.

Help was given to the Office of Works in distributing the tickets for the W.I. Stand. Five hundred seats and 1,000 standing places were allotted and used by W.I. members from all over the country. A message of thanks for this privilege was sent to H.M. Government from the Annual Meeting.

#### ROYAL SHOW, WOLVERHAMPTON.

Miss Hirst Simpson was again in charge of the N.F.W.I. Exhibit with Miss Rowe as assistant on the handicraft side.

Thirteen County Federations entered for the Denman Cup Competition—an increase in entries of seven compared with 1936. The judges, Miss Hirst Simpson, Miss Adams (Board of Education) and Miss Jessie Ferguson (University of Bristol) awarded first place to Warwickshire, second place to East Sussex, and third place to East Suffolk. The new method of collecting the rest of the produce exhibit worked satisfactorily and special local exhibits from Staffordshire were staged both on the handicrafts as well as on the produce side.

Eleven meetings of this Sub-Committee have been held.

Agricultural Activities in the Counties.

The Committee, during the period of the report, has had under consideration a scheme of work for the encouragement of

agricultural activities in the counties. This scheme includes help with agricultural competitions in the Institutes, the provision of produce judges, and an Agricultural Questions Quarterly Service, on the lines of the Public Questions Service already in existence. The first issue of the new Service appeared in December. In the same month a memorandum on Agricultural Competitions in the Institutes was circulated to the counties.

#### Rural Domestic Economy Conference.

Forty-six students from thirty County Federations attended this successful Conference, the first of its kind to be organized by the Committee. The theme of the school was "Growing and Cooking". Sir Daniel Hall spoke at the opening session and the other speakers were: Mr. Robinson, M.Sc., Principal, Midland Agricultural College; Mr. C. F. Lawrance and Miss Strang, both of the Northamptonshire County Council; Miss Hope, Miss Cox, H.M.I., Board of Education; Mrs. Munro, Miss Miles, Miss Rotherham and Miss Hirst Simpson. It is hoped that County Federations will now organize similar schools in their own localities.

#### British Dairy Show.

Miss Simpson gave a favourable report on the W.I. Exhibit at the British Dairy Show. The Committee noted with interest that the standard was higher this year in all classes of fruit preservation, and that two-thirds of the exhibitors gaining awards in the open classes were W.I. members. Congratulations were sent from the Committee to the Institutes gaining first and second awards in the co-operative class for W.I.s only.

#### N.F.W.I. Flower Show.

Arrangements are being made for a small Flower Show, open only to County Federations, to be held at the time of the Annual General Meeting in London in 1938. Full particulars were sent to County Federations in September.

#### Animal Welfare.

The Exportation of Horses Bill received the Royal Assent in July. During the progress of the Bill the Committee wrote letters of support to the mover and to the Minister of Agriculture.

Following on the resolution passed at the Annual General Meeting in 1936, the Committee has agreed to co-operate with the University of London Animal Welfare Society by distributing copies ot the torm tor the Petition against the Gin Trap, which is to be sent to Members of Parliament.

#### Annual Meeting.

The Sub-Committee has co-operated with the Education Sub-Committee over following up work on Annual Meeting resolutions, notably over the price of milk, destruction of wild flowers and the hire-purchase system. (See pages 16-19.)

#### Honey.

The Annual Meeting resolution was sent to the Ministry of Health, for action, and for information to the Ministry of Agriculture, the Beekeepers' Association and Grocers' Federation.

#### Visits of N.F.W.I. Agricultural Organizer.

Miss Simpson has spent the following days on agricultural work in the counties: Berkshire (1), Derbyshire (3), Gloucestershire (1), Hertfordshire (1), Isle of Wight (2), Leicestershire and Rutland (6), Lindsey (2), Northamptonshire (5), Nottinghamshire (3), Shropshire (2), West Sussex (1), Warwickshire (1), Wiltshire (2).

#### DRAMA.

This Sub-Committee has met five times. It has given a great deal of consideration to the arrangements for the Inter-County Drama Festivals which will be held in 1938, in Norwich, Bristol, Birmingham, Swansea, Old Colwyn, York and London. Forty-three County Federations have notified their intention of entering teams for the festivals. Mr. Jack Carlton has been appointed judge. In connection with the festivals, the Sub-Committee has been able to arrange with various publishers for some reduction in the actingfees of plays performed. Particulars of the plays thus affected have been sent to County Federations.

The Sub-Committee has been represented on the Joint Committee of representatives of the National Council of Social Service and the National Federation of Women's Institutes, set up to administer the Carnegie Fund for Music and Drama in the Villages. This Committee has received many applications for grant-aid and the requests for help now far exceed the funds available. In view of the development concerning music referred to on page 24, the Joint Committee is considering what recommendations it will bring before the Carnegie Trustees as regards help towards Drama during the quinquennium 1941-46. Miss Maughfling and Mrs. Reid-Jamieson, as representatives of the Committee, have visited the following counties to give help and advice on the organization of and the technical aspects of Drama:—

Miss Maughfling :

Durham (2), Hereford (1), East Kent (1), Middlesex (1), Somerset (1).

Mrs. Reid-Jamieson :

Gloucester (1), Holland (1), Isle of Ely (1), Lancashire (1), Montgomery (1), West Sussex (1).

Members of the Sub-Committee have, during the year, considered and given opinions on a number of original plays, submitted to them by W.I. members. They have also visited County Federations and Institutes to advise on drama and to see dramatic performances.

#### HANDICRAFTS.

This Sub-Committee has met eleven times. It has been greatly helped in its work by the grant of  $\pounds 450$  sanctioned by H.M. Treasury on the recommendation of H.M. Development Commission for the Handicraft work of the Federation. The Sub-Committee has applied to H.M. Treasury for a grant of  $\pounds 450$  for the coming year.

The Sub-Committee wishes to express once again its keen appreciation of the help and advice received from Mr. Marston, Director of the Rural Industries Bureau, by whose membership of the Sub-Committee close contact is maintained between the Federation and the Bureau.

Grants under the Scheme for assisting counties to obtain handicraft teachers have been made to: Cheshire, Durham, Monmouthshire and West Sussex.

Craft Adviser has visited : Anglesey, Bedfordshire, Buckinghamshire, Cheshire, Devon, Dorset, Durham, Essex, Gloucestershire, Hertfordshire, Lancashire, Leicestershire and Rutland, Lindsey, Merionethshire, Middlesex, Monmouthshire, Norfolk, Northumberland, Nottinghamshire, Oxfordshire, Shropshire, Somerset, Staffordshire, Wiltshire, Suffolk East, Suffolk West, Yorkshire.

Miss Rowe as Craft Organizer has visited : Berkshire, Buckinghamshire, Caernarvonshire, Cumberland, Devon, Gloucestershire, Isle of Wight, Lancashire, Leicestershire and Rutland, Nottinghamshire, Oxfordshire, Radnorshire, Sussex West, Suffolk East. The membership of the Guild of Learners is now approximately 3,000.

"A" Tests have been held in twenty-seven crafts and in these, from an entry of 158, seventy-nine members gained proficiency certificates, making a total of 1,484 members who have gained certificates since 1923.

"B" or Lecture Tests have been held in : Lindsey, Yorkshire, Berkshire, Leicestershire, Northumberland, Gloucestershire and Durham. Out of an entry of forty-one, twenty-five gained firstclass and eight second-class certificates, making a total of 355 members who have gained "B" Test proficiency certificates since 1923.

"C" or Teaching Tests have been held in Berkshire, Leicestershire, Durham and Northumberland. Out of an entry of twelve, twelve gained certificates.

A Methods of Judging School in Embroidery has been held at which Dr. Welsh acted as the instructress. Fourteen students from ten County Federations attended, and of these Dr. Welsh adjudged four to be capable of judging at county and five at group exhibitions.

The loan collections now number about thirty and are maintained by means of the interest on the grant so generously made to the Federation by the Carnegie Trustees. They are in constant demand by County Federations and Institutes. The Committee has given very serious consideration to their replenishment and to obtain specimens for this purpose is organizing a competition in connection with the 1938 Handicraft Exhibition.

Two conferences on handicrafts have been held during the year, the first in April when 120 members from thirty-nine County Federations attended. The agenda included discussions on the 1938 Handicrafts Exhibition, Knitting, Rugmaking, Plain Sewing, Quilting, Pattern Making. The second conference was held in November when 129 members from forty County Federations attended. The speakers included : Miss Cox, H.M.I., on Up-to-date Methods of Teaching, and Mr. Wilson on Colour and Design as applied to Embroidery and Rugs.

An exhibit showing examples of about sixteen crafts and demonstrations of Thrift were staged at the N.F.W.I. Stand at the Royal Agricultural Show held at Wolverhampton.

A residential school for training members in the organization of handicrafts was held at Buxton in October. Fifteen students from eleven County Federations attended. The instructresses included : Dr. Welsh, Mrs. Temperley, Miss Walker, Miss Armes. Miss Rowe and Miss Walder.

A successful one-day school for Vat Dyeing was organized in November, at the request of the County Federations. Eleven members from ten County Federations attended. The Instructor was Professor Merheim, assisted by Miss Somerville of West Kent.

Arrangements are going forward for the next N.F.W.I. Handicrafts Exhibition to be held from November 16th to 23rd, 1938.

The Sub-Committee has been asked to send an exhibit of Institute handicrafts work to the Empire Exhibition to be held in Glasgow, 1938.

Members of the Sub-Committee have visited County Federations to meet the County Committees and handicraft workers to consider means of improving the standard of handicraft work.

The Sub-Committee has compiled and revised the following publications: the booklet on Pile Rugs, leaflets on the Guild of Learners, and on the Guild of Learners Tests, the Craftworker's Guide.

#### HEALTH AND GENERAL EDUCATION.

This Sub-Committee has held eleven meetings.

#### Nutrition and Cookery.

Late in 1936 the Committee learnt with much appreciation of the Board of Education's decision to organize a refresher course on nutrition for Women's Institute teachers. This course was held at the Usk Farm Institute in September and attended by twenty-one students selected from the Western and South Western counties on the recommendation of Local Authorities and County Federations.

The lecturers were all experienced in W.I. work and the Farm Institute with its garden and rural surroundings proved an admirable centre. It is hoped that this pioneer course will be followed by others in different areas.

The Commissioner for the Special Areas has sanctioned further grant aid for classes in County Durham and the County Federation has successfully organized a fresh series with a syllabus entitled "Growing and Cooking".

#### Milk.

The Committee decided in February to collect information from (1) Women's Institutes; (2) County Federations, about 16

existing facilities for the supply of milk to mothers and young children. It was felt that this information would be useful not only to the N.F.W.I. Committee in its efforts to secure cheaper milk, but also to the individual Institutes which, in the course of filling in the questionnaire would learn more about the existence or non-existence of local schemes, than they had hitherto known.

A N.F.W.I. deputation met Sir Kingsley Wood in March and submitted the Institutes' case for milk, and in especial the need for a general reduction in price for mothers and children.

The Minister in his reply stated that the Government was still considering action on the report of the Re-organization Commission.

The Annual Meeting resolution on milk for mothers and the " under-fives " was sent to the Ministry of Health, the Ministry of Agriculture, the Milk Marketing Board, the Food Council, the Maternity and Child Welfare Council, the British Medical Association, the Children's Minimum Council, the People's League of Health, the Nursery Schools' Association, the Society of Medical Officers of Health and the National Farmers' Union.

When it became known that the Government were proposing to introduce a Milk Bill, a letter was written to all Institutes suggesting that they should urge their Members of Parliament to support the case for cheaper milk for mothers and children.

On November 9th, Lady Denman addressed the Nutrition Committee of Supporters of the Government on the same matter. The introduction of the Milk Bill is still awaited.

#### Physical Education.

A discussion was held in May with representatives of the Government's new Advisory Council on Physical Education. Subsequently, (1) a preliminary application was made to the Council for the cost of a full-time N.F.W.I. Organizer under the scheme; (2) a list submitted of W.I. members who might be prepared to serve on the Area Councils to be set up under the scheme. The negotiations with regard to the grant for an organizer are still continuing.

#### Health Services.

The Committee gave publicity to the Government Campaign which is being carried out through the local health authorities between October 1937 and March 1938, and suggested that Women's Institutes might co-operate. In the spring the Committee circulated to the counties a leaflet published by the East Sussex County Council showing the health services it provided for its ratepayers. It was hoped that this might lead to the publication of similar leaflets by other County Councils.

A Conference on the Health Services was held in London on November 25th, and attended by 154 representatives of forty-four County Federations, twenty-five visitors and Committee members. Lady Denman was in the Chair and the principal speakers were Sir Kingsley Wood, Minister of Health; Miss Ida Chamberlain, Mrs. Haldane, Mrs. Neville-Smith and Dr. Carling.

The Minister of Health, in his opening address, stressed the help which Women's Institutes could give him in his efforts to build up a healthier nation. He made detailed announcements about various health matters, e.g. milk, rural housing, water supply, in which the Institutes are interested.

#### Government Family Budget Enquiry.

Co-operation has been given to the Ministry of Labour over the above enquiry. The Ministry asked :

- (1) That Women's Institutes together with other organizations should assist the local employment exchanges with the collection of sample budgets.
- (2) That the N.F.W.I. should be solely responsible for the collection of 500 budgets from agricultural households.

Both invitations were accepted and up to date 446 completed budgets have been sent to the Ministry.

#### Unjust Wills.

Letters of support for Mr. Stanley Holmes' Bill which is in line with the Annual Meeting resolution of 1931, were written to the Attorney-General and Prime Minister. The Bill received a second reading on November 5th and is being supported by the Government.

#### Secret Ballot for Parish Elections.

The Committee has worked in co-operation with the National Council of Social Service to secure this reform. As the Home Office is not prepared to consider an alteration of the present system without fresh evidence, Rural Community Councils and Women's Institutes have been asked to collect further information, particularly with regard to: (1) the cost of a poll under the present arrangements, and (2) the number of parishes which have used section 51 of the Local Government Act.

#### Education and Pleasure School.

Fifty students from seventeen County Federations attended this school which was held at the University of Bristol in June. The theme of the school was artistic appreciation. The speakers were Mrs. Haldane, Miss Hadow (novels), Miss Sharpe (pictures), Miss M. Sidgwick (poetry), Mr. R. Southern (plays), Mr. Marston (household goods), and Mr. Granville Streatfeild (village architecture).

#### Sewage and Drainage.

An article by an expert was included in the N.F.W.I. Public Questions Service, a discussion held at the Autumn Consultative Council and a popular article is being published in *Home and Country*.

#### Destruction of Wild Flowers.

The Annual Meeting resolution was sent to the Wild Plant Conservation Board, to the Townswomen's Guilds and to the National Union of Teachers. A letter was also published in the journal of the Townswomen's Guilds by arrangement with their headquarters.

#### Hire Purchase.

An article by Professor Hilton was published in *Home and Country*, and information on the agricultural aspect obtained through the Farmers' Union. The terms of Miss Wilkinson's Bill to control undesirable practices in connection with Hire Purchase, are being studied.

#### Reliability Trials.

The Annual Meeting resolution was sent to the Ministry of Transport.

#### Registered Clubs.

The Committee wrote to the Home Secretary to express appreciation at the mention in the King's Speech in November of proposed legislation designed to control undesirable clubs. It will be remembered that the promise to introduce a Bill made in 1936 was not fulfilled.

#### British Red Cross Society's "How to Keep Well" Lectures.

The Committee has recently noted that there has been less and less demand for these lectures from Women's Institutes. The reasons for this appear to be (1) unsuitable lecturers; (2) length of course; (3) elaborate regulations for tours. Negotiations are being carried on with the Society to see whether better arrangements can be made in the future.

#### Educational Facilities in Wales.

By means of a questionnaire sent to all Welsh County Federations information was collected on existing educational facilities for Welsh Women's Institutes. This was passed on to the University of Wales Extension Board at its request for use in connection with the survey of adult education which it is now making.

#### "HOME AND COUNTRY."

1937 has proved an anxious year for Home and Country.

The Sub-Committee met five times. The first meeting was called in February (instead of, as usual, in March) to consider the serious situation created by the rise in the cost of paper. The Sub-Committee were determined that the price of *Home and Country* should not be increased from 2d. per copy, and it was decided to use a slightly lower grade paper rather than add to production costs. This, however, did not end the matter, for the paper-makers notified the Sub-Committee that the price even of the lower grade paper would have to be increased in 1938. In addition, the printers gave notice that owing to changes in the conditions of the printing trade, there would be an increase in printing charges from October 1937.

These unforeseen and heavy additional expenses, making the average monthly bill for printing and paper in 1938  $f_{490}$  instead of  $f_{436}$  as in 1937 (approximately  $f_{650}$  on the year), coupled with a slight decline in the advertising revenue, led the Sub-Committee to recommend the appointment of a full-time advertisement canvasser. This recommendation was endorsed by the Executive Committee, and the new member of the staff took up his duties on November 15th.

It was decided also to make certain alterations in the appearance of *Home and Country* from January 1938. The cover has been redesigned to include new features while retaining the old, the page has been slightly enlarged, and a better type is used. These changes will, the Sub-Committee hopes, make the magazine more attractive both to readers and to the advertisers without whose support the paper could not be published at the present price. The Sub-Committee would again remind members that they can greatly help their paper by always mentioning *Home and Country* when ordering advertised goods.

Stories, competitions, and sketches have supplied light fare; while world affairs, drama, handicrafts, social services, and various aspects of agriculture are among the more serious subjects that have received attention. Illustrated notices of new films and notes on broadcasting have appeared regularly, as have articles and news items relating directly to the progress and activities of the National and County Federations. A new feature introduced during 1937 that has proved popular is a scheme for supplying members with cut-out dresses at cost price. Instructions have several times been given for making knitted garments.

The subsidized County Supplements now number twenty-five.

Home and Country Sub-Committee heartily thanks its voluntary workers for their valued services, particularly those distributors who sent in their orders for 1938 in good time.

#### INTERNATIONAL.

This Sub-Committee has met four times.

#### League of Nations Union.

A meeting between representatives of the Union and the N.F.W.I. was held in May, at which the relationship of Women's Institutes to the Union was discussed. As a result of this interview it was decided that in future Corporate Associates should be called Study Associates in order to make it clear that their functions are educational and not propagandist. Women's Institutes have been informed accordingly.

#### International Book List and County Panels.

In response to a suggestion made at the Speakers' School in 1936, a Book List has been prepared and circulated. The international sections of County Panels have also been examined. It is hoped that suggestions for their improvement and extension may be made at future N.F.W.I. Programme Planning Schools.

### International Congress of Agriculture.

Mrs. Haldane attended this Congress as the Federation's representative. She acted as rapporteur at the Women's Section at which she opened proceedings by reading a paper on "Health in the English Village". The British delegation to the Congress numbered about twenty and included representatives of H.M. Government. The Committee has subsequently made suggestions for improving the organization of the Women's Section.

#### Associated Country Women of the World.

Early in the year the Executive Committee of the Association accepted the N.F.W.I. Committee's invitation to hold its next triennial Conference in 1939 in this country. A Joint Committee was formed to supervise the Conference arrangements and has so far held two meetings. The N.F.W.I. Committee has offered :

- (1) to arrange the rally with which the week of business will end, on the assumption that a charge for entrance may be made.
- (2) to ask the County Federations whether they could offer the delegates hospitality in the form of visits to W.I. activities.
- (3) to try and secure free accommodation for the business meetings at Friends House.

#### N.F.W.I. Advisers on International Work.

The Committee, in September, appointed three N.F.W.I. representatives, Miss Digby, Mrs. Spicer, and Miss Tennant, who are prepared to visit County Federations as advisers on international work, training of speakers schools, conferences, etc., or as speakers at Council or Group meetings. Already several counties have taken advantage of the offer and bookings are also being made for 1938.

#### MARKETING.

This Sub-Committee has met quarterly.

During the year five new markets have been opened in West Sussex, Hampshire, Norfolk, Gloucestershire and Berwick-on-Tweed. The latter market is serving both English and Scottish Institutes and is organized by a Committee representing both sides of the Border.

A new free leaflet entitled W. I. Markets was issued in June and the first edition of 3,000 copies was almost exhausted by the end of the year.

The N.F.W.I. specimen market stall, bought in 1934 and subsequently exhibited at various Shows has been sold and will be used for a market which is opening in South Devon next spring.

General propaganda work has continued. An exhibit of market stall photographs was shown at the Royal Agricultural Show, and the N.F.W.I. specimen stall was lent to the Monmouthshire markets for exhibit at the Royal Welsh Show at Monmouth.

Bishops Stortford Market, (Hertfordshire) and Hexham Market (Northumberland), have registered during the year, and under the East Sussex registration scheme Crowborough Market has registered and Haywards Heath, Tunbridge Wells and Forest Row are in the course of registering.

The registered markets are as follows :

Miss Cox's work has included visits to established markets, talks to producers at W.I. Group meetings and attendance at Committee and Annual Meetings of registered markets.

Since January she has visited following counties: Bedfordshire (1), Berkshire (1), Buckinghamshire (16), Cardiganshire (4), Carmarthenshire (1), Denbighshire (8), Dorset (2), Essex (6), Hertfordshire (8), Gloucestershire (3), Hampshire (12), Isle of Wight (1), East Kent (2), West Kent (1), Monmouthshire (5), Merioneth (5), Norfolk (2), Northumberland (9), Oxfordshire (2), Somerset (2), Surrey (1), West Suffolk (2), East Sussex (3), West Sussex (12), Warwickshire (1), Westmorland (4), Wiltshire (3), Yorkshire (2), Scotland (2). The figures in brackets represent days.

The Carnegie United Kingdom Trust has notified the Committee that they propose to continue the grant of  $f_{,500}$  for 1938, but that after then any further help if given would be on a descending scale. The Committee has considered the future in the light of this announcement, and is proposing to consult the markets during 1938 to see whether they would be prepared to contribute towards the expenses of a headquarters organization.

#### MUSIC AND DANCING.

This Sub-Committee has met six times. It has continued to co-operate with the National Council of Social Service in the administration of the National Licensing scheme for village halls. County Federations have again given valuable help to the Sub-Committee in the administration of this scheme.

Members of the Sub-Committee have served on the Joint Committee for Music and Drama in the Villages. The Sub-Committee has received reports from its representatives. The Joint Committee has sent forward for the consideration of the Carnegie Trustees a scheme for help to Amateur Music. The sum asked for under the scheme is approximately  $f_{40,000}$ ; help to be given in rural and urban areas. If the scheme is approved by the Trustees, it will come into operation during the next grant quinquennium, i.e. 1941-1946.

The Seventh London School for Rural Conductors was held in London in October. The school was organized by the National Council of Social Service in conjunction with the N.F.W.I. and the British Federation of Musical Competition Festivals. 170 students attended and the instructors included: Miss Ursula Nettleship, Miss Iris Lemare, Mr. Reginald Jacques, Sir Adrian Boult, Miss Dorothy Erhart, Mr. Leslie Woodgate, Mr. Charles Bavin, Mr. Ronald Biggs, Miss Joan Brocklebank, and Dr. Thomas Armstrong. Bursaries were awarded to twenty-three W.I. members from eighteen County Federations.

After consultation with the Sub-Committee, the English Folk Dance and Song Society has undertaken to organize a week-end school for W.I. Folk Dance leaders to be held at Cecil Sharp House, London, in February, 1938. Instruction will be given in country dancing, playing for dancing, singing, and there will be talks and discussions on the relationship between the N.F.W.I. and the E.F.D.S.

The Sub-Committee has asked the National Council of Social Service to consider the advisability of approaching the Carnegie Trustees and the National Advisory Council of Physical Recreation in order to see whether financial help might be obtained towards the provision and maintenance of County Festival halls. A questionnaire asking County Federations for information concerning the accommodation available for festivals, exhibitions, etc., was answered by forty-three counties.

Miss Brocklebank, Music Organizer, has spent the following days in the counties: Buckinghamshire (2), Cambridgeshire (13), Derbyshire (5), Dorset (5), Devon (1), Hampshire (4), Holland (4), Huntingdonshire (2), Leicestershire and Rutland (6), Lindsey (3), Monmouthshire (1), Northamptonshire (1), Nottinghamshire (6), West Suffolk (1).

#### OFFICE AND FINANCE.

Twelve meetings of this Sub-Committee have been held.

#### Income and Expenditure.

The gratitude of the Federation is again due to H.M. Treasury which, on the recommendation of the Development Commission and Ministry of Agriculture, made a grant of  $\pounds 450$  towards the work of the Handicraft Department, and also to the Carnegie United Kingdom Trust for a further instalment of  $\pounds 500$  of the grant allotted for marketing work.

The Committee would also like to record its thanks (often recorded before, but none the less sincere), for the voluntary donations from Women's Institutes sent through their County Federations, reaching a combined total of  $\pounds 1,094$  4s. 0d. The suggested rate of donation since 1935 has been 4s.; every year the response is greater. This year the amount sent only fell short by 16s. of the amount suggested and only three County Federations failed to send at the full rate. A list of the donations appears on page 60.

Though it seems likely that the anticipated income for the current year will be realized the Committee will probably have to face a shrinkage in income during the ensuing year owing to decreased profits from *Home and Country*. The question of how this position should be met has been carefully considered. In view of the fact that the Federation's reserves are still substantial it has been decided for the present to postpone making an appeal for increased donations from the Institutes but to remind the County Federations that this may be necessary before long.

#### Endowment Fund.

The Executive Committee in December 1936 most gratefully accepted a donation from Lady Denman to the Endowment Fund of  $\pounds 1,500$ , and a promise of a further  $\pounds 1,500$  to be paid within the next few years.  $\pounds 500$  of the latter instalment was received in November.

#### Office Premises.

At the beginning of the year it was found necessary, owing to the expansion of the work, to accommodate *Home and Country* in a separate office at No. 26 Eccleston Street.

#### Benevolent Fund and Staff Pensions Scheme.

The total of the Benevolent Fund is now over  $\pm 1,229$ . Sixteen members of the N.F.W.I. staff, and three members of the staff of County Federations are members of the Staff Pensions Scheme.

#### Exemptions from Income Tax.

Exemption has been gained for twenty-two Women's Institutes and one County Federation during the year.

#### ORGANIZATION.

This Sub-Committee has met eleven times. It is responsible for keeping the Executive Committee informed of the progress of the movement throughout the country, and is prepared to help County Federations and Institutes in special difficulties and to arrange visits from members of the N.F.W.I. Executive Committee or of its Sub-Committees. It arranges the work of the National Federation Organizers, trains and recommends Voluntary County Organizers, and gives them, when appointed, additional help in their work by means of Conferences and Advanced Schools. It is responsible for the arrangement of the Annual General Meeting, of the meetings of the Consultative Council, and of the Welsh Conference.

Reports have been received monthly of the new Institutes formed and of those which have been suspended or closed. The Sub-Committee has sanctioned the transference of Institutes from one County Federation to another and has dealt with problems affecting W.I. organization. The Sub-Committee has also, with the co-operation of the County Federations concerned, enquired into the reasons for any considerable decrease in membership in any county, as compared with the previous year. In counties where such a decrease has occurred the main reason given has been lack of suitable leadership.

During 1937 forty-five V.C.O.s have been trained at Schools held at Haywards Heath and Weston-super-Mare.

The Sub-Committee has revised the conditions of training of V.C.O.s and has organized Preliminary V.C.O. Schools in the following centres: London, Cambridge, Barmouth, Leicester, Oxford, Darlington, Stafford and Winchester. As a result of these Schools sixty-one members have been approved for further training at a residential training school.

A Refresher Conference for V.C.O.s was held in London on June 3rd, 1937, when 175 V.C.O.s from fifty County Federations attended. The agenda included discussions on V.C.O. problems and the V.C.O. at Officers' Schools and the W.I. Annual Meeting. Speakers included Mrs. Hitchcock, Mrs. Hollis, Mrs. Neville-Smith, and the N.F.W.I. Organizers. Miss Gaskell, Chairman of the Sub-Committee, was in the Chair.

The number of V.C.O.s who have been working during the year is 511, and they have paid 3,637 official visits to Women's Institutes.

The Sub-Committee has made arrangements for a series of conferences on County Committee work to be held in a number of County Federations. The meetings consist of a preliminary conference to which are invited all members of a County Executive Committee and its Sub-Committees, and are to be followed by discussion and help where necessary on the various sides of Institute work. Applications for such conferences have been received from thirty County Federations.

The Welsh Conference was held at Cardiff in April. Twenty delegates and visitors from ten County Federations attended. Mrs. Mostyn was again nominated for co-option as the Welshspeaking member of the N.F.W.I. Executive Committee.

The Sub-Committee has considered the revision of the leaflets concerned with organization which are issued by the Literature Department. A first step in the campaign of helping Institutes to improve their programmes was taken with the publication of *Women's Institutes Programmes* in June. The experience of twenty-one years of programme planning in the Institutes is embodied in this leaflet, which it is hoped will prove of great value. The following new or revised leaflets have been issued during the year:

The Sub-Committee has reviewed the help which has been given to County Federations through the N.F.W.I. Committee members and Organizers, and had been in consultation with certain County Federations as to the best ways in which the N.F.W.I. may help them.

The Sub-Committee has supervised the work of the National Federation Organizers, Miss Hirst Simpson (half-time), Miss Walder (full-time), Mrs. FitzRandolph (auxiliary), and Miss Morris-Jones (auxiliary Welsh-speaking Organizer).

The Organizers have made the following visits to the counties (the figures in brackets represent the number of days spent in the county):

#### CORONATION MESSAGE.

The Chairman read the Coronation Message to the King.

To the King's Most Excellent Majesty.

May it please your Majesty to accept a loyal address of congratulation in the following terms :—

This meeting of eight thousand countrywomen, representing 5,430 Women's Institutes in England and Wales, asks His Majesty to accept its heartfelt congratulations on his accession to the throne, and its gratitude for the interest shown by Her Majesty the Queen and by Her Majesty Queen Mary in the countrywomen's movement.

#### APPOINTMENT OF RETURNING OFFICERS AND TELLERS.

Mrs. Nugent Harris moved the appointment of the Women's Employment Federation as Returning Officers and of Miss Simpson and Mrs. Hume as Tellers.

The motion was seconded from the body of the Hall and *Carried unanimously*.

#### APPOINTMENT OF AUDITORS.

Mrs. Huxley moved the appointment of Messrs. Knox, Cropper & Co., Chartered Accountants, as Auditors for 1938.

The motion was seconded from the body of the Hall and Carried unanimously.

#### MINUTES.

The Minutes of the Twentieth Annual General Meeting were signed by the Chairman.

#### CHAIRMAN'S ADDRESS.

After giving her address, the Chairman moved the adoption of the Annual Report.

#### HONORARY TREASURER'S STATEMENT.

In the absence of Miss Chamberlain, through illness, this was presented by Lady Worsley-Taylor, who proposed the adoption of the Financial Statement.

The adoption of the Annual Report and Financial Statement was seconded from the Hall, and *Carried unanimously*.

THE RESULT OF THE BALLOT FOR THE ELECTION OF THE N.F.W.I. COMMITTEE FOR 1937-38 was announced by the Chairman.

#### PRESENTATION TO LADY DENMAN.

On behalf of the Federation, Miss Hadow presented to Lady Denman an Institute Book, to commemorate the Twenty-first Birthday of the Movement. It is dedicated :—

To Lady Denman, in token that there is no County in England and Wales in which her name is not held in warm affection and respect as that of a wise and just Chairman and a true friend, and in grateful acknowledgment of twenty-one years of unsparing service to Women's Institutes.

Lady Denman thanked the members for their gift.

#### N.F.W.I. STANDING ORDERS.

Miss Hadow (N.F.W.I. Executive Committee) moved and Mrs. Dunham (Durham) seconded the following resolution, which was *Carried by a very large majority* :—

"That the following sentence be added to Standing Order No. 4 of the N.F.W.I. Annual General Meeting :— 'No resolution sent in on the ground of urgency shall be accepted by the Executive Committee or in cases of necessity by the Chairman acting on its behalf, unless the said resolution deals with some development arising after the correct date for sending in resolutions for the Agenda, and involves action which must be taken at once to be effective. This resolution to take effect in 1938.""

The following resolution was moved from the Chair and Carried :---

"In Standing Order 13 of the N.F.W.I. Annual General Meeting, delete the words 'the Previous Question namely' so that the Order shall read : 'Any member may move that the meeting do now proceed to the next business, etc.'"

#### ALTERATIONS TO RULES.

"That N.F.W.I. Rule VIII (a) should be altered to allow for seventeen elected members, two representatives from the Ministry of Agriculture, one representative from the Ministries of Education and Health, and four co-opted members (one of whom shall be Welsh-speaking), the resolution to take effect in 1938." An amendment moved by Miss Rome (Lancashire) and seconded by Mrs. Adams (Yorkshire Federation Executive Committee) was Lost :----

"Delete all after 'allow for' and substitute 'eighteen elected members, two representatives from the Ministry of Agriculture, one representative from the Ministries of Education and Health and three co-opted members (one of whom shall be Welsh-speaking), the resolution to take effect in 1938.'"

#### MILK FOR YOUNG CHILDREN.

The following resolution was proposed by Mrs. Hollyer (Blewbury and Upton W.I., Berkshire), seconded by Mrs. Marshall (Wash Common W.I., Berkshire) was *Carried by an overwhelming majority* :—

"That this meeting regrets that adequate steps have not yet been taken by the Government to ensure that the price of milk is reduced to all needy parents of children under school age and, since milk is a commodity essential to the health and life of young children, urges that this position should be remedied without delay, provided that this reduction in price does not adversely affect the producer."

An amendment moved by Mrs. Evans (Cefn Cribbwr W.I., Glamorganshire) and seconded by Mrs. Sloman (Cowbridge W.I., Glamorganshire) was *Lost*.

A second amendment proposed by the Isle of Wight was, by leave, withdrawn.

Leave of URGENCY was *refused* for the following resolution, proposed by Mrs. Scott (Kilmington W.I., Wiltshire) and seconded by Mrs. Cook (Zeals W.I., Wiltshire) :—

"That this meeting protests against the bombing of open towns and urges the Government to do all in its power through the League of Nations to prevent the recurrence of such outrages."

#### HIRE PURCHASE.

The following resolution was proposed by Lady Sibell Argles (Nottinghamshire), seconded by Mrs. Wadsworth (Wyke Regis W.I., Dorset) and *Carried* :—

"That this meeting urges Women's Institutes to study the terms of the Hire Purchase and Deferred Payment systems and as far as possible to help members to understand the danger inherent in the systems."

#### DRAINAGE AND SEWAGE DISPOSAL.

Mrs. Methuen (Wiltshire Federation Executive Committee) moved, and Mrs. Brown (Lindsey Federation Executive Committee) seconded the following resolution :—

"This meeting urges the Women's Institutes to study the question of drainage and sewage disposal in the villages." An amendment, proposed by Mrs. Elliot (Cerne Abbas W.I., Dorset), seconded by Mrs. Bennett (Cheselbourne W.I., Dorset) was Carried by a large majority :---

"Delete all after ' to ' and substitute ' press their Local Authorities to provide drainage and sewage disposal in the villages.'"

The resolution as amended was Carried.

#### DESTRUCTION OF WILD FLOWERS.

Mrs. Atherton (Colesbourne W.I., Gloucestershire) moved, and Miss King (Isle of Wight) seconded the following resolution :----

"That the rapid and widespread destruction of wild flowers throughout England and Wales should be thoroughly discussed by Women's Institutes with a view to taking such steps as may appear most effective to prevent such destruction, and that the N.F.W.I. Executive Committee be instructed to support, when considered advisable, the Wild Plant Conservation Board in representations the Board may make to the Government on the subject."

"Add, 'That the co-operation of the Townswomen's Guilds be invited.'"

The resolution, as amended, was Carried.

#### PLAIN SEWING IN SCHOOLS.

Mrs. Wild (Wiltshire Federation Executive Committee) moved and Miss Gaskell (N.F.W.I. Executive Committee) seconded the following resolution :---

"That this meeting is of the opinion that the teaching of plain sewing and mending in senior and junior elementary schools should be given pre-eminence over the less useful crafts, and urges the N.F.W.I. to approach the Board of Education in this matter."

An amendment proposed by Mrs. Thornbarrow (Westmorland Federation Executive Committee) and seconded by Mrs. Weller (Old Farnley W.I., Yorkshire) was *Carried* :—

"Add, 'Further, that amongst the qualifications of at least one of the teachers in each school there should be ability to teach plain sewing."

The resolution, as amended, was Carried by a large majority.

#### HONEY.

Mrs. Robson (Buckinghamshire Federation Executive Committee) moved and Mrs. Walters Davies (Cardiganshire) seconded the following resolution, which was *Carried by a large majority* :—

"That this meeting strongly urges the Government to take steps to prohibit the use of the word honey on any foodstuffs which are not wholly produced by bees from natural sources."

#### RELIABILITY TRIALS AND ROAD SAFETY.

Mrs. Ilbert (Thursley W.I., Surrey) moved and Mrs. Stephens (Shackleford W.I., Surrey) seconded the following resolution, which was *Carried* :—

"That the N.F.W.I. urges the Minister of Transport to seek powers without delay for the regulation of motor cycle trials, above all for the prevention of motor cycle reliability and other trials through villages and in country lanes. Such trials occurring as they usually do on Sundays are a real danger to villagers, especially children, and to users, both human and animal, of country lanes."

#### LEAGUE OF NATIONS AND ANIMAL WELFARE.

Mrs. Gray (Cambridgeshire Federation Executive Committee) moved and Mrs. Assheton (Lancashire Federation Executive Committee) seconded the following resolution, which was *Carried* :----

"That this meeting of delegates from Women's Institutes in England and Wales approves the action of the Royal Society for the Prevention of Cruelty to Animals in endeavouring to secure international agreement for the protection of animals through the League of Nations, and pledges itself heartily to support its efforts."

This report was considered.

#### BUDGET.

Miss Chamberlain, Hon. Treasurer, N.F.W.I., before presenting the budget made a short statement on the financial policy of the N.F.W.I. She gave comparative figures to show the development of work at Headquarters since 1928; spoke of the increasing number of Public Questions on which the Executive Committee was given instruction to take action by the Annual Meeting, and finally warned the Council that such expansion of work necessarily involved expansion of staff and accommodation, and that though an increase in the "quota" would probably not be necessary in 1938 it must not be lost sight of for the future. In presenting the budget Miss Chamberlain made special reference to the N.F.W.I. Pension Scheme and Benevolent Fund.

#### N.F.W.I. LITERATURE.

Lady Worsley-Taylor asked County Federations to consider how sales of N.F.W.I. literature could be extended at W.I. meetings. She was of opinion that such sales could be greatly increased. In response to a question, the Council did not consider that there would be much demand for envelopes printed with the name and address of the General Secretary of the N.F.W.I.

#### PROPOSED BIRTHDAY FUND.

By permission of the Chairman, Miss Pearce, member of Canford Cliffs W.I., made a proposal to the Council that the comingof-age of the N.F.W.I. should be commemorated by a birthday gift, to be voluntarily subscribed by members and friends of the Movement as a token of their gratitude for all it had given them.

The Council, after full consideration and on the proposal of the East Sussex delegate, were unanimously in favour of a subscription list being opened in *Home and Country*. It was considered advisable to leave the allocation of the fund (i.e. Endowment Fund or Capital Reserve) until a later date. An amendment moved by Miss Gaskell, seconded by Dr. Carling—that subscriptions should be sent to some individual in the Counties, in order that Headquarters might be disassociated from the appeal—was *Lost*.

#### AGENDA OF ANNUAL MEETING.

Of the thirty-nine resolutions submitted for the Agenda, ten were placed in Class A and two in Class B.

It was *agreed* to refer the following resolutions to the N.F.W.I. Committee :—

> Holiday Homes for W.I. Members (Radstock W.I.). Juvenile Crime (Lupton W.I.).

Entries for W.I. Handicraft Exhibitions (Hurst Green W.I.).

#### RESOLUTIONS.

The following were discussed :----

(a) "That adequate arrangements be made for luncheons for delegates at the N.F.W.I. Annual Meeting."

Moved by East Suffolk. Carried by a majority.

Miss Hirst Simpson, on behalf of the N.F.W.I. Committee, outlined a scheme for supplying snack box luncheons to the delegates. It was *decided* that this should be tried as an experiment.

(b) "That the N.F.W.I. be asked to arrange Schools for County Drama Advisers, on the same lines as those recently held for Handicraft Organizers."

Moved by Yorkshire. It was pointed out that the budget for 1937-38 made no provision for such expenditure but the resolution was referred to the N.F.W.I. Organization Committee for consideration.

(c) "That the names of all handicraft judges and examiners should be published before N.F.W.I. 'A ' Tests."

Moved by East Kent, seconded by Yorkshire. Lost.

(d) "That individual reports of N.F.W.I. handicraft tests should be signed by judges."

Moved by East Kent, seconded by Yorkshire. Carried by a small majority.

(e) "That the National Federation shall make a charge of 6d. per dozen to County Federations for membership cards, except in the case of new Institutes, which shall be entitled to their first issue of membership cards free."

Committee, stated that the policy of drawing on the Federation's reserves would be continued until the Committee considered that the safety limit had been reached.
